4. Do not place this product near the window, curtain line will entangle the baby.






## Swing Gear Indicator

## Bluetooth function instructions

Turn on the rocker Bluetooth function switch, and all indicator lights on the panel flash; Turn on the Bluetooth function of the mobile phone and search for the "little children" device to select the connection;

If the indicator light returns to normal display, it is connected successfully;

**Note: please disconnect the power supply if it is not used for a long time.**

# Assembly Instructions



1. Open the legs to both sides.



2. Please ensure listen a audible click that indicate the swing is securely unfolded.



3. Position basket flat for assembly.



4. Attach toys to swing.

5.Put the mosquito net on the sleeping basket.



6. Press and hold the buttons on both sides to adjust the angle.



7. Press and hold the upper button to fold.



8. Press and hold the leg buckle to adjust the height.

In gaps between extra padding and side of the bassinet/cradle, and On soft bedding.

Use only the pad provided by manufacturer. NEVER add a pillow, comforter, or another mattress for padding. To reduce the risk of SIDS. pediatricians recommend healthy infants be placed on their backs to sleep, unless otherwise advised by your physician.

Use only the sheet provided by the bassinet or cradle manufacturer or one specifically designed to fit the dimension of the bassinet or cradle mattress.

Strings can cause strangulation! Do not place items with a string around a child's neck. such as hood strings or pacifier cords. Do not suspend strings over a bassinet or cradle or attach strings to toys.

**1.** The first use to clean The cleaning time of baby bedding should be treated differently according to different seasons and personal habits, and the general cycle is once a month. The newly bought baby bedding must be rinsed once in the water to wash off the surface pulp and dyeing floating color, which will be softer to use and will not fade easily when washed in the future.

**2.** Cleaning bedding should be divided into material Washing procedures for washable baby bedding:

**①** Pour in neutral detergent and control the water temperature to about 30 degrees. After the detergent is completely dissolved, put in the bedding to be cleaned.

**②** Different shades of color should be washed separately to avoid dyeing each other.

**3.** Storage conditions are exquisite When storing, please clean it first, dry it thoroughly, fold it neatly, and put a certain amount of camphor balls in a dark place with low humidity and good ventilation. Products that have not been used for a long time can be dried in the sun before being reused to make them fluffy.

**4.** Maintenance of supplementary knowledge :

**①** Flax products cannot be rubbed or twisted hard during washing (because the fiber is brittle and easy to fluff, which affects the appearance and service life).

**②** When collecting cotton and hemp products, care should be taken to keep the environment clean and prevent mildew. Light and dark color products should be stored separately to prevent shade and yellowing.

**③** White silk products cannot be put in camphor balls or camphor wood boxes, otherwise they will yellow.
