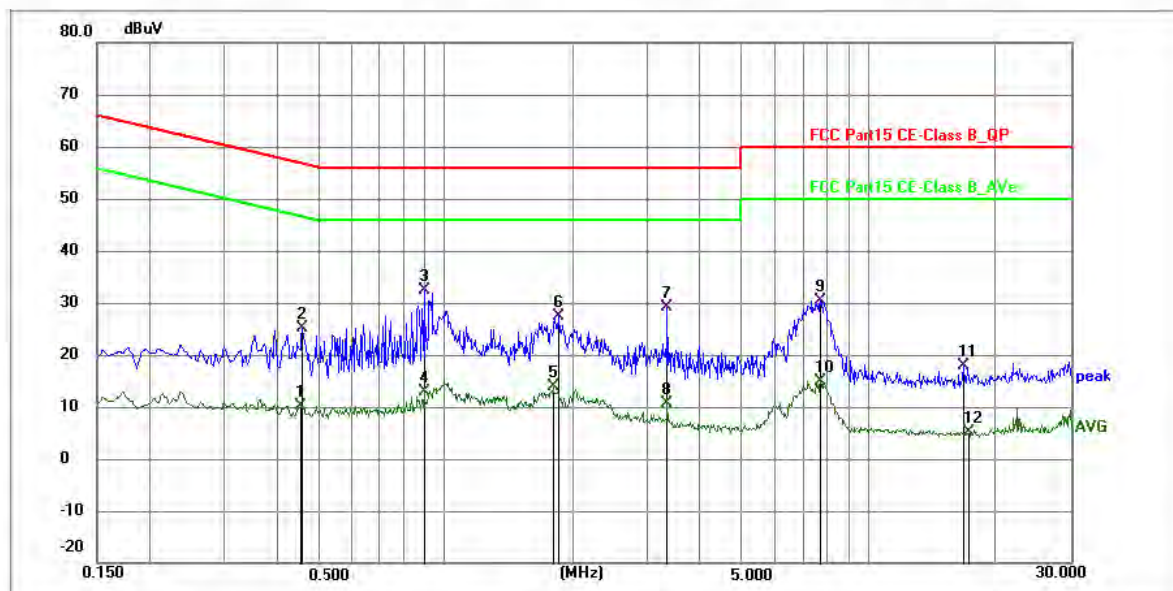

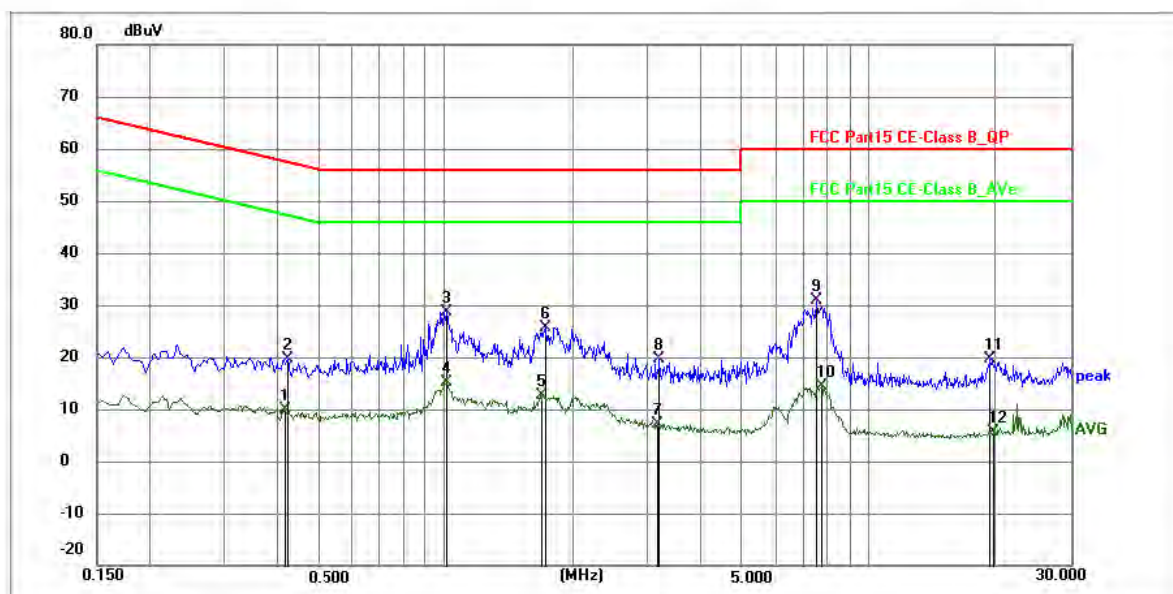

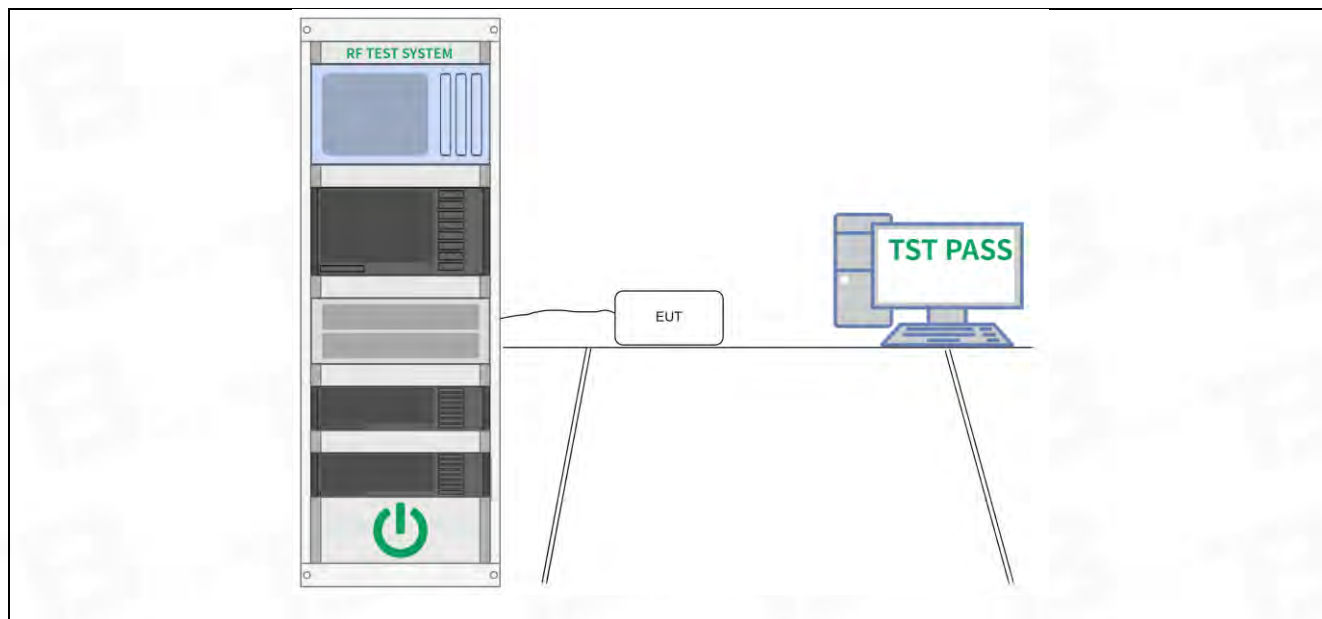

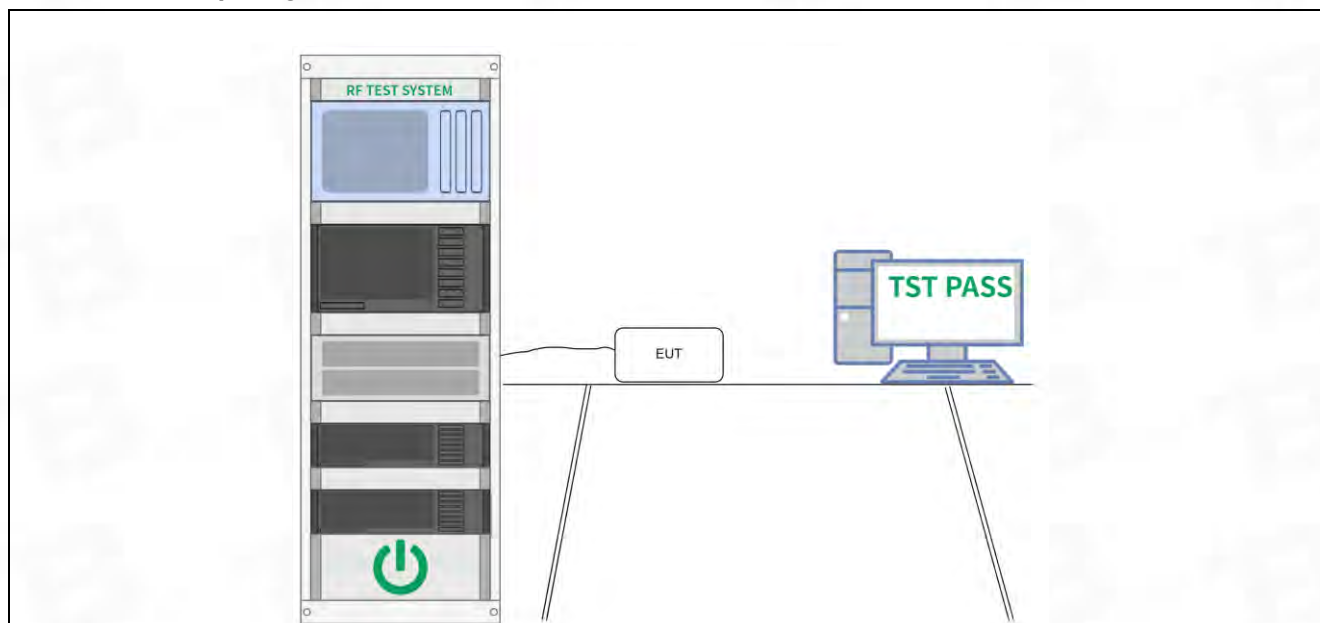

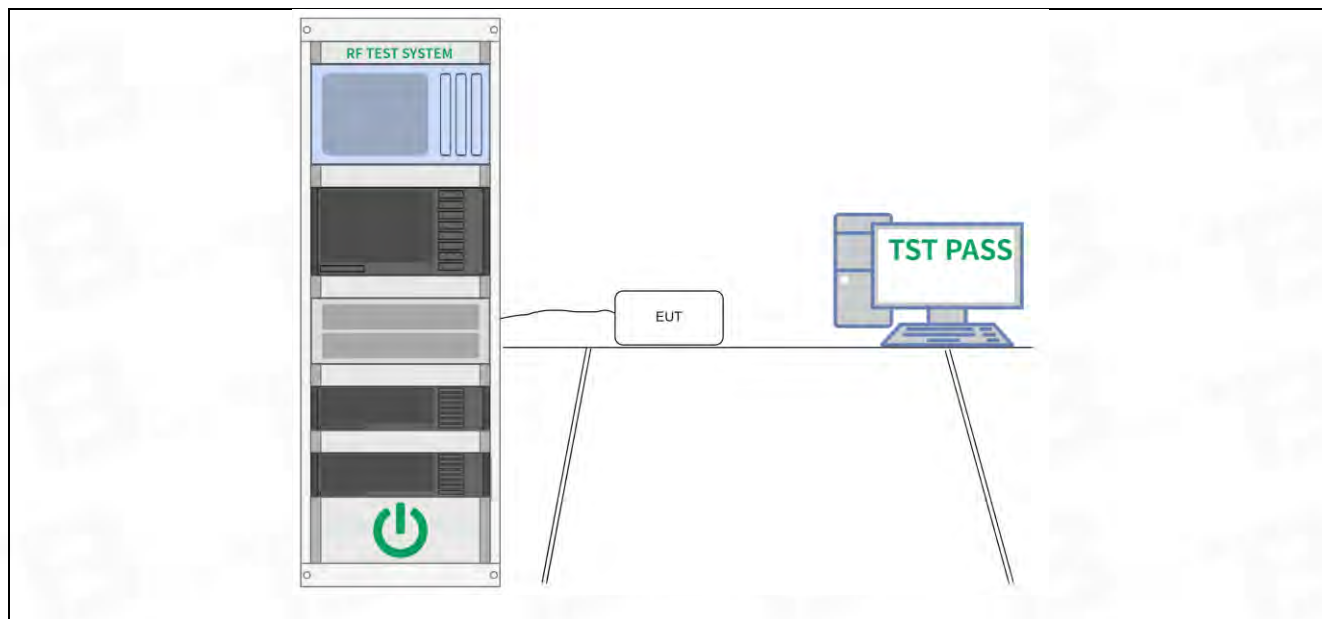

### 6.9.2 Test Setup Diagram:



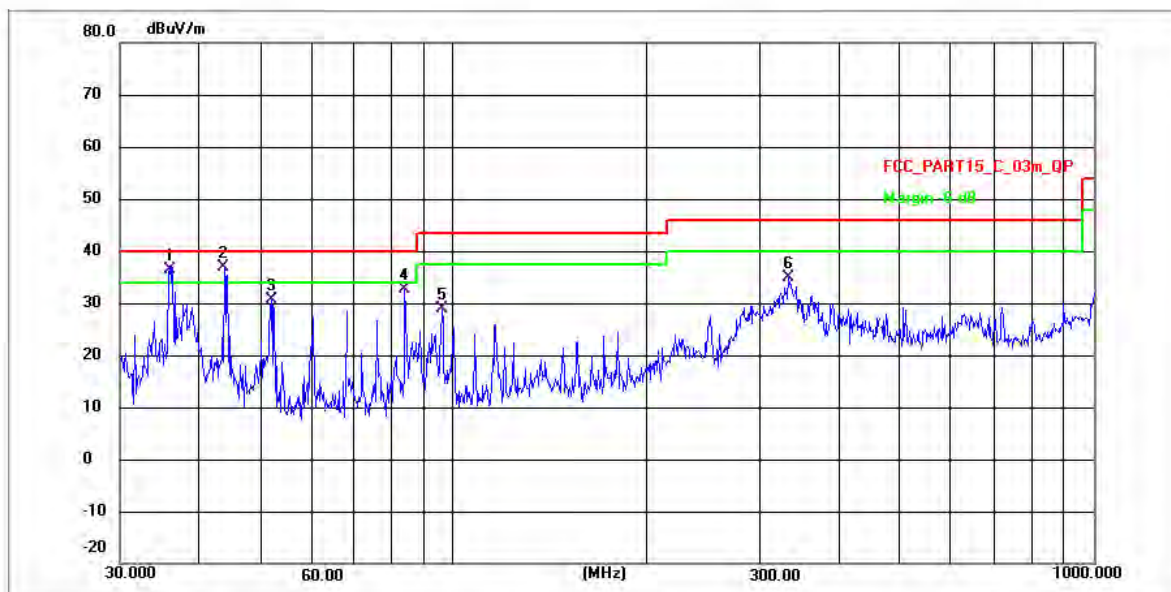
