The antenna is a PCB antenna which permanently attached, and the best case gain of the antenna is - 0.58dBi . It complies with the standard requirement.



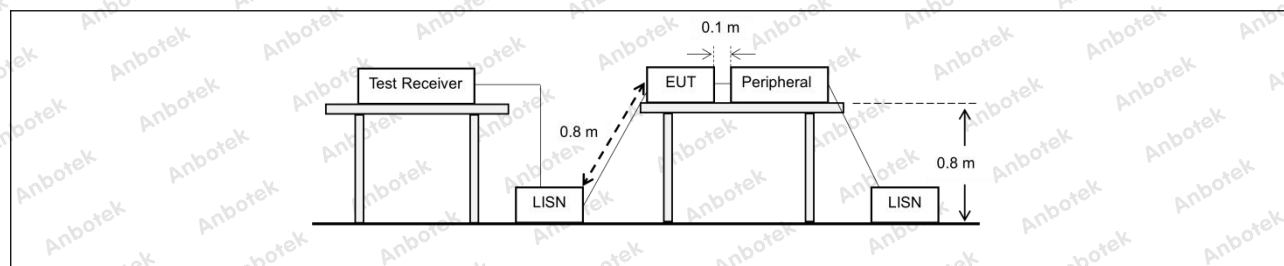

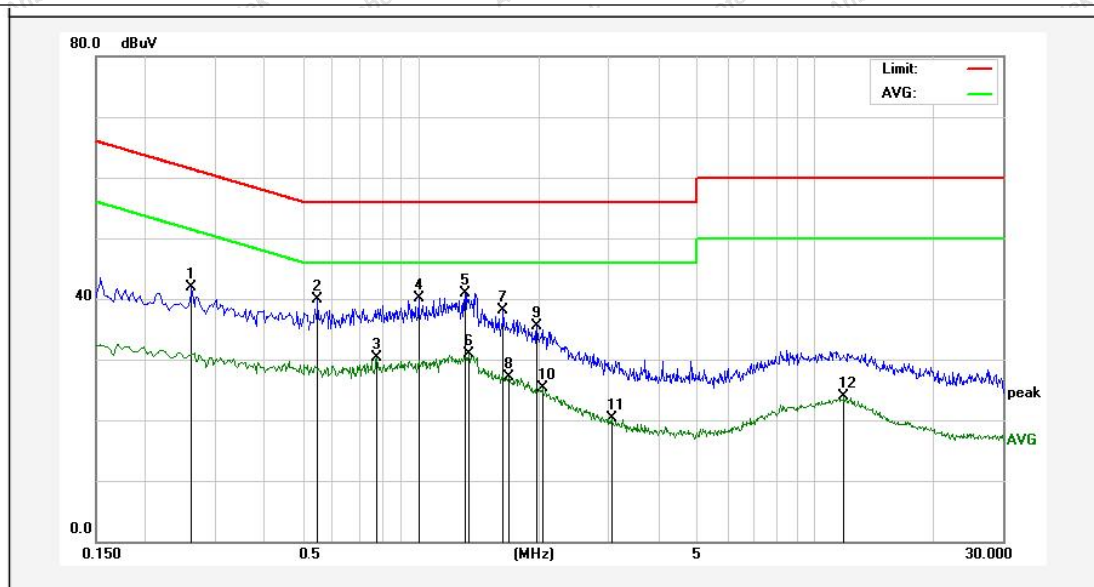

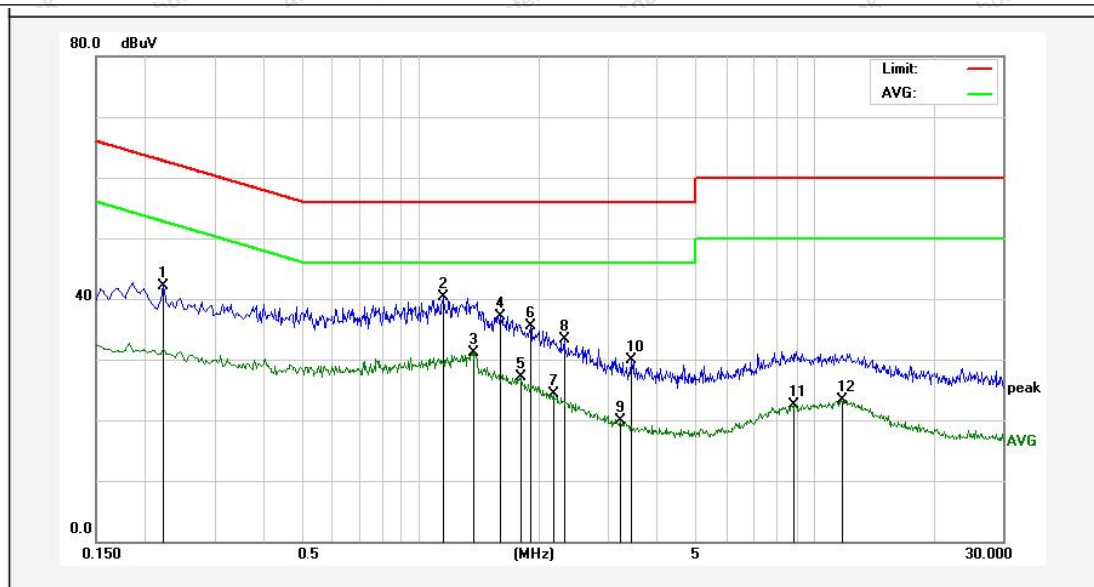

4. Occupied Bandwidth
