




The Transmitter was operated in the normal operating mode. The TX frequency was fixed which was for the purpose of the measurements.



Software Setting Diagram-ANT 4





Test Graphs of Conducted Output Power



Test Graphs of Occupied Bandwidth







Test_Graph_2.4G_SRD_ANT5_2402_1Mbps_OBW







Test_Graph_2.4G_SRD_ANT5_2480_1Mbps_OBW







Test Graphs of DTS Bandwidth





Test_Graph_2.4G_SRD_ANT4_2480_1Mbps_DTSBW







Test_Graph_2.4G_SRD_ANT4_2440_2Mbps_DTSBW









Test_Graph_2.4G_SRD_ANT5_2480_1Mbps_DTSBW








9.1 Provisions Applicable

The transmitter power spectral density conducted from the transmitter to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

9.2 Measurement Procedure

- The testing follows the ANSI C63.10 Section 11.10.2 Method PKPSD.
- 1. The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.
- 2. Set to the maximum power setting and enable the EUT transmit continuously.
- 3. Make the measurement with the spectrum analyzer's resolution bandwidth (RBW) = 3 kHz. Video bandwidth VBW = 10 kHz in order to make an accurate measurement, set the span to 1.5 times DTS Channel Bandwidth. (6dB BW)
- 4. Detector = peak, Sweep time = auto couple, Trace mode = max hold, Allow trace to fully stabilize. Use the peak marker function to determine the maximum power level.
- 5. Measure and record the results in the test report.
- 6. The Measured power density (dBm)/ 100kHz is a reference level and used as 20dBc down limit line for Conducted Band Edges and Conducted Spurious Emission.



Test Graphs of Conducted Output Power Spectral Density





The limit for out-of-band spurious emissions at the band edge is 20dB below the fundamental emission level, as determined from the in-band power measurement of the DTS channel performed in a 100kHz bandwidth per the PSD procedure.

 7. The trace was allowed to stabilize
 8. The manufacturer of RF external cable claims that the cable loss is 0.5dB, and the cable loss and attenuator have been compensated into the Corrections Configuration of measuring equipment.
 9. Input correction factor includes external cable loss and attenuator amplitude compensation. The formula is:
Input compensation coefficient (dB) = Cable Loss (dB) + Attenuator attenuation value (dB)



Test Graphs of Spurious Emissions in Non-Restricted Frequency Bands



Test_Graph_2.4G_SRD_ANT4_2402_1Mbps_Higher Band Emissions





Test_Graph_2.4G_SRD_ANT4_2440_1Mbps_Lower Band Emissions







Test_Graph_2.4G_SRD_ANT4_2480_1Mbps_Higher Band Emissions









Test_Graph_2.4G_SRD_ANT4_2440_2Mbps_Higher Band Emissions





Test_Graph_2.4G_SRD_ANT4_2480_2Mbps_Lower Band Emissions







Test_Graph_2.4G_SRD_ANT5_2402_1Mbps_Higher Band Emissions






