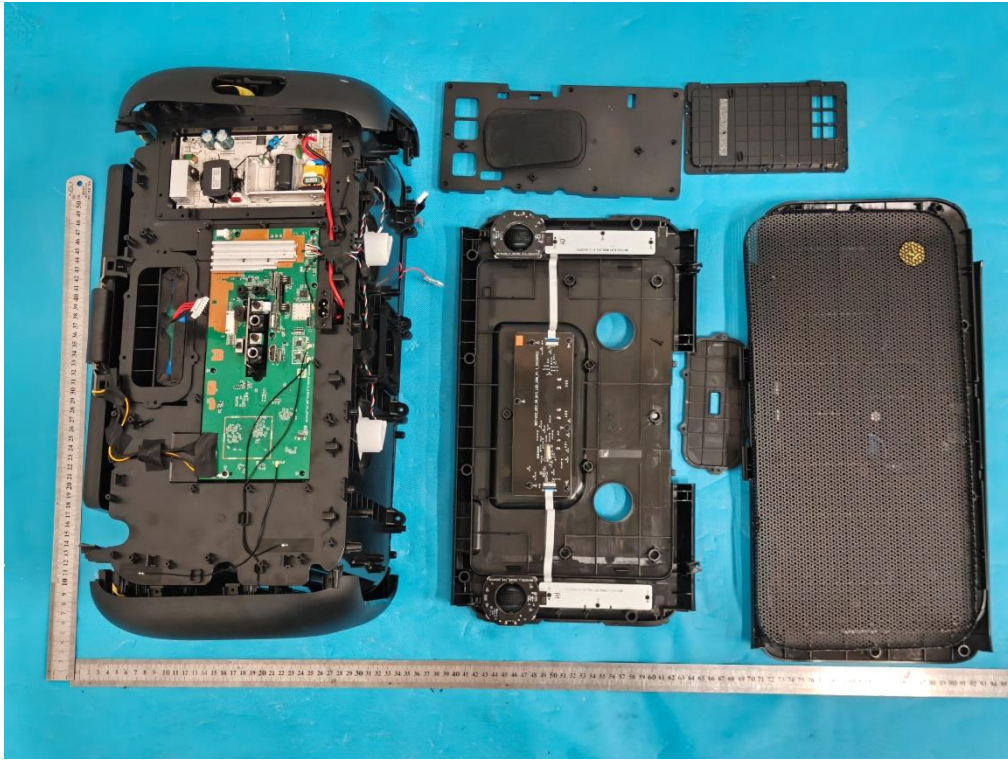
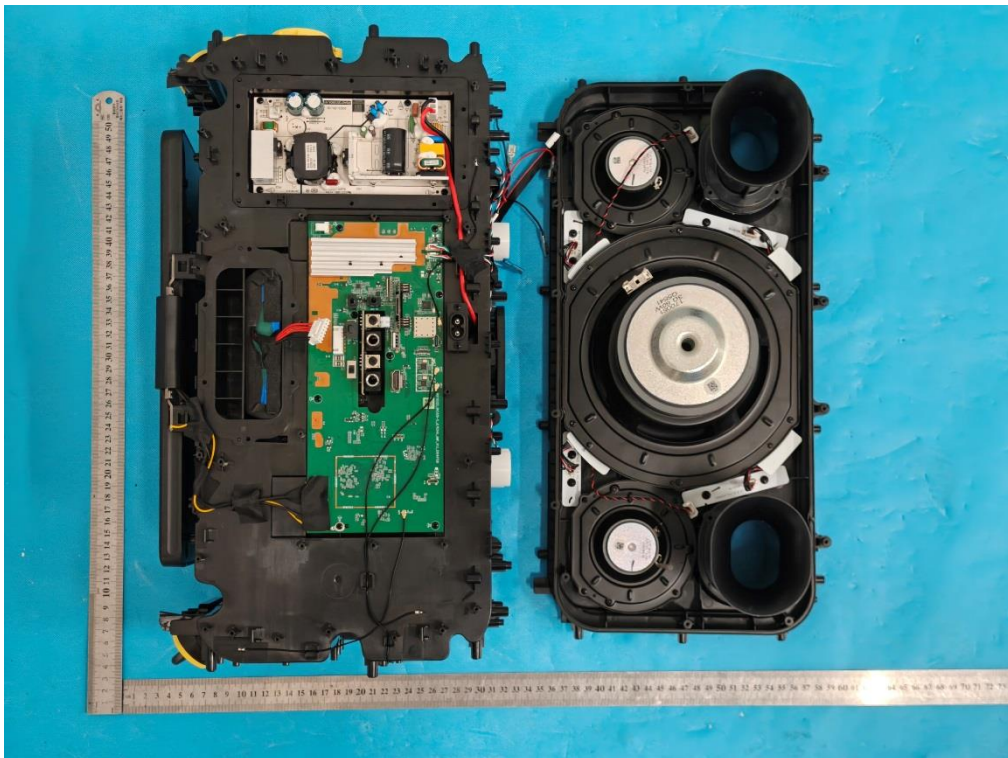


INTERNAL PHOTOS OPEN VIEW OF EUT (FIGURE 1)

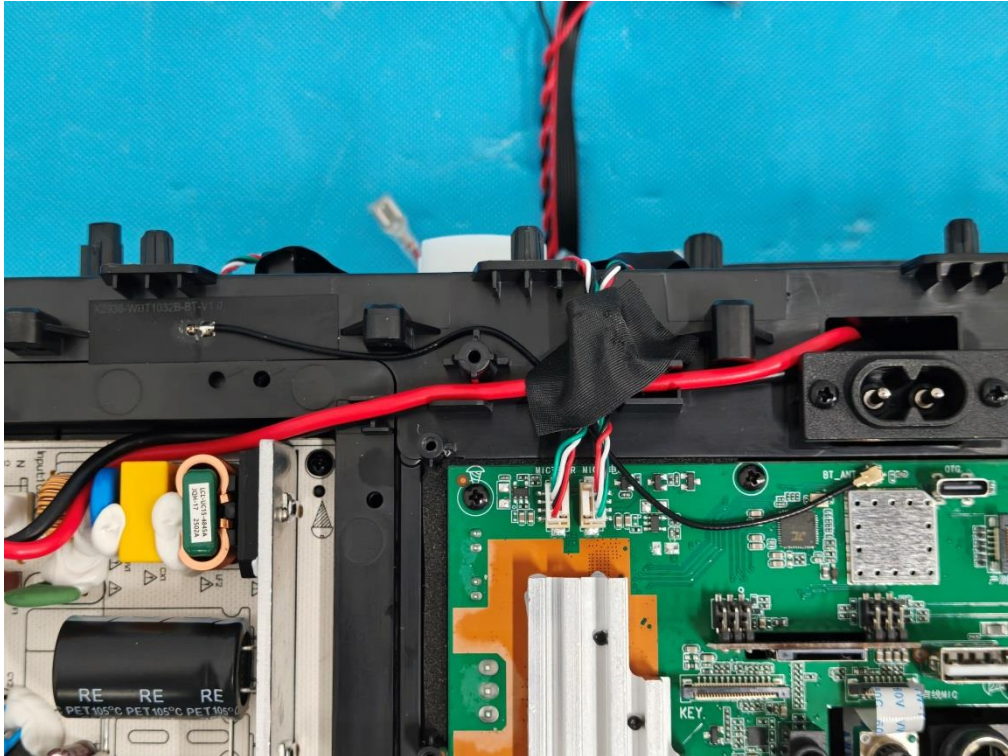


OPEN VIEW OF EUT (FIGURE 2)

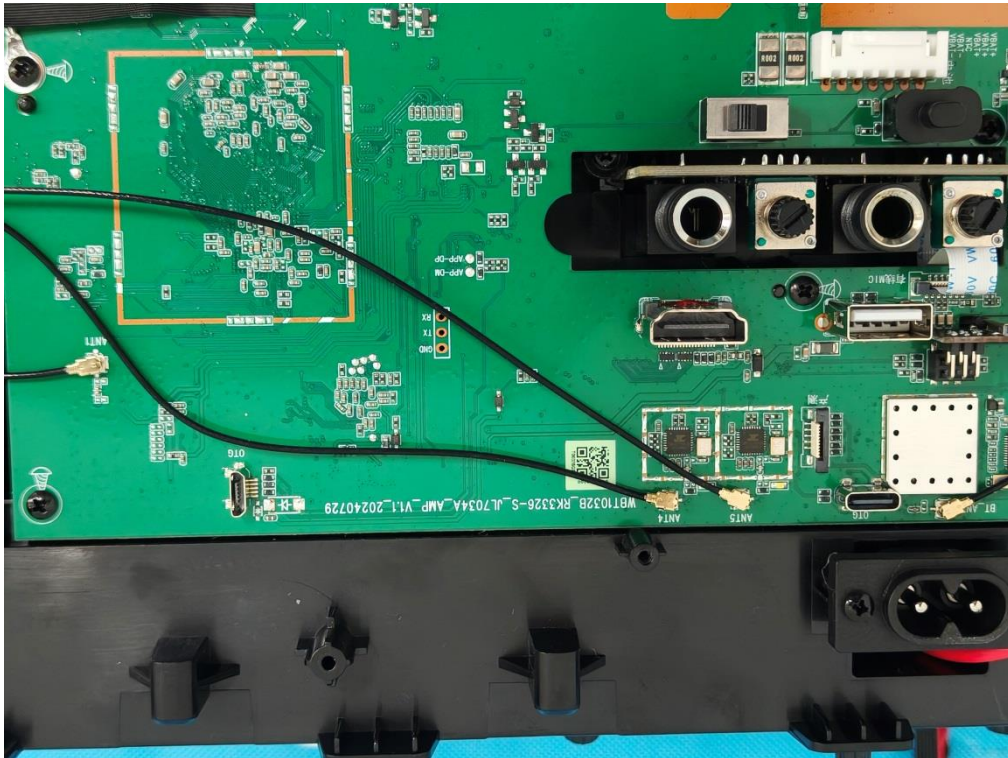

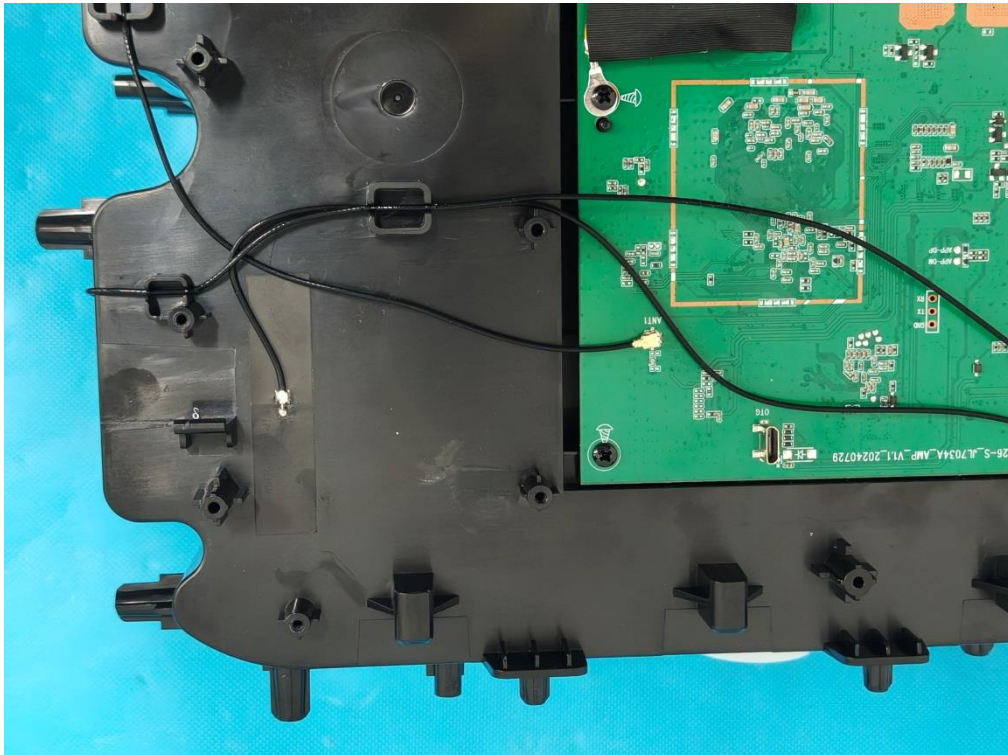


OPEN VIEW OF EUT (FIGURE 4)

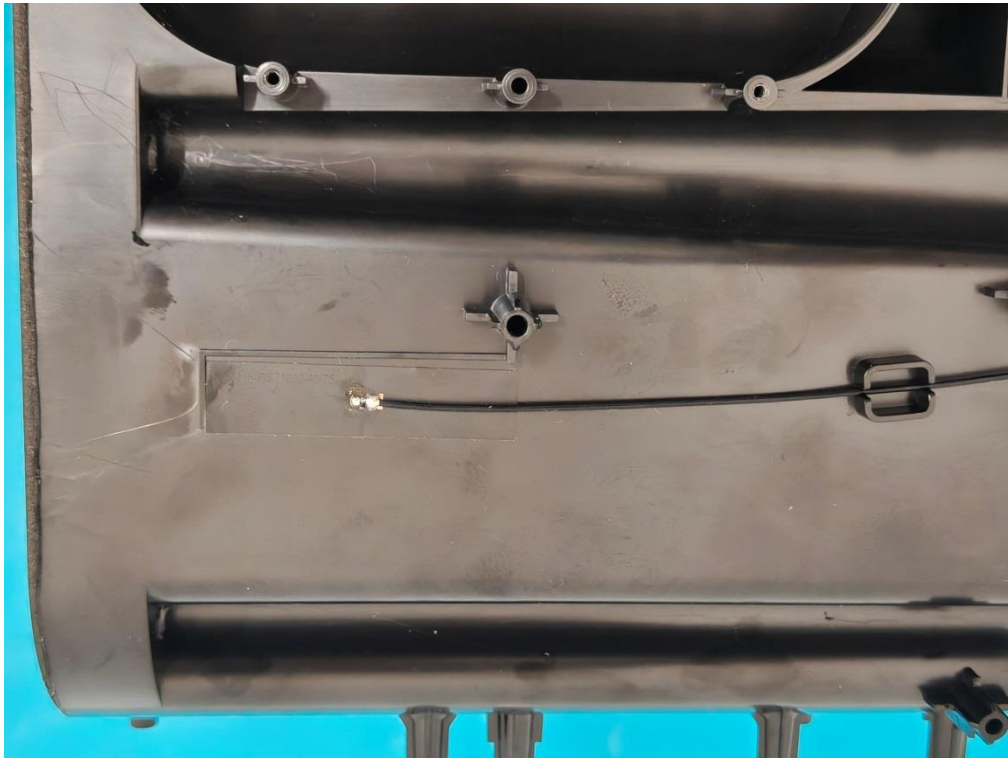

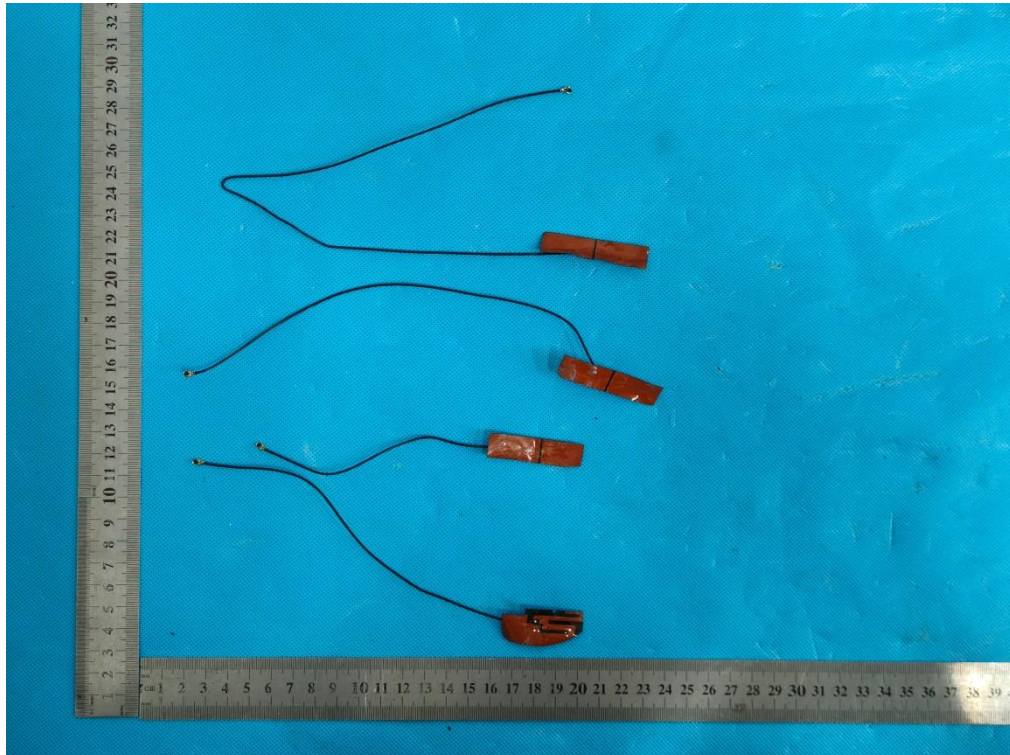

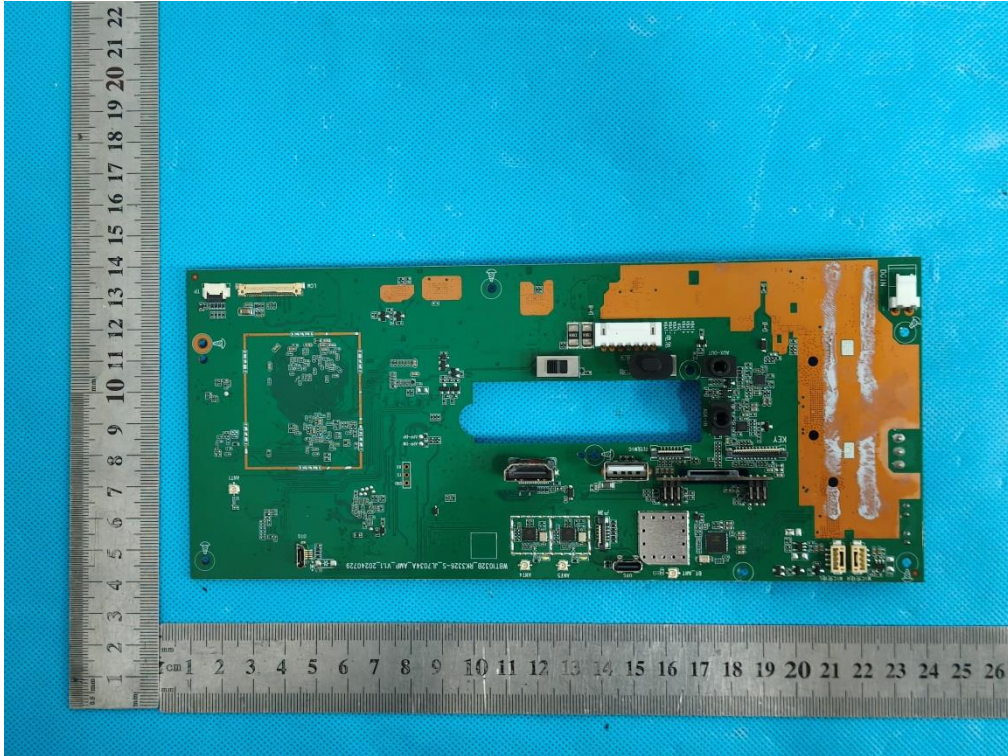

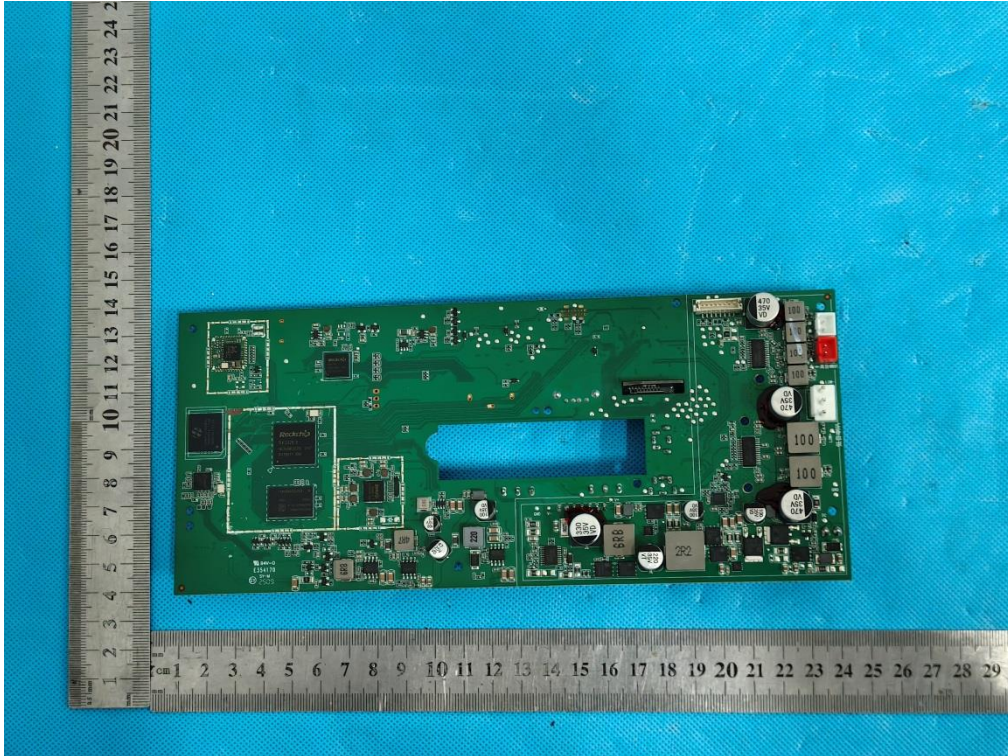

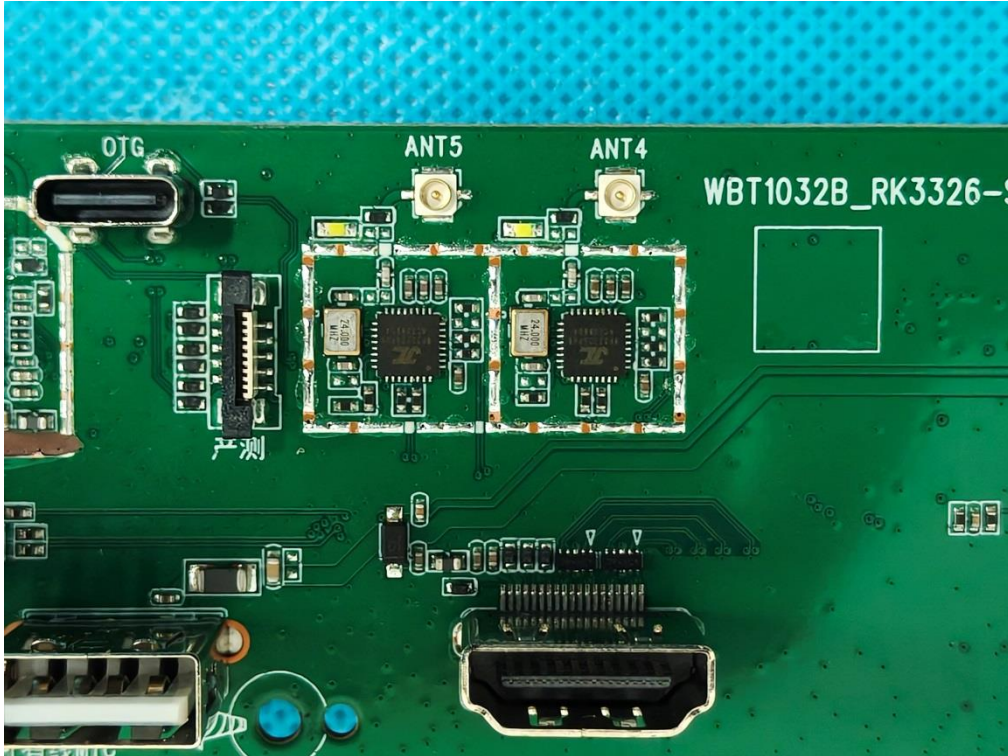

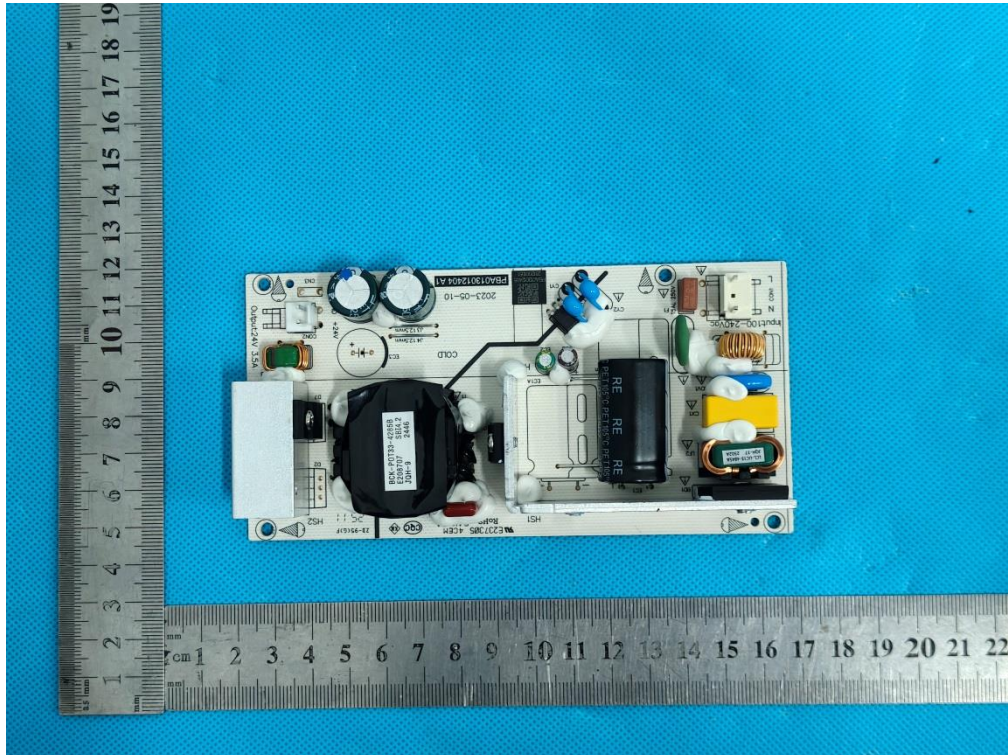


INTERNAL VIEW OF EUT (FIGURE 9)

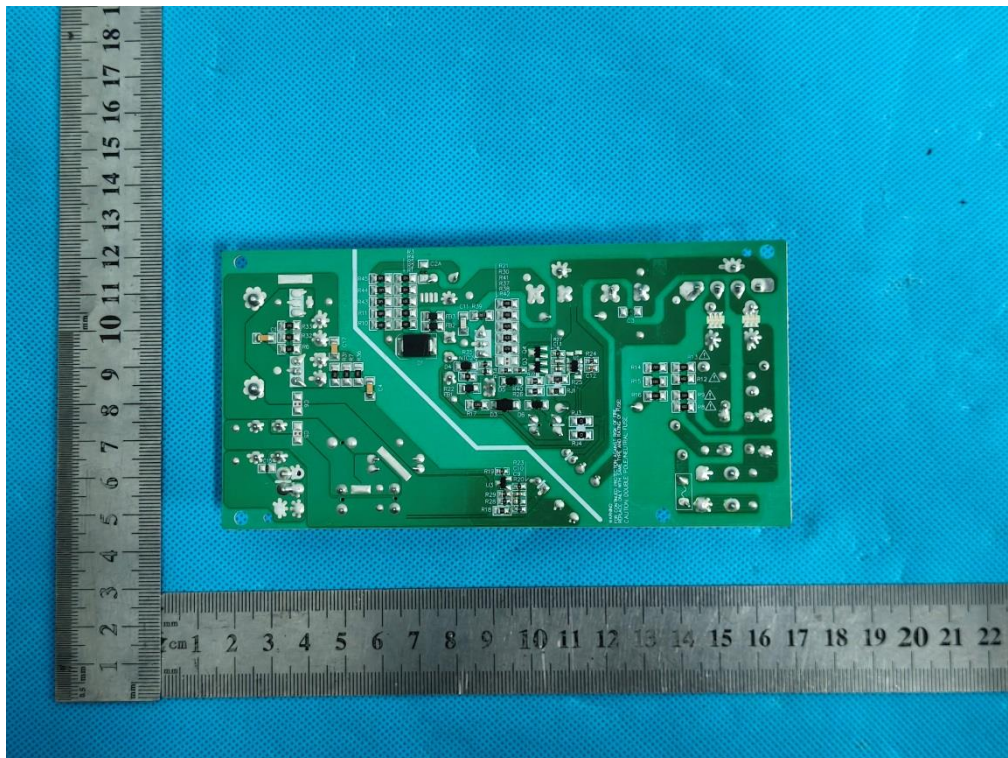

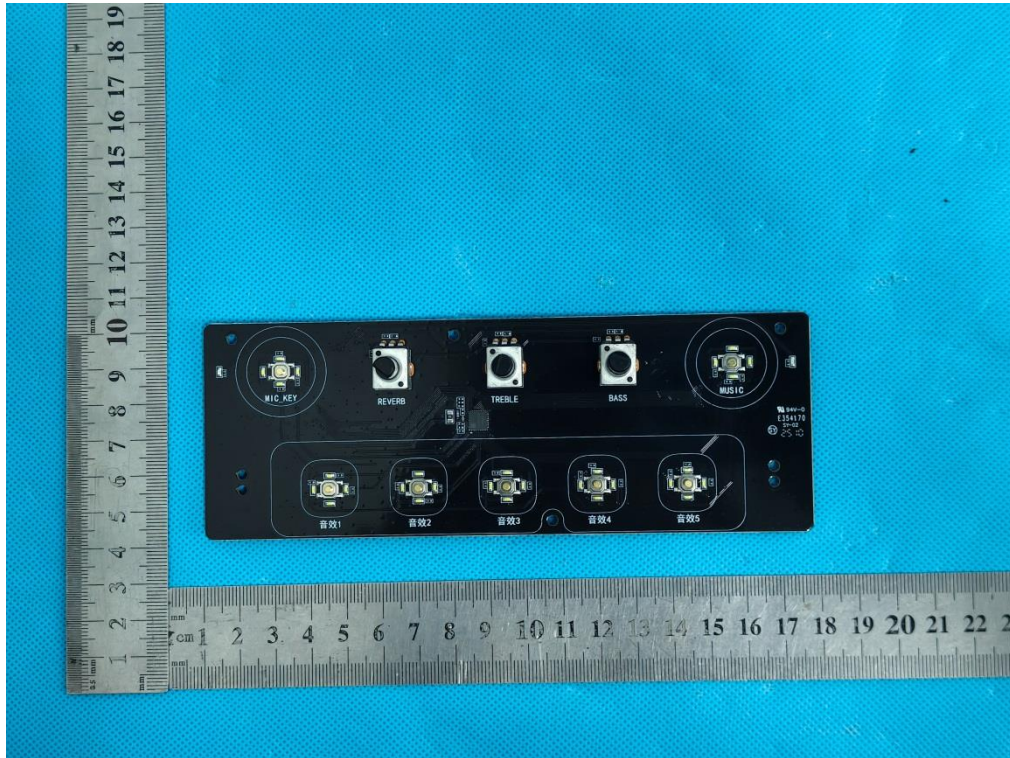


INTERNAL VIEW OF EUT (FIGURE 11)

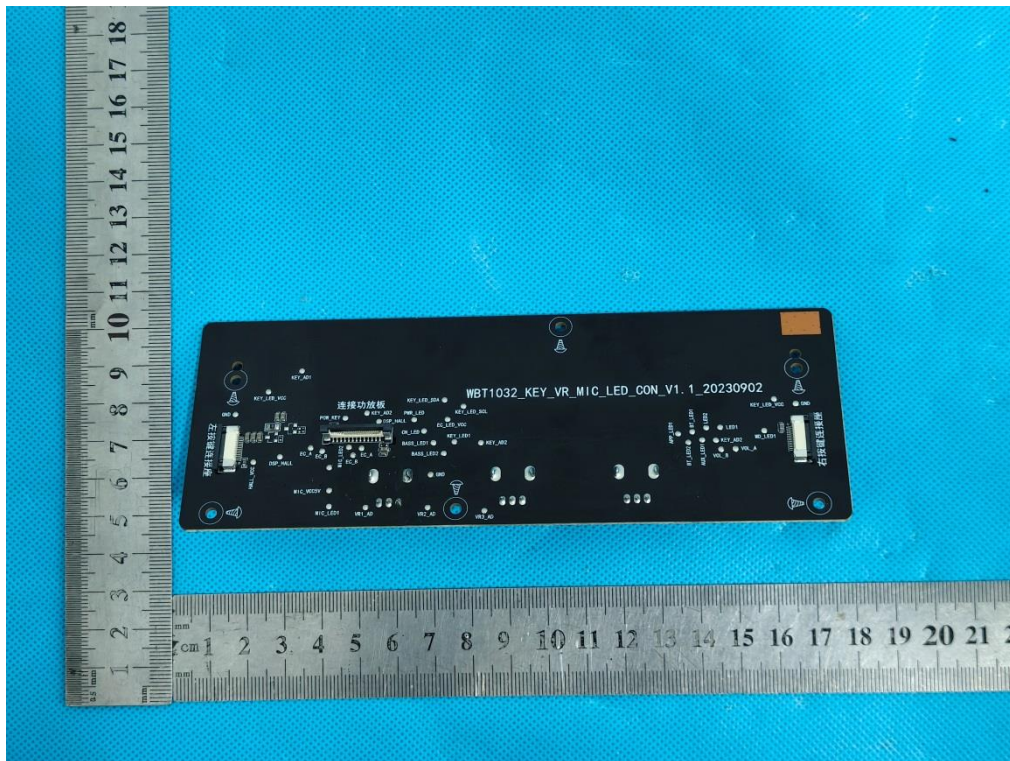
