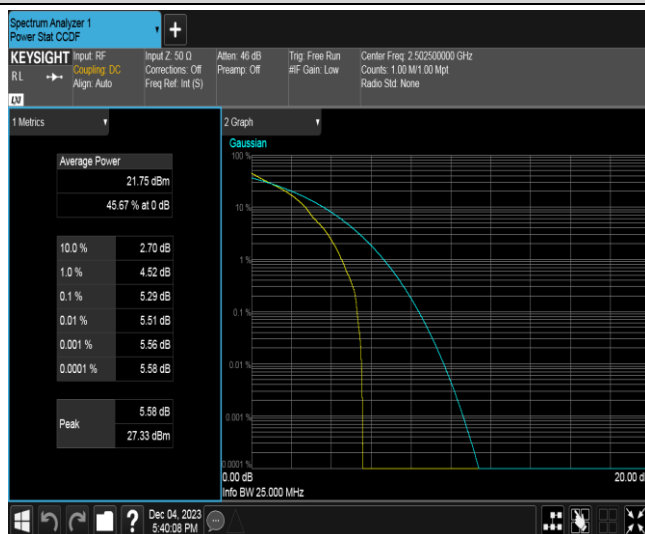

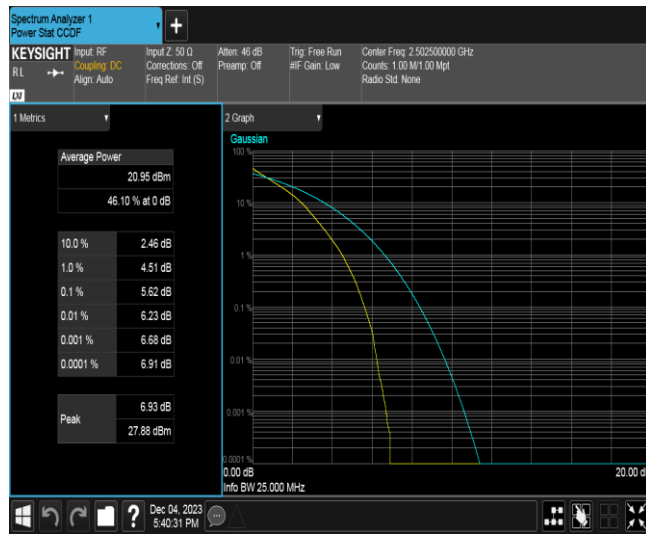

Band7-5MHz-QPSK-21100-1RB#0

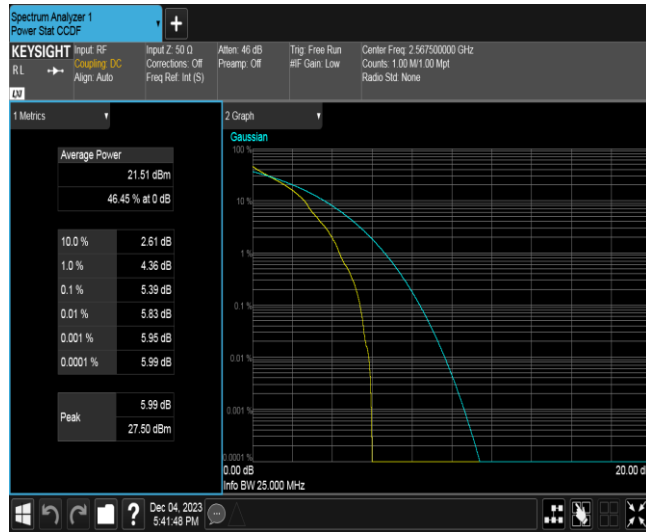


Band7-5MHz-QPSK-21100-25RB#0

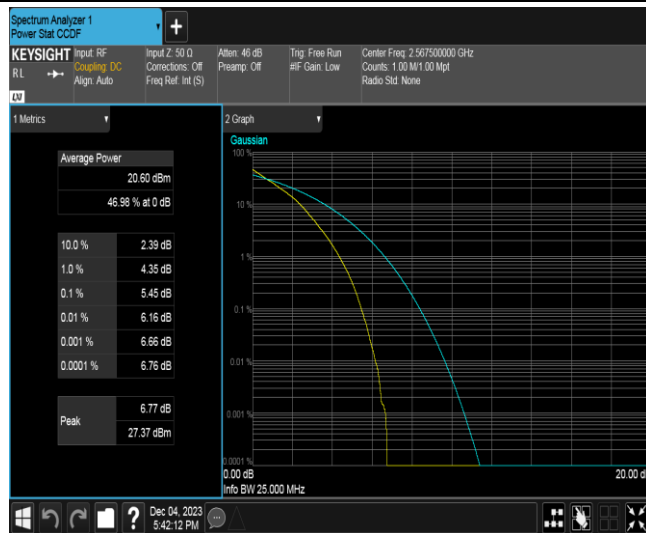

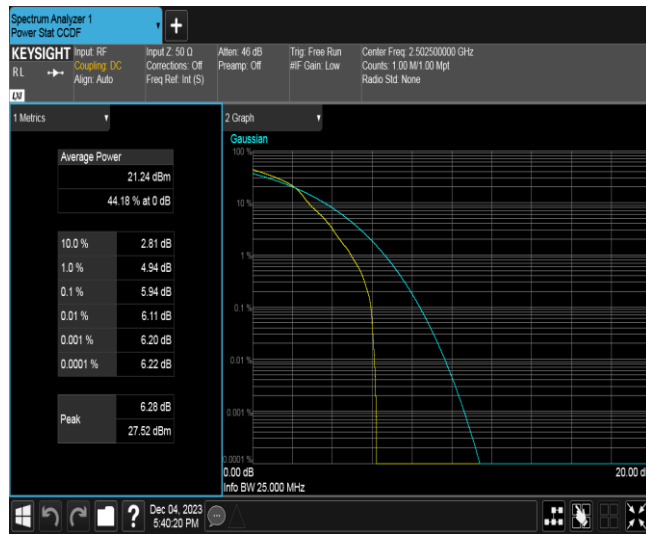


Band7-5MHz-QPSK-21425-25RB#0

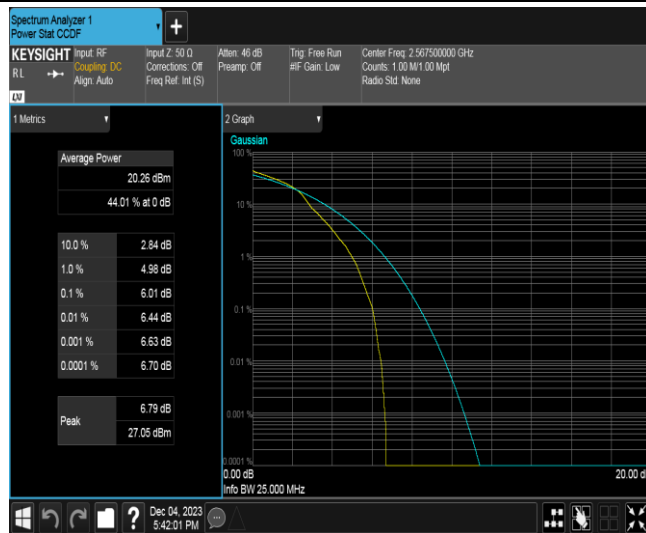

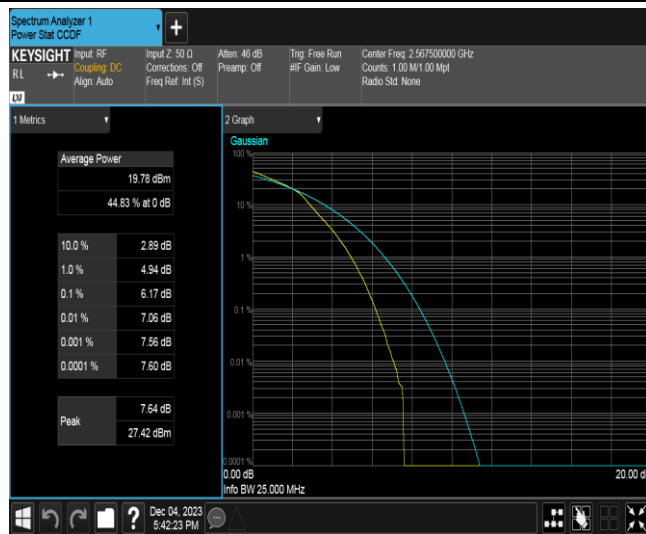

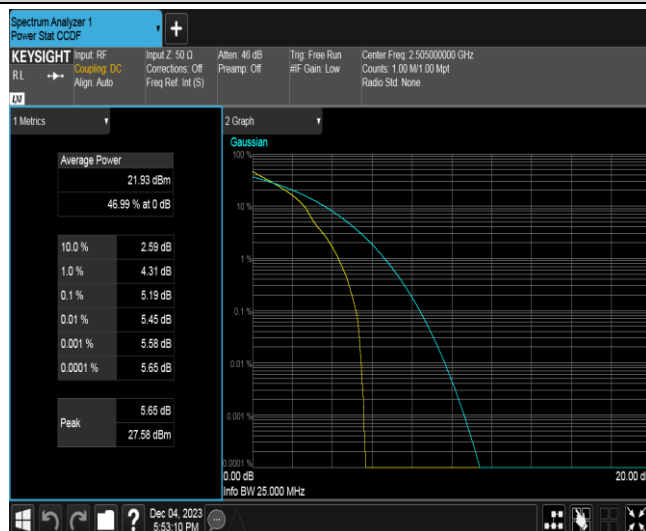

Band7-10MHz-QPSK-20800-1RB#0

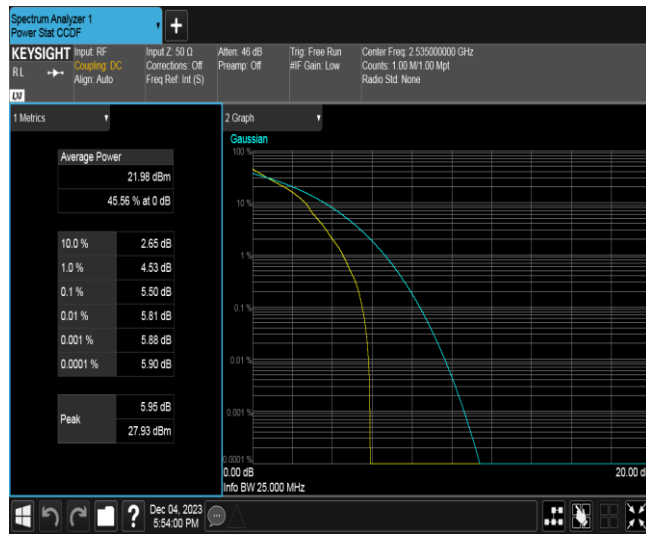


Band7-10MHz-QPSK-20800-50RB#0

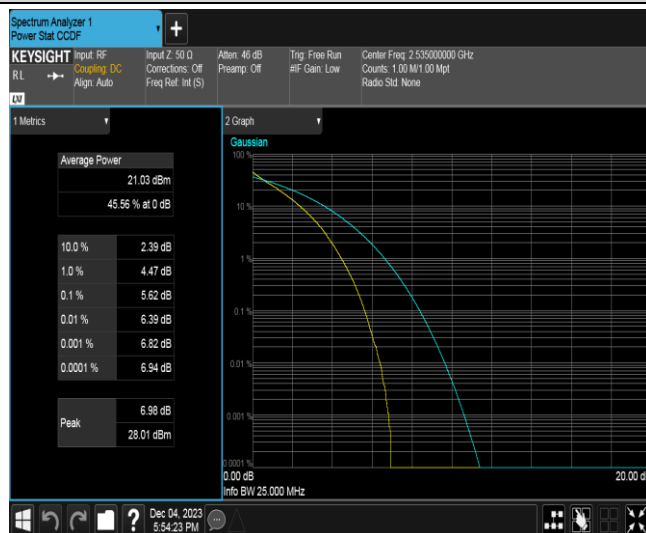
