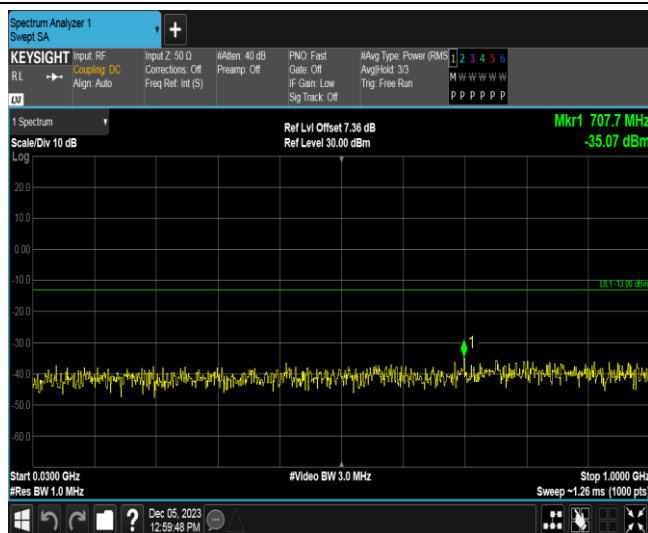
Band25-1.4MHz-QPSK-26047-1RB#0-Range2:1000~20000MHz



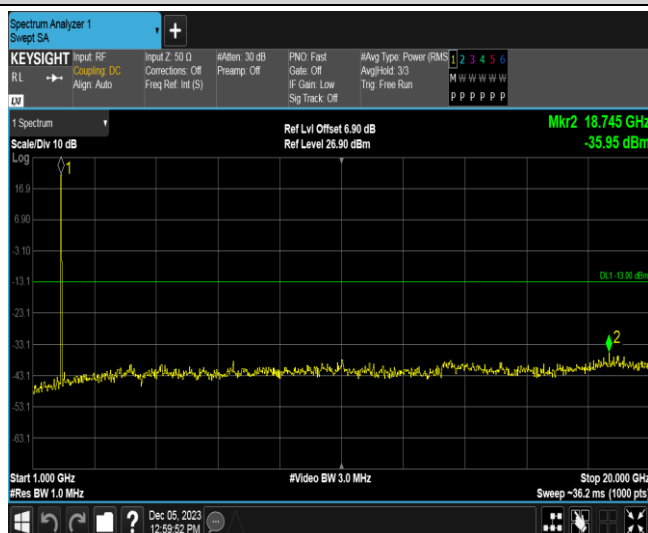

Band25-1.4MHz-16QAM-26365-1RB#0-Range1:30~1000MHz

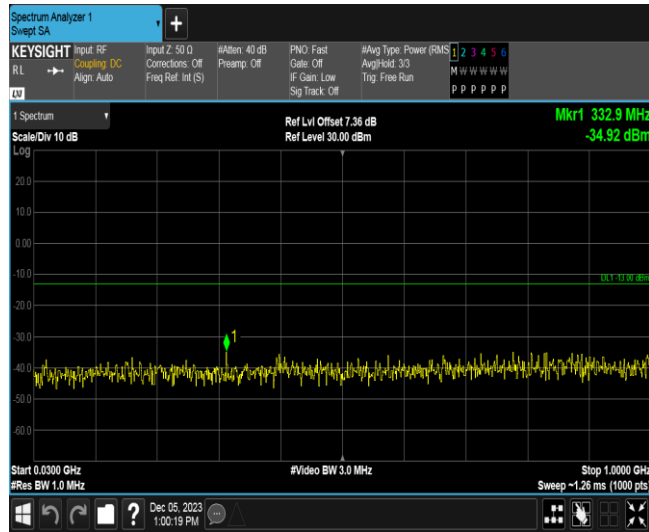

Band25-5MHz-QPSK-26665-1RB#0-Range1:30~1000MHz

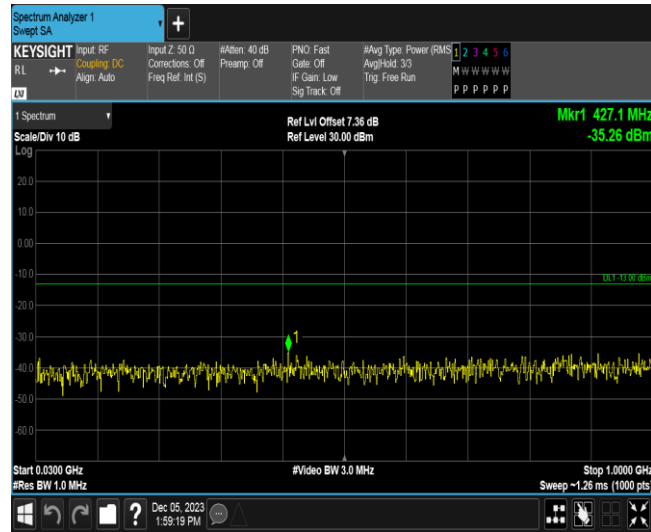

Band25-15MHz-16QAM-26615-1RB#0-Range1:30~1000MHz

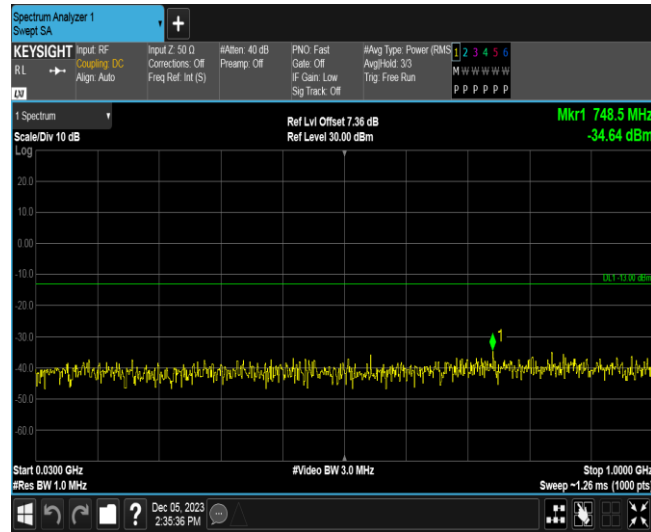
