

2.2 Assessment Results

Power density (S) is calculated according to the formula:

$$S = P / (4\pi R^2)$$

Where S = power density in mW/cm²

P = Radiated transmit power in mW

R = distance (cm)

As we can see from the test report 2309A1188SHA-002:

62.9dBuV/m@3m, @20cm=@3m+40log(3/0.2)=109.94dBuV/m=0.314V/m<60.77.

The power for WIFI module refers to certificate of FCC ID: 2AC7Z-ESPC3WROOM

The power for LTE module refers to certificate of FCC ID: XMR201909EC25AFX

The calculations in the table below use the highest gain of antenna for client EUT. These calculations represent worst case in terms of the exposure levels.
