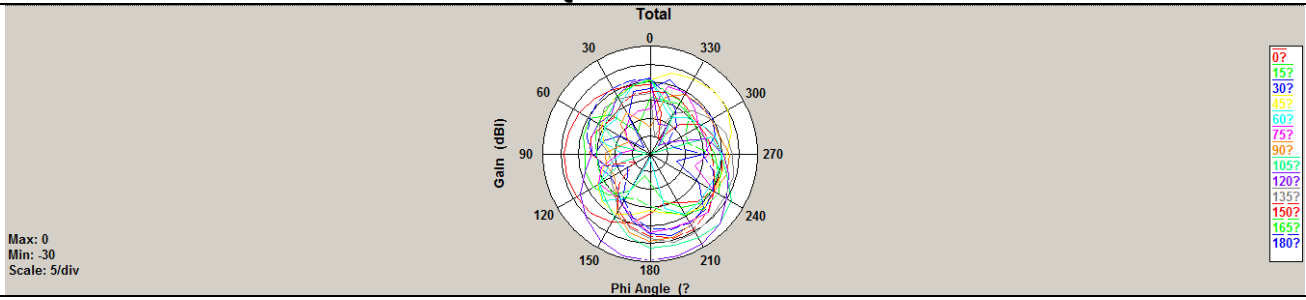

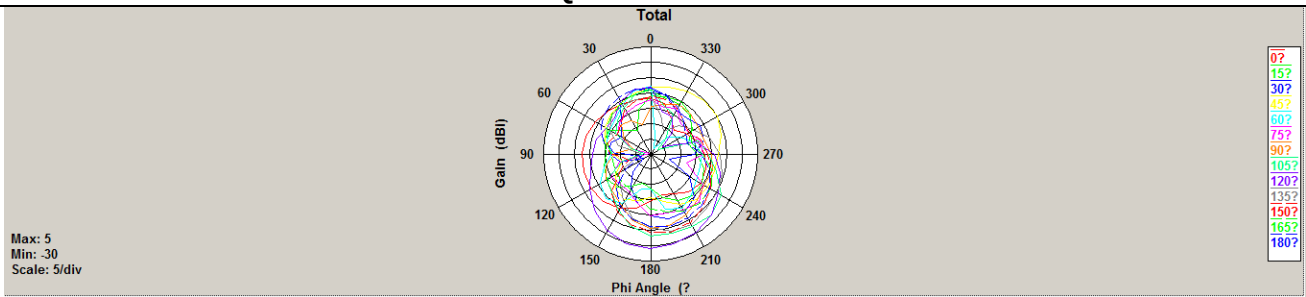

2D POLAR RADIATION PATTERN

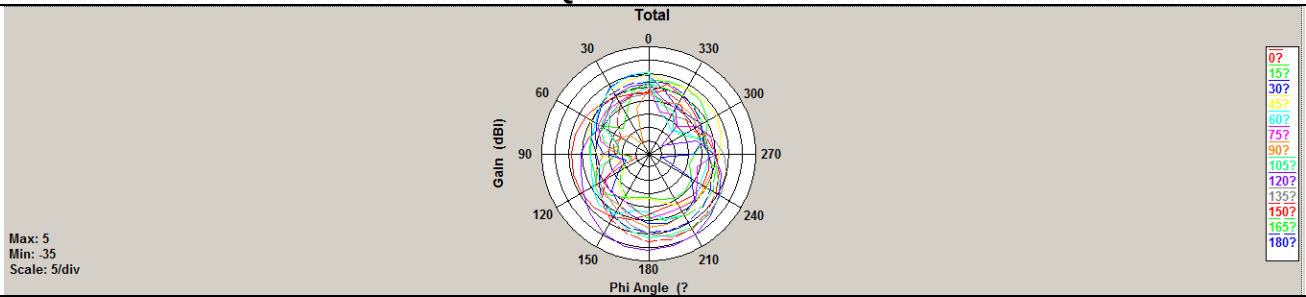

FREQUENCY=2500MHZ

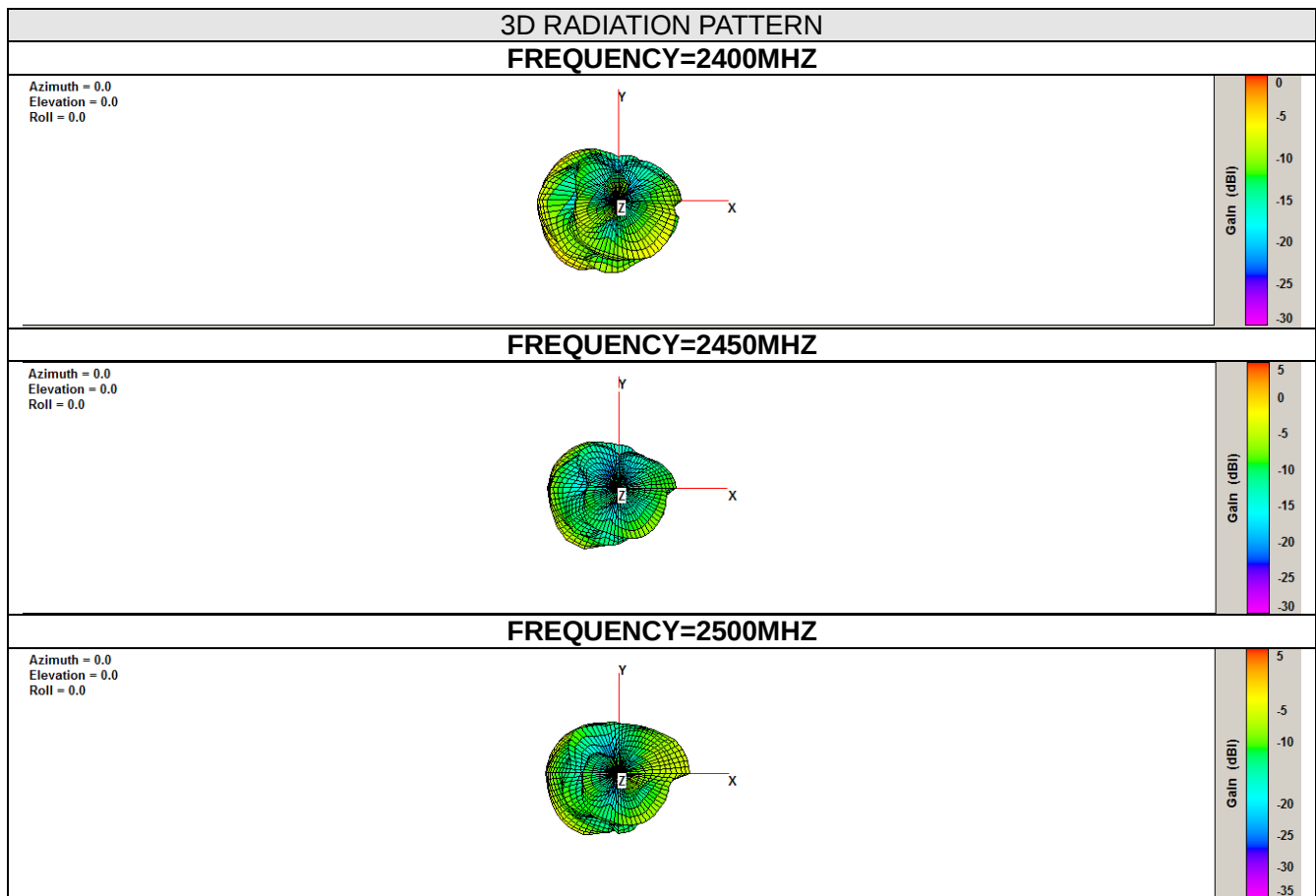

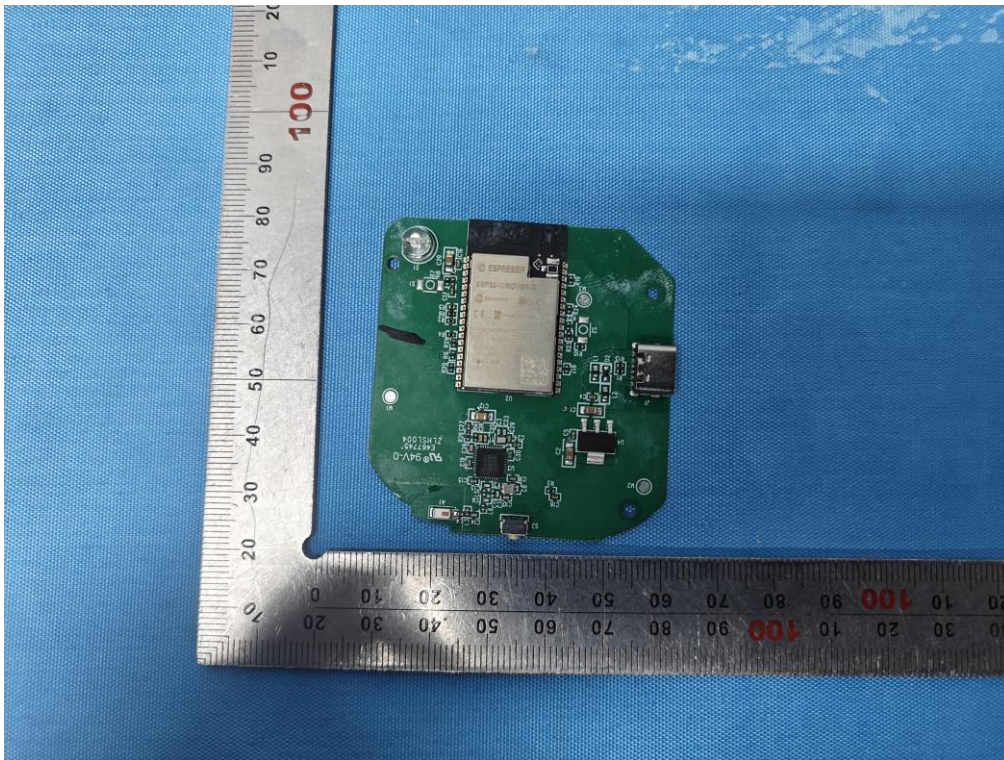

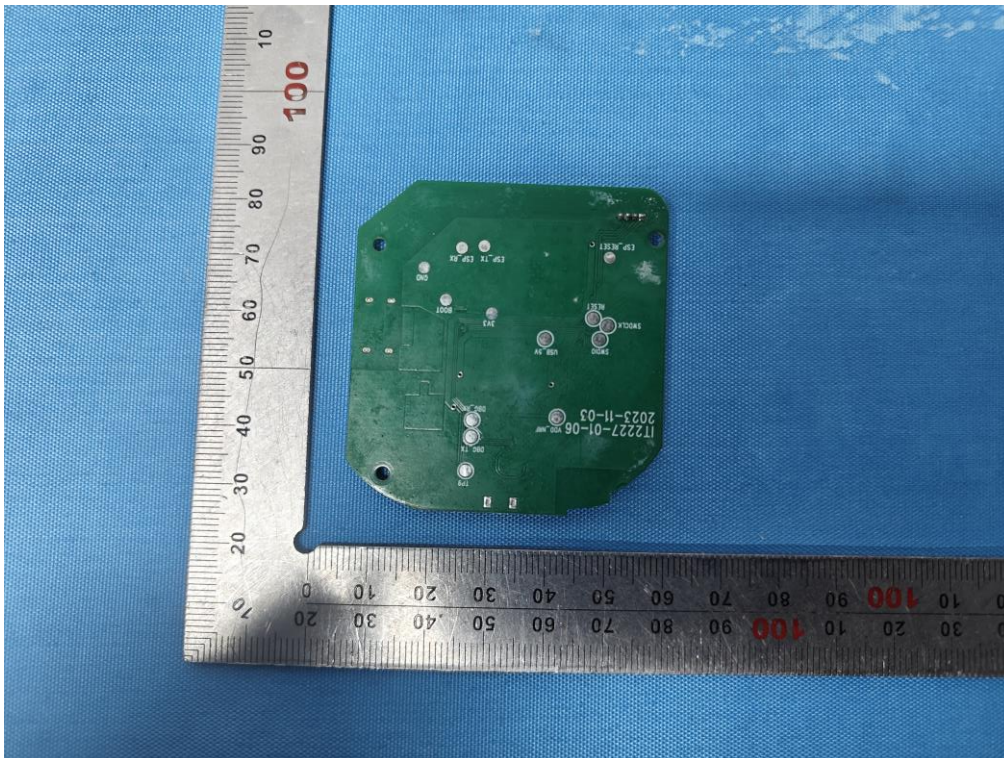

INTERNAL VIEW OF EUT-2



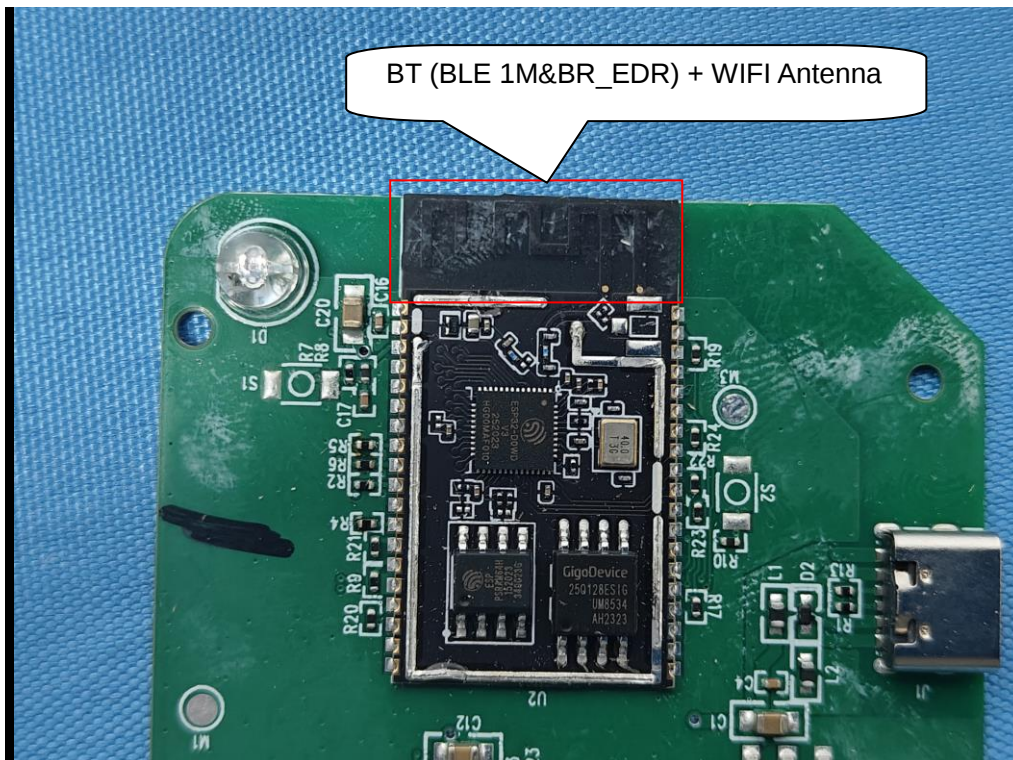
