4.1 RETURN LOSS REQUIREMENTS

The dipole used for SAR system validation measurements and checks must have a return loss of -. dB or better. The return loss measurement shall be performed against a liquid filled flat phanton with the phantom constucted as outlined in the fore mentioned standards.

4.2 MECHANICAL REQUIREMENTS
