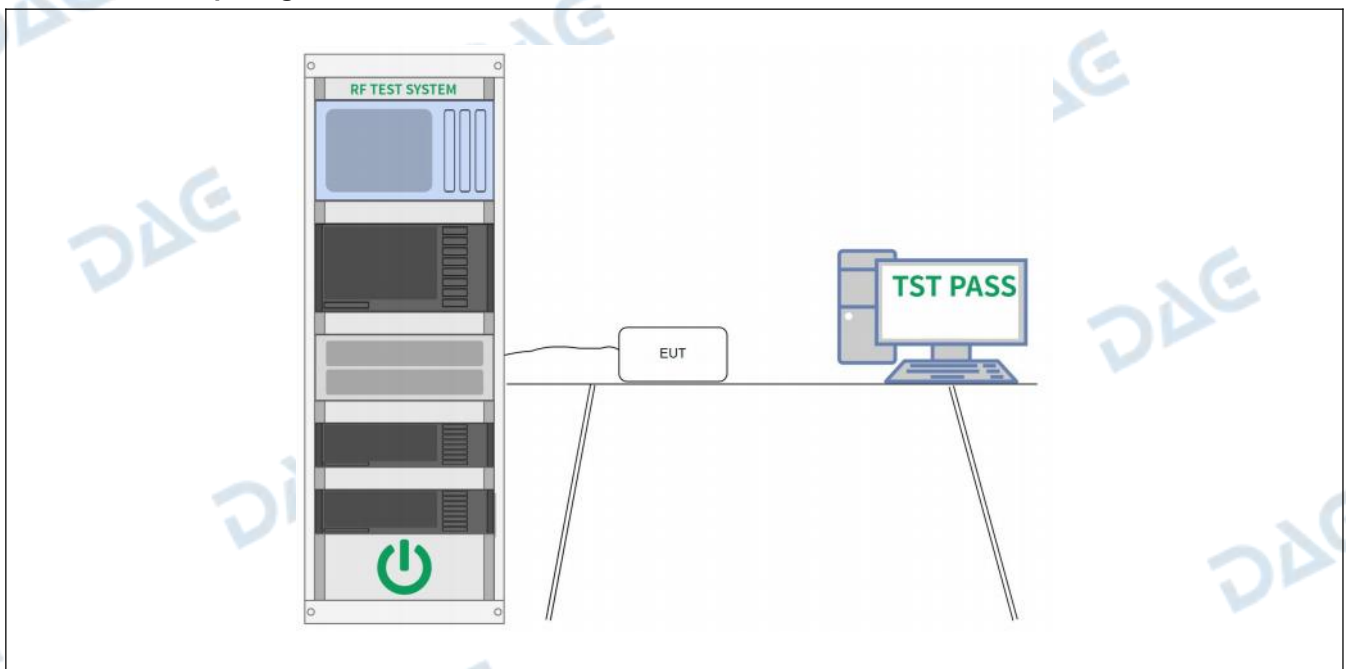
4.4 Power Spectral Density

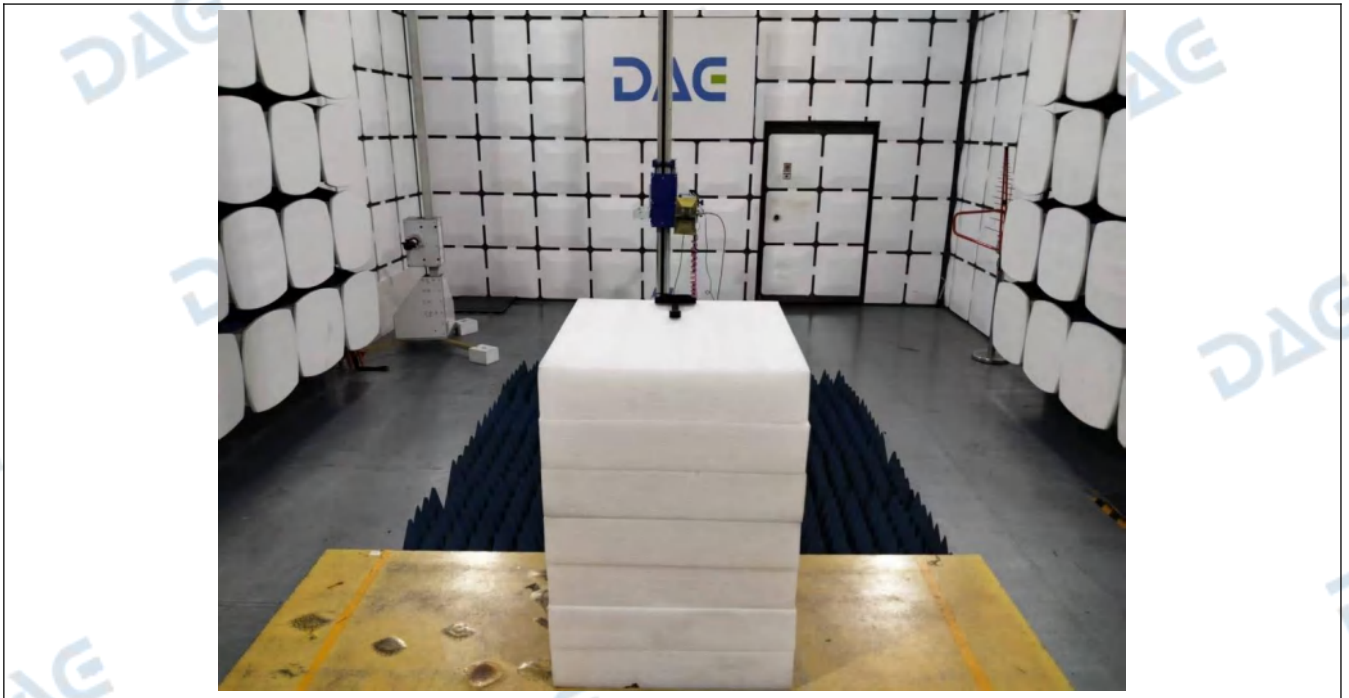
Conducted Emission at AC power line



Emissions in frequency bands (below 1GHz)



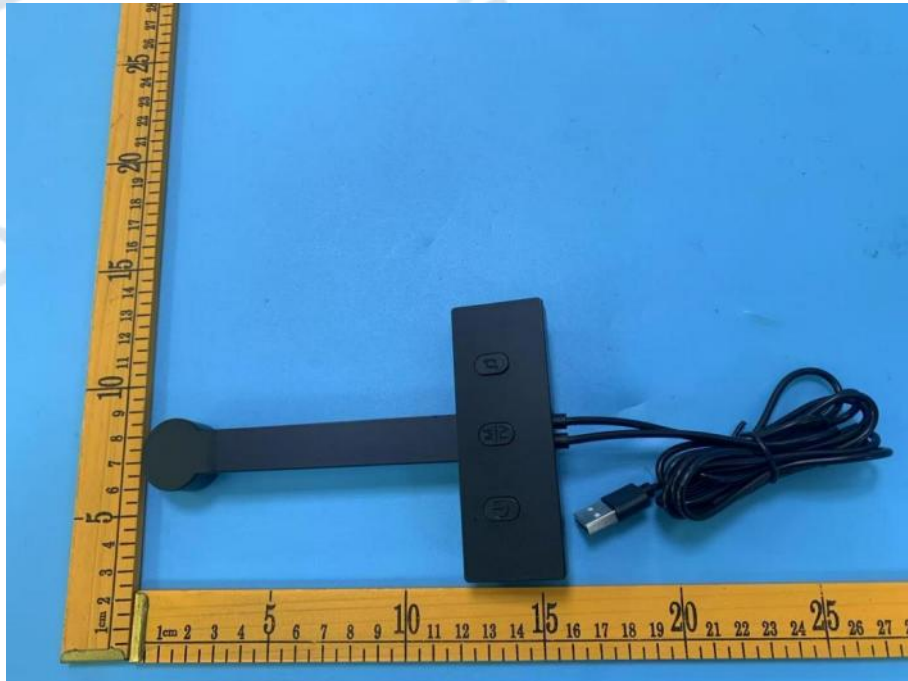
