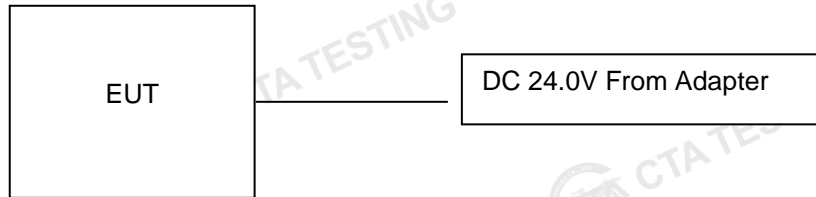

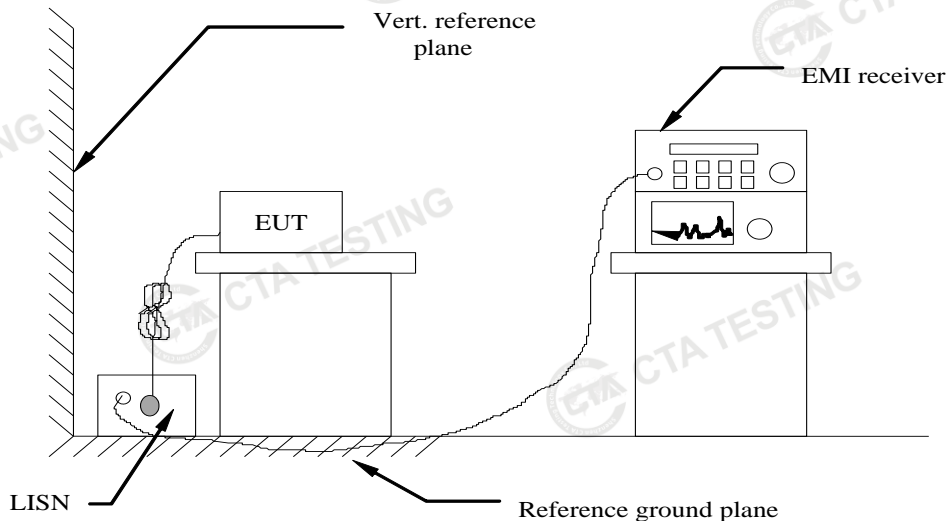

4. TEST CONDITIONS AND RESULTS

4.1. AC Power Conducted Emission

TEST CONFIGURATION



TEST PROCEDURE

- 1 The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. The EUT is a tabletop system, a wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.10-2013.
- 2 Support equipment, if needed, was placed as per ANSI C63.10-2013
- 3 All I/O cables were positioned to simulate typical actual usage as per ANSI C63.10-2013
- 4 The EUT received DC 12V power from adapter, the adapter received AC120V/60Hz and AC 240V/60Hz power through a Line Impedance Stabilization Network (LISN) which supplied power source and was grounded to the ground plane.
- 5 All support equipments received AC power from a second LISN, if any.
- 6 The EUT test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.
- 7 Analyzer / Receiver scanned from 150 KHz to 30MHz for emissions in each of the test modes.
- 8 During the above scans, the emissions were maximized by cable manipulation.

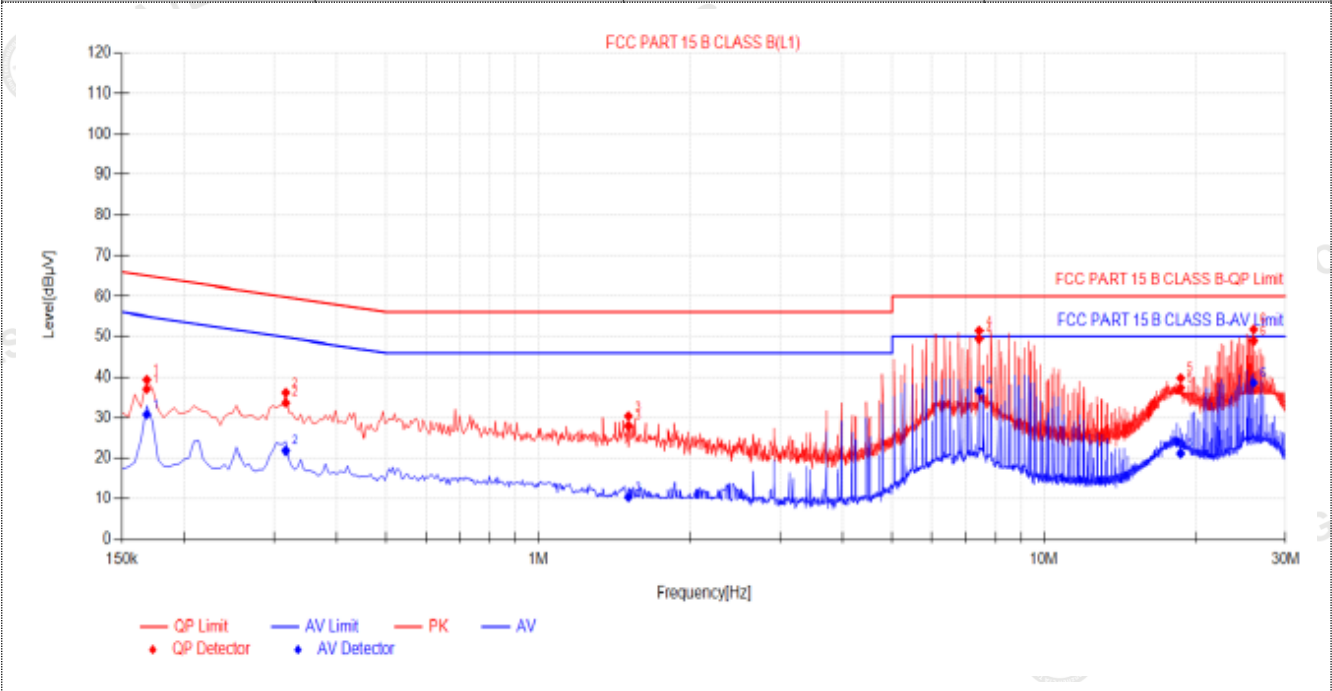

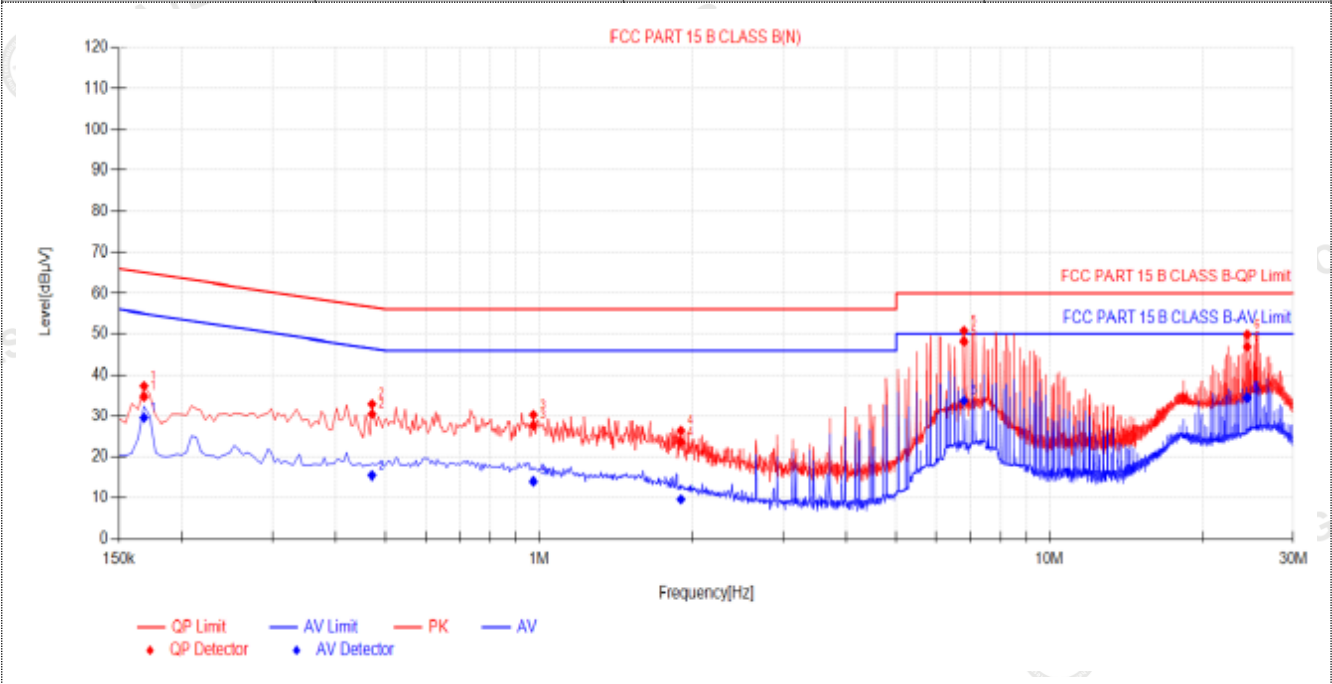

4.2. Radiated Emission

Limit

The maximum emissions outside of the frequency bands of operation shall be attenuated in accordance with the following limits:

- (1) For transmitters operating in the 5.15-5.25 GHz band: All emissions outside of the 5.15-5.35 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz.

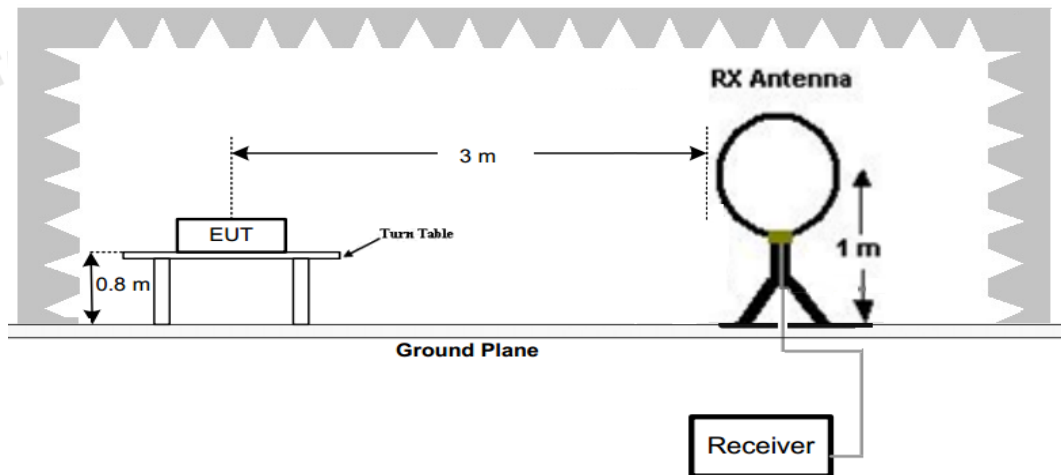

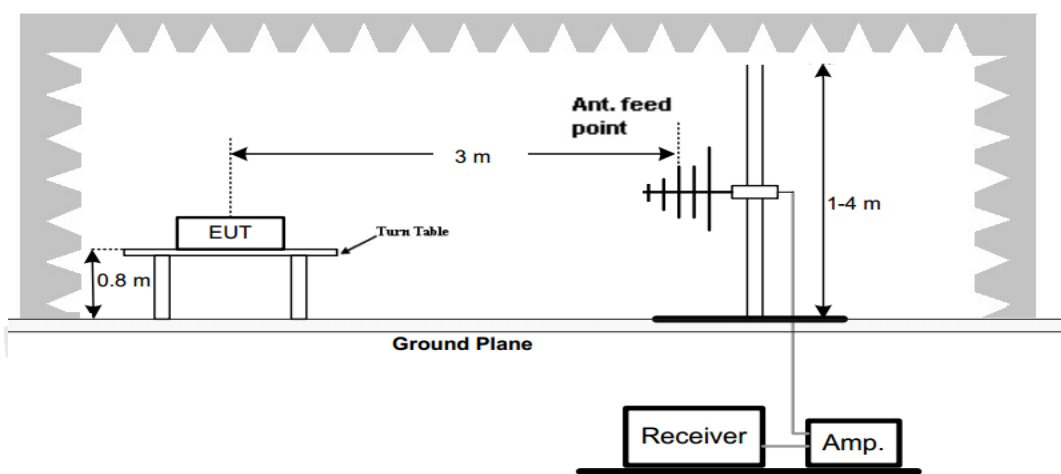

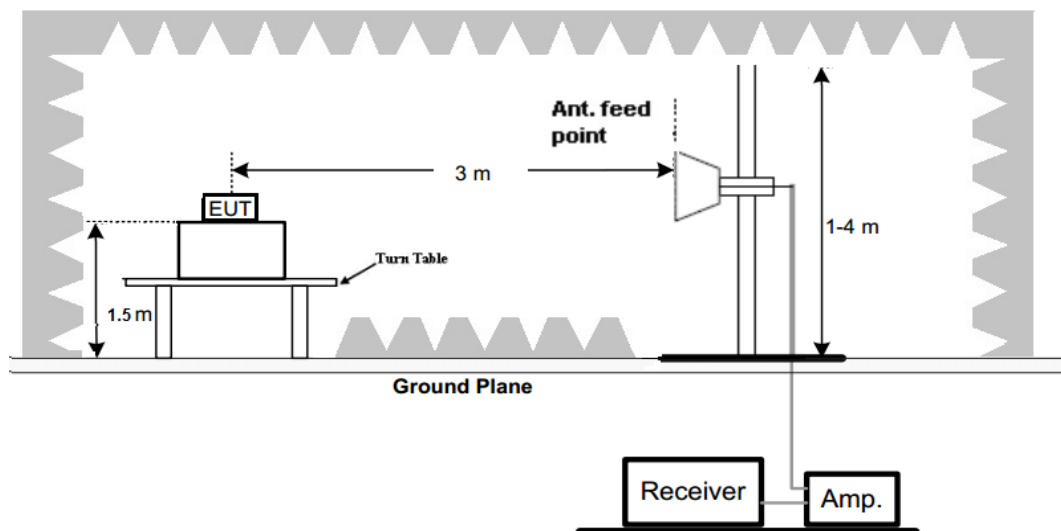
(A) Radiated Emission Test Set-Up, Frequency Below 30MHz

Test Procedure

- Below 1GHz measurement the EUT is placed on a turntable which is 0.8m above ground plane, and above 1GHz measurement EUT was placed on a low permittivity and low loss tangent turn table which is 1.5m above ground plane.

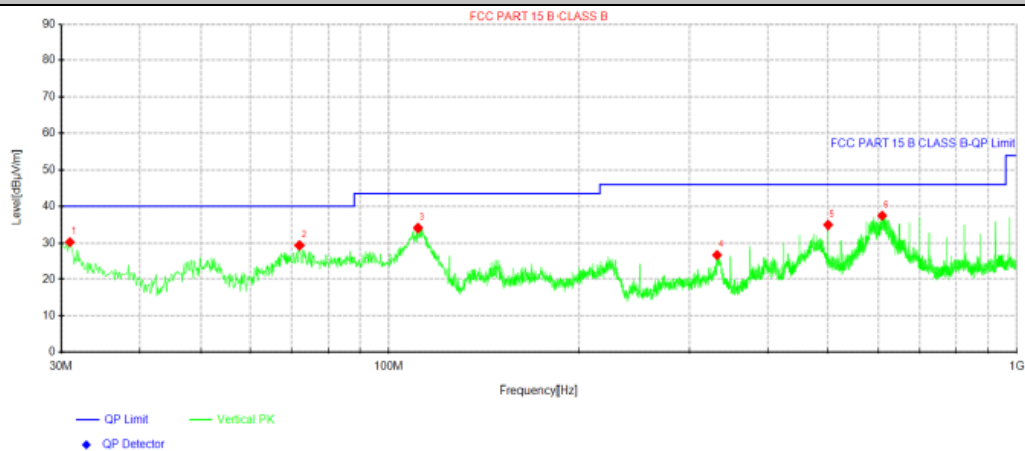

TEST PROCEDURE

According to KDB 789033 D02 General UNII Test Procedures New Rules v01 F: The rules requires “maximum power spectral density” measurements where the intent is to measure the maximum value of the time average of the power spectral density measured during a period of continuous transmission

- Create an average power spectrum for the EUT operating mode being tested by following the instructions in section II.E.2. for measuring maximum conducted output power using a spectrum analyzer or EMI receiver: select the appropriate test method (SA-1, SA-2, SA-3, or alternatives to each) and apply it up to, but not including, the step labeled, “Compute power...”. (This procedure is required even if the maximum conducted output power measurement was performed using a power meter, method PM.)
- Use the peak search function on the instrument to find the peak of the spectrum and record its value.
- Make the following adjustments to the peak value of the spectrum, if applicable:
 - If Method SA-2 or SA-2 Alternative was used, add $10 \log(1/x)$, where x is the duty cycle, to the peak of the spectrum.
 - If Method SA-3 Alternative was used and the linear mode was used in step II.E.2.g)(viii), add 1 dB to the final result to compensate for the difference between linear averaging and power averaging.
- The result is the Maximum PSD over 1 MHz reference bandwidth.
- For devices operating in the bands 5.15-5.25 GHz, 5.25-5.35 GHz, and 5.47-5.725 GHz, the above procedures make use of 1 MHz RBW to satisfy directly the 1 MHz reference bandwidth specified in § 15.407(a)(5). For devices operating in the band 5.725-5.85 GHz, the rules specify a measurement bandwidth of 500 kHz. Many spectrum analyzers do not have 500 kHz RBW, thus a narrower RBW may need to be used. The rules permit the use of a RBWs less than 1 MHz, or 500 kHz, “provided that the measured power is integrated over the full reference bandwidth” to show the total power over the specified measurement bandwidth (i.e., 1 MHz, or 500 kHz). If measurements are performed using a reduced resolution bandwidth (< 1 MHz, or < 500 kHz) and integrated over 1 MHz, or 500 KHz bandwidth, the following adjustments to the procedures apply:
 - Set $RBW \geq 1/T$, where T is defined in section II.B.I.a).
 - Set $VBW \geq 3 RBW$.
 - If measurement bandwidth of Maximum PSD is specified in 500 kHz, add $10\log(500\text{kHz}/RBW)$ to the measured result, whereas $RBW (< 500 \text{ KHz})$ is the reduced resolution bandwidth of the spectrum analyzer set during measurement.
 - If measurement bandwidth of Maximum PSD is specified in 1 MHz, add $10\log(1\text{MHz}/RBW)$ to the measured result, whereas $RBW (< 1 \text{ MHz})$ is the reduced resolution bandwidth of spectrum analyzer set during measurement.
 - Care must be taken to ensure that the measurements are performed during a period of continuous transmission or are corrected upward for duty cycle.

Note: As a practical matter, it is recommended to use reduced RBW of 100 KHz for the sections 5.c) and 5.d) above, since $RBW=100 \text{ KHz}$ is available on nearly all spectrum analyzers.

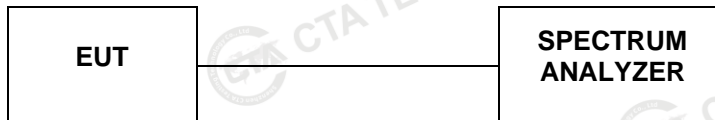

- Set RBW = 100 kHz.
- Set the video bandwidth (VBW) $\geq 3 \times$ RBW
- Detector = Peak.
- Trace mode = max hold.
- Sweep = auto couple.
- Allow the trace to stabilize
- Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.

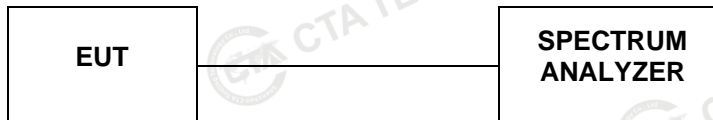

- Set the video bandwidth (VBW) = 1000 KHz (VBW > RBW)
- Detector = Peak.
- Trace mode = max hold.
- Sweep = auto couple.
- Allow the trace to stabilize
- Measure the maximum width of the emission that is 26 dB down from the maximum of the emission. Compare this with the RBW setting of the analyzer. Readjust RBW and repeat measurement as needed until the RBW/EBW ratio is approximately 1%.

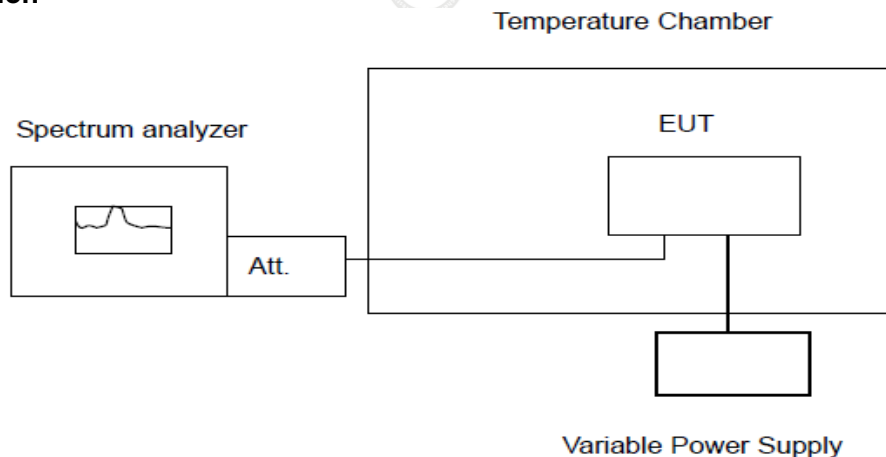
Standard Applicable

According to FCC §15.407(g) "Manufacturers of U-NII devices are responsible for ensuring frequency stability such that an emission is maintained within the band of operation under all conditions of normal operation as specified in the users manual."

According to FCC §2.1055(a) "The frequency stability shall be measured with variation of ambient temperature as follows:"

- (1) From -30° to $+50^{\circ}$ centigrade for all equipment except that specified in paragraphs (a) (2) and (3) of this section.
- (2) From -20° to $+50^{\circ}$ centigrade for equipment to be licensed for use in the Maritime Services under part 80 of this chapter, except for Class A, B, and S Emergency Position Indicating Radiobeacons (EPIRBS), and equipment to be licensed for use above 952 MHz at operational fixed stations in all services, stations in the Local Television Transmission Service and Point-to-Point Microwave Radio Service under part 21 of this chapter, equipment licensed for use aboard aircraft in the Aviation Services under part 87 of this chapter, and equipment authorized for use in the Family Radio Service under part 95 of this chapter.
- (3) From 0° to $+50^{\circ}$ centigrade for equipment to be licensed for use in the Radio Broadcast Services under part 73 of this chapter.

Test Procedure

The equipment under test was connected to an external AC or DC power supply and input rated voltage. RF output was connected to a frequency counter or spectrum analyzer via feed through attenuators. The EUT was placed inside the temperature chamber. Set the spectrum analyzer RBW low enough to obtain the desired frequency resolution and measure EUT 20 degree operating frequency as reference frequency. Turn EUT off and set the chamber temperature to -30° degree. After the temperature stabilized for approximately 30 minutes recorded the frequency. Repeat step measure with 10 degree increased per stage until the highest temperature of $+50^{\circ}$ degree reached.

4.9. Antenna Requirement
