




## INSTALLATION TIPS

### STEP 1




Push two tabs down to remove grille.

### STEP 2




Remove and keep two hood fasteners. Move hood rearward to remove.

### STEP 3




Remove plastic accent light cover and three nuts from vehicle.

### STEP 4




Attach front accent light assembly ① with three hex nuts ②.




Connect power cable to front accent light, then finish installation.



Pass the wiring harness[3]under the hood, first insert the three-pin plug into the original vehicle plug, and then connect the two-pin plug of the wiring harness and the light[1] plug.



**Note: When the color and mode do not match:**  
1. Settings in the upper right corner of the APP.  
2. RGB sequence.



Scan the QR code, download the control APP, then open the APP and connect to Bluetooth to control the RGB lights.
