SAR test exclusion for 116 – 123 GHz RADAR devices

According to FCC § 1.1307(b)(3)(i)(C) and the Table 1 in (C), the EUT is exempted from SAR evaluation.

SAR test exclusion according to RSS-102 Issue 5 Section 2.5.2

According to RSS-102 Issue 5 section 2.5.2, if the EUT operates at or above 6 GHz and the source-based, time-averaged maximum e.i.r.p of the device is equal to or less than 5 W (adjusted for tune-up tolerance), then it is exempted from SAR evaluation.
