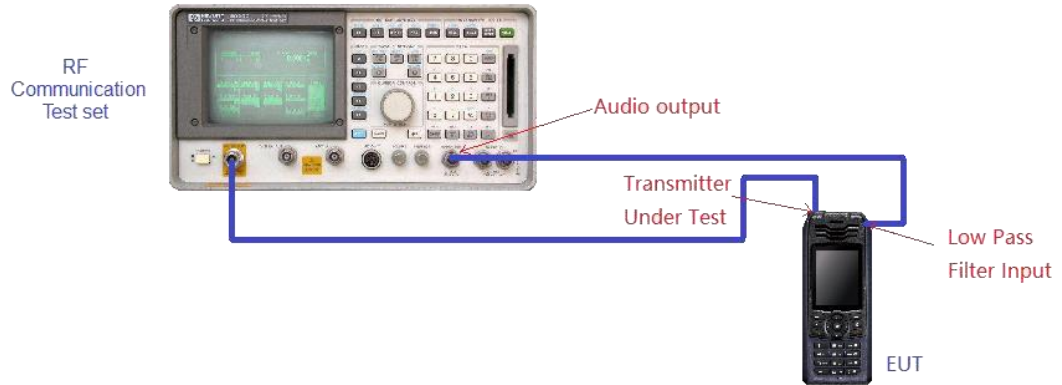

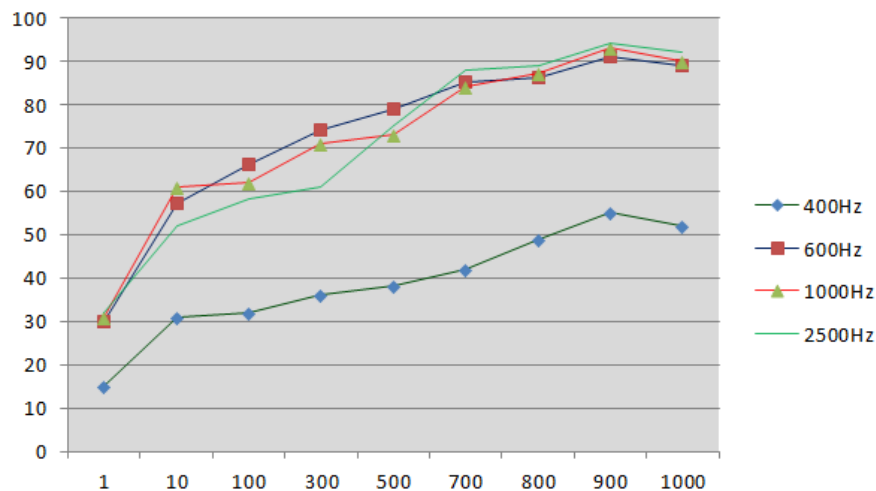

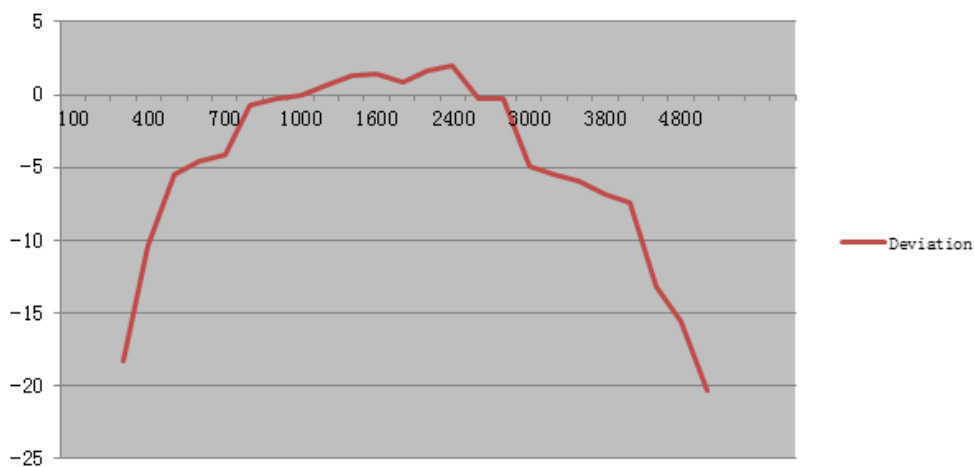

10 KHz Channel Separations**



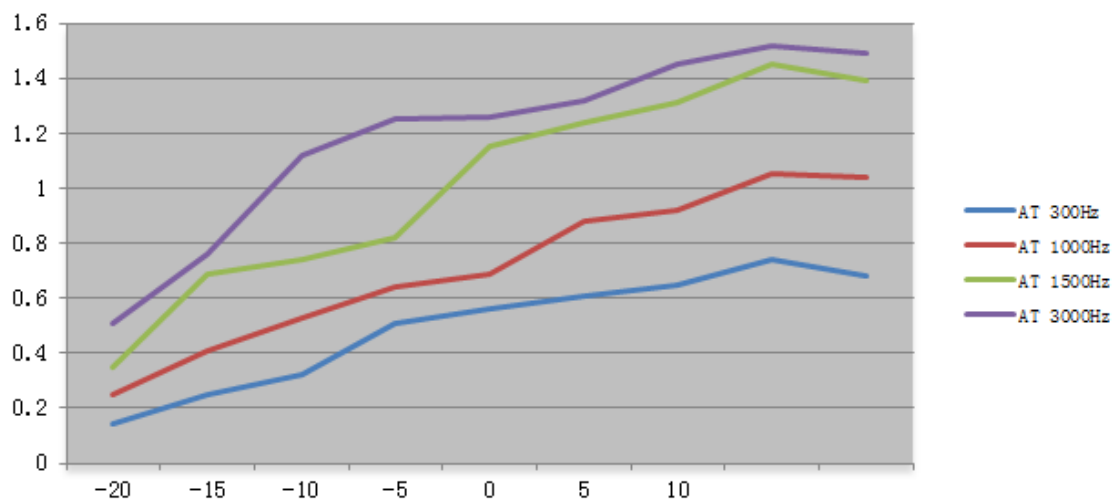

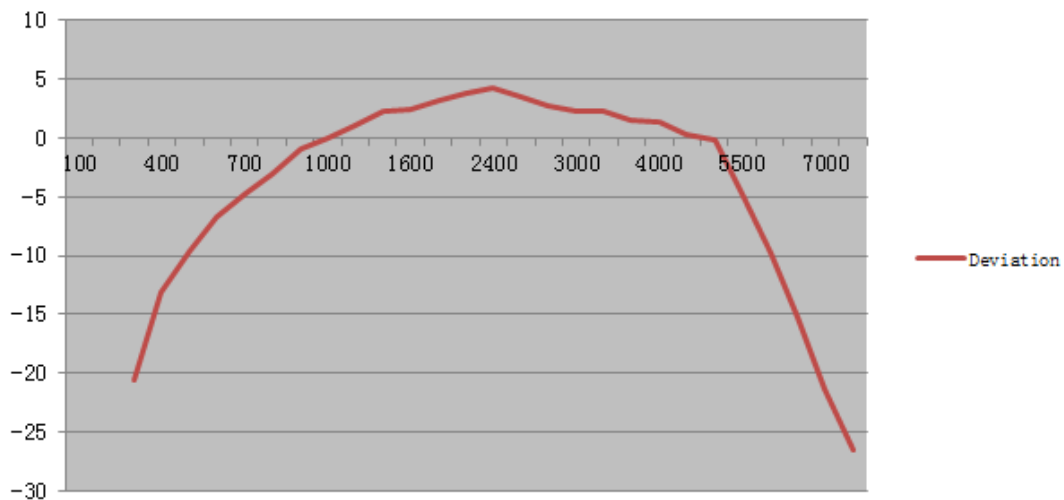
