## 1. GENERAL CONCLUSION

According to FCC KDB447498 D01, Appendix A, SAR Test Exclusion Thresholds for 100 MHz - 6 GHz and  $\leq 50$  mm, the 1-g and 10-g SAR test exclusion thresholds are determined by the following:

$[(\text{max. power of channel, including tune-up tolerance, mW}) / (\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}]$   
 $\leq 3.0$  for 1-g SAR, and  $\leq 7.5$  for 10-g extremity SAR, where

- $f(\text{GHz})$  is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation
- The result is rounded to one decimal place for comparison
