The antenna is a Rod antenna which permanently attached, and the best case gain of the antenna is 1.16dBi . It complies with the standard requirement.



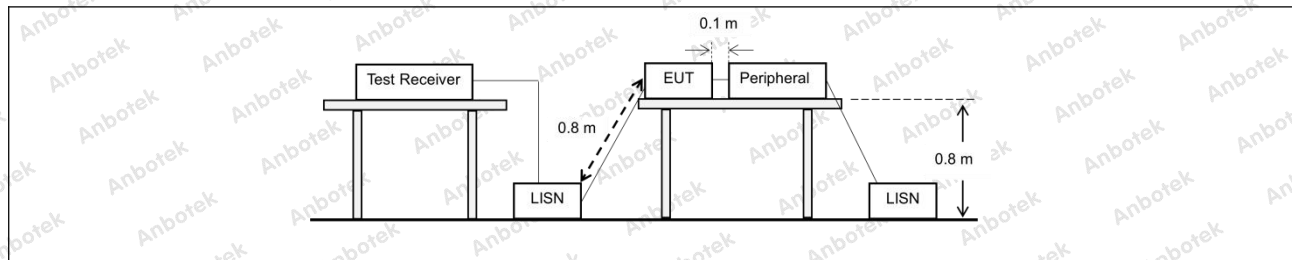
