I am sorry for contacting you directly despite the instructions given in the message below but the KDB inquiry tool on your website shows the error as shown in the attachment and I was not able to submit the response that way.

So, first of all I wish you a happy new year.

Please find my comments to your inquiry as below.

- 1) Is the address of the agent a valid physical US mailing address (not a US post office box, not a virtual mailbox, not P.O. Boxes, not a vacant lot, not a public building, etc.)

We used a google maps search to find the address.

- 2) Is the agent physically located at that valid US address such that the agent can be legally served at that address?

We contacted the agent via phone to verify this point.

- 3) Has the listed agent clearly agreed in writing to serve as the agent for the grantee at that address?

A signed agreement between the applicant and the local agent exists and is part of the internal documentation stored at the TCB.

We involved the applicant in this inquiry to make the aware about the FCC concerns and being transparent in our work. Together with an unusual workload during the Christmas time we missed to send the reply in time.
