A: Conducted Emission on Live Terminal (150kHz to 30MHz)

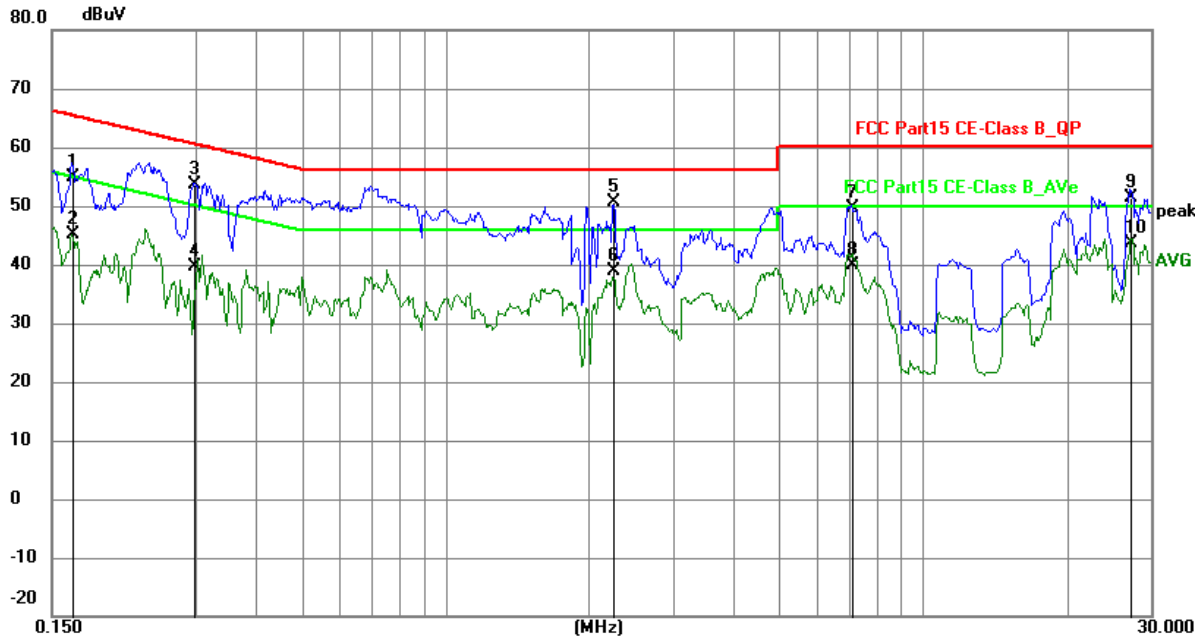

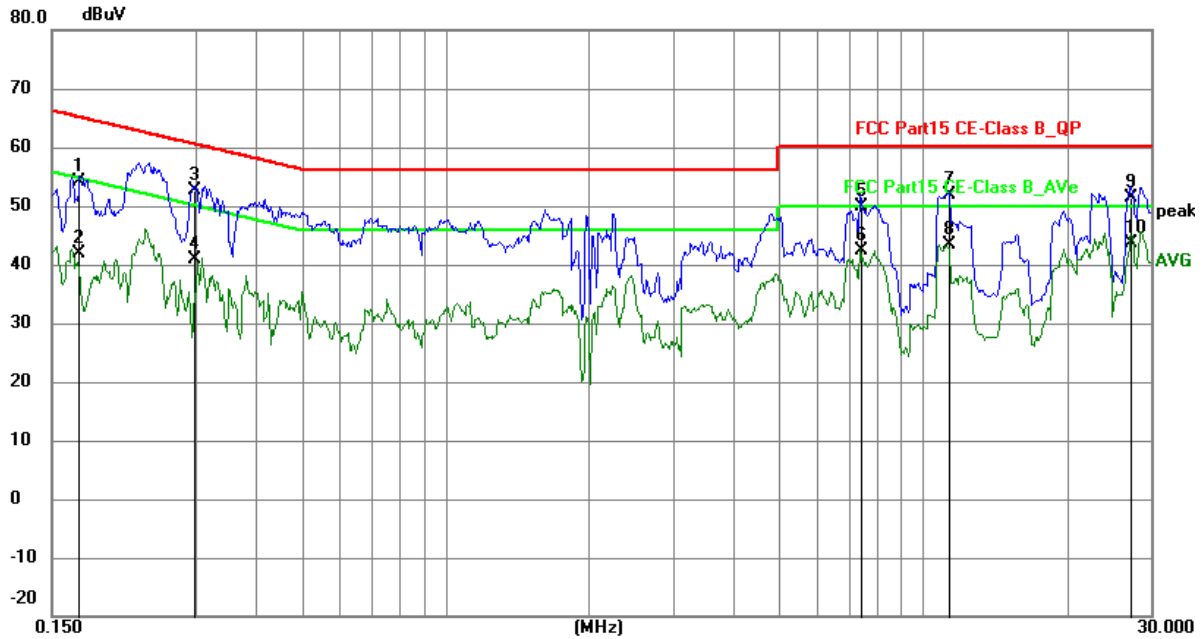

6 Radiated Emission Test

6.1 Test Method and test Procedure:

- (1) The EUT was tested according to ANSI C63.10-2013. The radiated test was performed at Timeway EMC Laboratory. This site is on file with the FCC laboratory division, Registration No. 744189
- (2) The EUT, peripherals were put on the turntable which table size is 1m x 1.5 m, table high 0.8 m. All set up is according to ANSI C63.10-2013.
- (3) The frequency spectrum from 9kHz to 25 GHz was investigated. The frequency spectrum is set as follows:

- (4) The antenna high is varied from 1 m to 4 m high to find the maximum emission for each frequency.
- (5) The antenna polarization: Vertical polarization and Horizontal polarization.

For radiated emissions from 9kHz to 30MHz



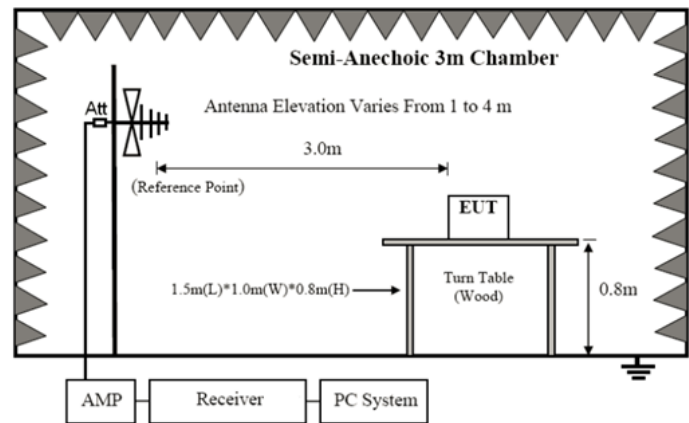

The transmitter output was connected to the spectrum analyzer through an attenuator. The bandwidth of the fundamental frequency was measured by spectrum analyzer with 30kHz RBW and 100kHz VBW.

The 20dB bandwidth is defined as the total spectrum the power of which is higher than peak power minus 20dB.

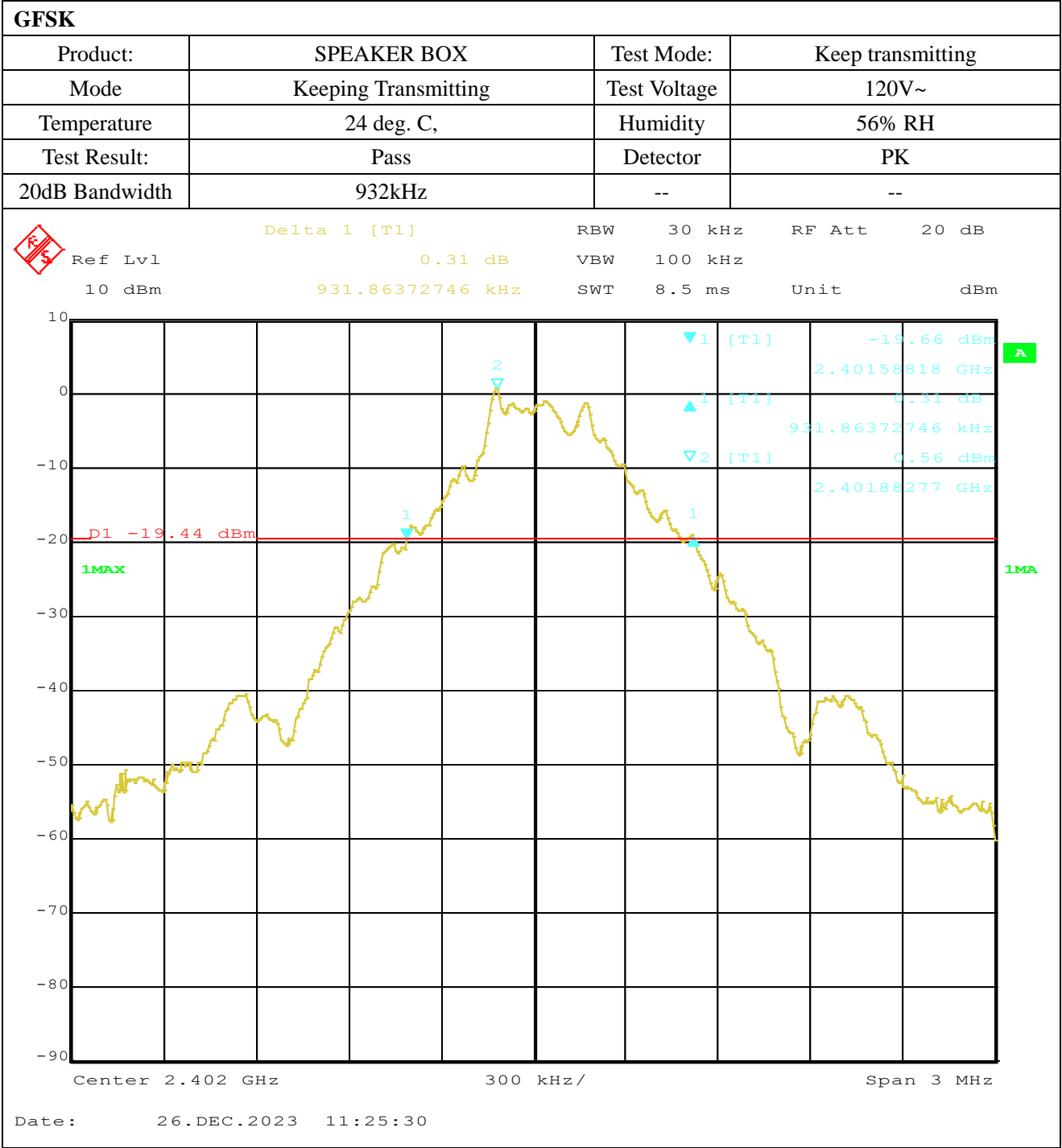
