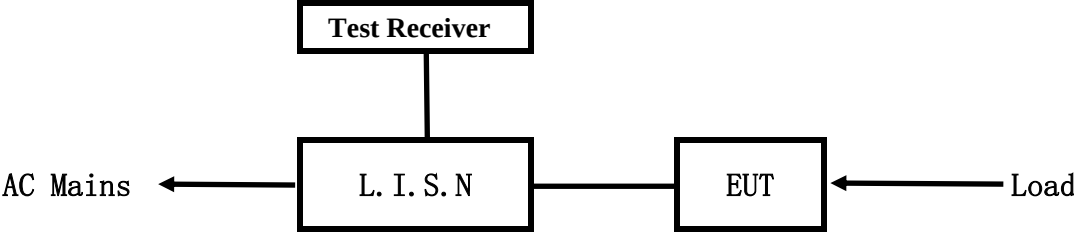

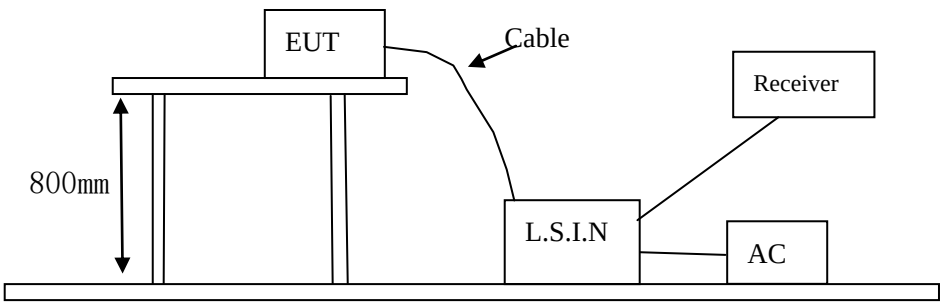

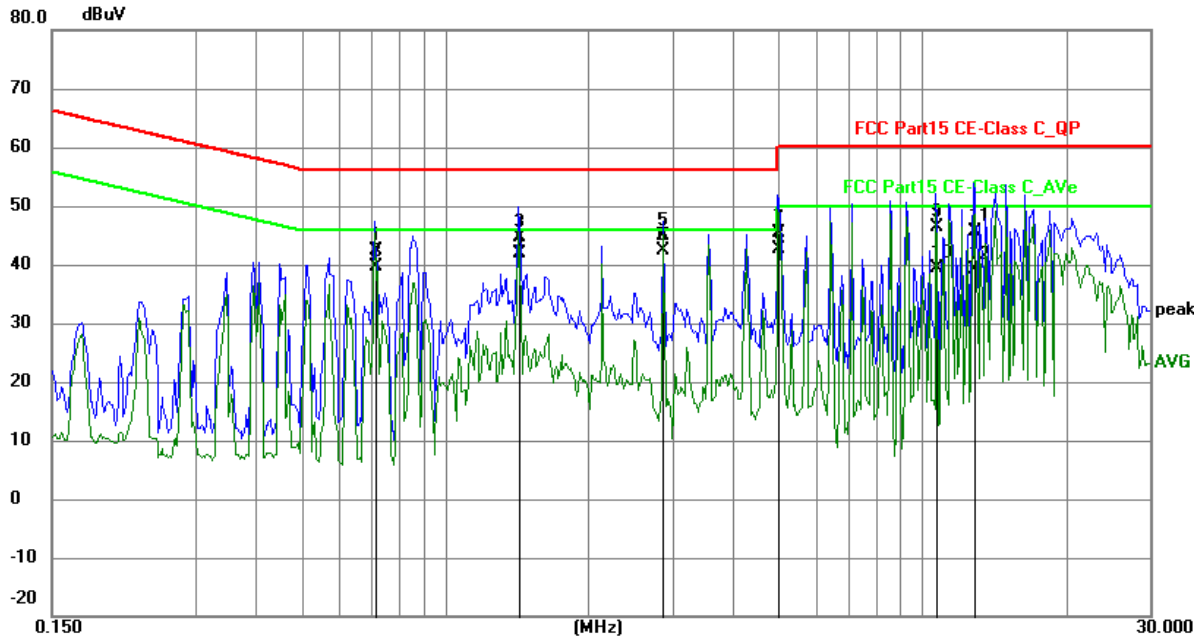

## 6 Radiated Emission Test

### 6.1 Test Method and test Procedure:

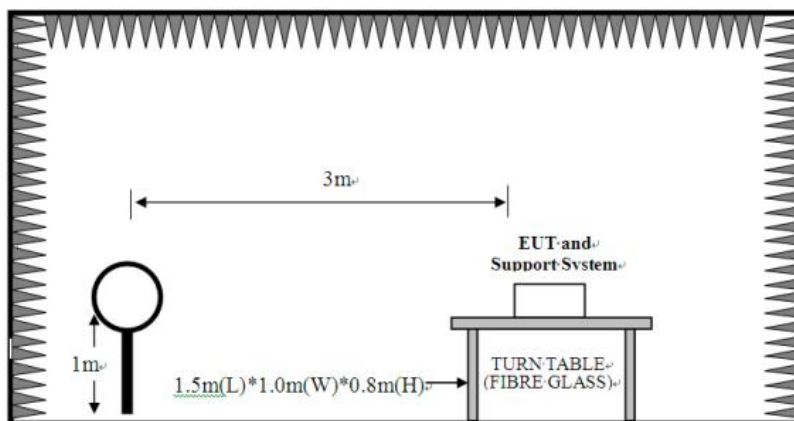

For radiated emissions from 9kHz to 30MHz



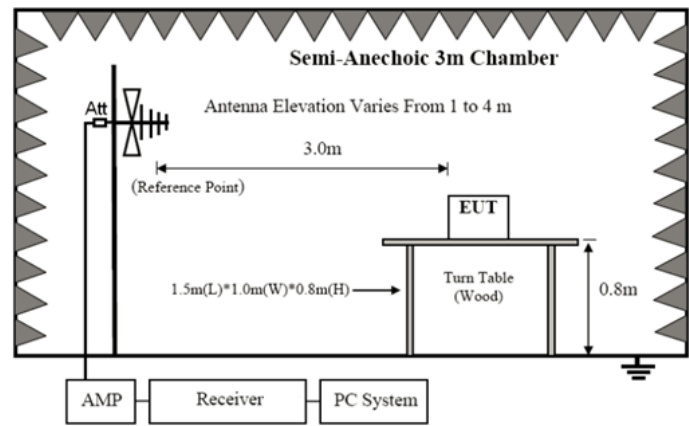

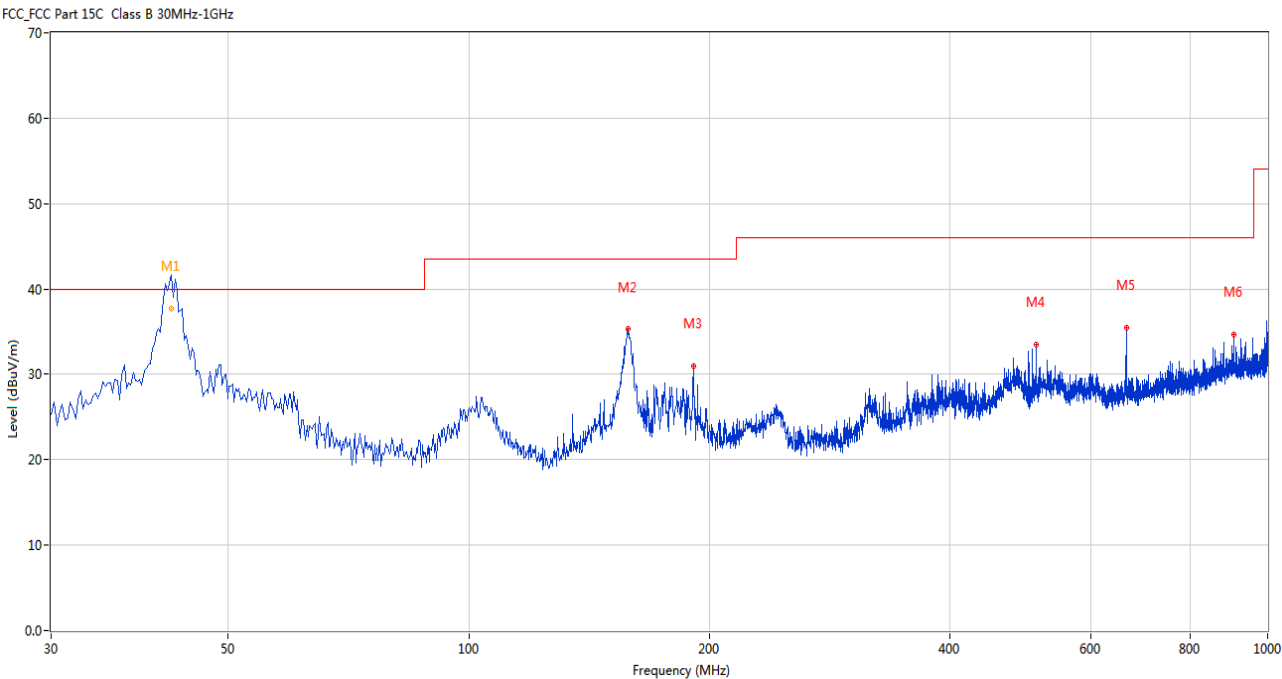


Radiated Emission In Vertical (30MHz----1000MHz)
