

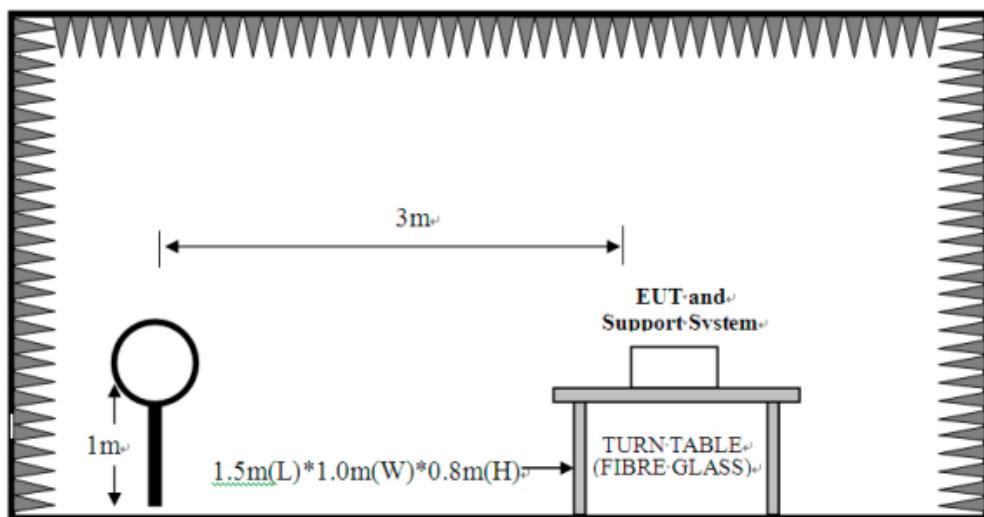
## 6 Radiated Emission Test

### 6.1 Test Method and test Procedure:

- (1) The EUT was tested according to ANSI C63.10-2020+Cor.1-2023. The radiated test was performed at Timeway EMC Laboratory. This site is on file with the FCC laboratory division, Registration No. 744189
- (2) The EUT, peripherals were put on the turntable which table size is 1m x 1.5 m, table high 0.8 m. All set up is according to ANSI C63.10-2020+Cor.1-2023.
- (3) The frequency spectrum from 30 MHz to 25 GHz was investigated. All readings from 30 MHz to 1 GHz are quasi-peak values with a resolution bandwidth of 120 kHz. All readings are above 1 GHz, peak values with a resolution bandwidth of 1 MHz (Note: for Fundamental frequency radiated emission measurement, RBW=3MHz, VBW=10MHz). Measurements were made at 3 meters.
- (4) The antenna height is varied from 1 m to 4 m high to find the maximum emission for each frequency.
- (5) The antenna polarization: Vertical polarization and Horizontal polarization.

For radiated emissions from 9kHz to 30MHz








## 7. Band Edge

- (2) Set Spectrum as RBW=1MHz, VBW=3MHz and Peak detector used for PK value. RBW=1MHz, VBW=10Hz and Peak detector used for AV value.
- (3) The antenna high is varied from 1 m to 4 m high to find the maximum emission for each frequency.
- (4) The antenna polarization: Vertical polarization and Horizontal polarization.
