VOL- VOL+ POWER LIGHT



POWER ①Long press on/Off (short press Pause/play)

②Double-tap Bluetooth to disconnect

VOL + Short press Vol+ (Long press for next song)

VOL - Short press Vol- (Long press previous)

- ① Press and hold the machine + - key to enter TWS connection mode, accompanied by a beep (to enter TWS mode)
- ② When TWS pairing is successful, accompanied by a tone (TWS connection), the main unit's indicator light is blinking, and the secondary unit has no indicator light.
- ③ When TWS pairing is successful, press and hold the + - key to disconnect TWS, accompanied by a beep (TWS disconnected), if the main unit is not connected to Bluetooth, the main/secondary indicator light flashes, if the main unit is connected to Bluetooth, the main unit indicator light has no light (still maintains the Bluetooth connection), and the second unit indicator light flashes.

NOTE

- ① If TWS is not successfully connected within 15 seconds after entering TWS mode, you need to repeat the steps to enter TWS.
- ② After entering TWS mode, you cannot exit this mode and connect Bluetooth within 15 seconds, you need to wait for 15 seconds to exit automatically.
- ③ Before entering TWS mode, both machines must be in the Bluetooth-unconnected state;
- ④ TWS Unable to control the secondary unit when pairing is successful Disconnect Bluetooth

Low battery indicator

- ① When 20% of battery power is remaining; one low battery alert occurs
- ② Automatic shutdown when battery level is 5%; two low battery alerts occur

White Light

- ① No Bluetooth connection, white light blinks at 1 second intervals
- ② White light goes out when Bluetooth is connected
- ③ In any state, plug in the charging cable, the white light will be on for a long time, and off when fully charged.
- ④ White light flashes at 300 ms intervals in TWS pairing state

保修政策 WARRANTY POLICY

Subject to the following terms and conditions, MOON will provide consumers with a three-year warranty for quality problems caused by raw materials or production processes.

- A. These terms and conditions apply only to products sold by MOON in mainland China.
- B. These terms and conditions are only applicable to consumers who own MOON products for daily consumption through purchase and other legal means (hereinafter referred to as consumers).
- C. Consumers should read the product manual in detail before using the product.
- D. The warranty service is limited to under normal circumstances within the effective warranty period (no date of purchase to the production date shall prevail), due to product quality caused by non-man-made damage to the fault, with the invoice and warranty card will enjoy the following services:
 - 1) Consumers can enjoy free return, replacement or repair services at the original place of purchase within seven days of purchase.
 - 2) Consumers can enjoy free replacement or warranty service at the original place of purchase within 15 days from the date of purchase.

3) Within one year from the purchase, you can enjoy free warranty service at the company's designated maintenance point.

E. The following circumstances are not within the scope of the three Guarantees:

- 1) Damage caused by all human factors, including failure and damage caused by use under abnormal working conditions, use not according to the instructions or use in the environment specified in the instructions;
- 2) Without the consent of the company, the user privately disassemble, repair, modify;
- 3) The natural wear of the product and the periodic inspection, maintenance, repair or replacement of parts caused by it;
- 4) The contents of the valid invoice and the warranty card are inconsistent or altered;
- 5) Damage caused by force majeure;

F. After the expiration of the three guarantees of service, or within the three guarantees but not within the scope of service, the company can provide paid maintenance services.

G. If there is any inconsistency between the warranty instructions of this product and the provisions of the national three guarantees, the provisions of the national three guarantees shall prevail.
