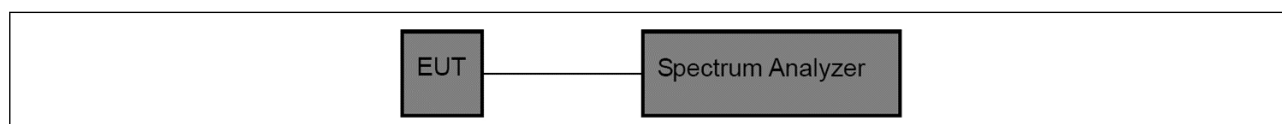
4. 6dB Bandwidth

Test Requirement:	47 CFR 15.247(a)(2)
Test Limit:	Refer to 47 CFR 15.247(a)(2), Systems using digital modulation techniques may operate in the 902-928 MHz, and 2400-2483.5 MHz bands. The minimum 6 dB bandwidth shall be at least 500 kHz.

Procedure:	11.8.1 Option 1 The steps for the first option are as follows: a) Set RBW = shall be in the range of 1% to 5% of the OBW but not less than 100 kHz. b) Set the VBW $\geq [3 \times \text{RBW}]$. c) Detector = peak. d) Trace mode = max-hold. e) Sweep = No faster than coupled (auto) time. f) Allow the trace to stabilize. g) Measure the maximum width of the emission by placing two markers, one at the lowest frequency and the other at the highest frequency of the envelope of the spectral display, such that each marker is at or slightly below the “-6 dB down amplitude”. 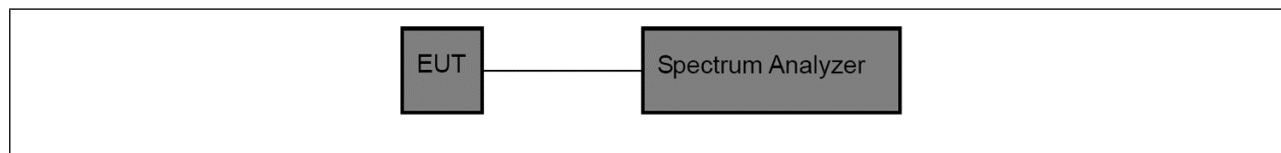
5. Maximum Conducted Output Power

Test Requirement:	47 CFR 15.247(b)(3)
Test Limit:	Refer to 47 CFR 15.247(b)(3), For systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: 1 Watt.
