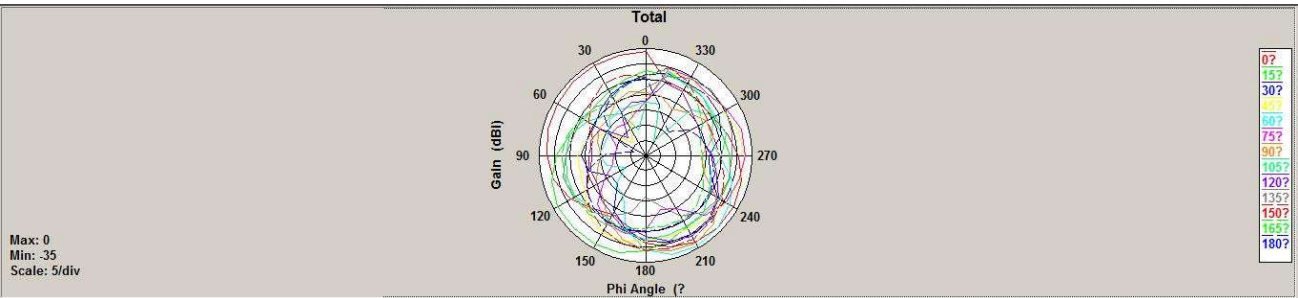

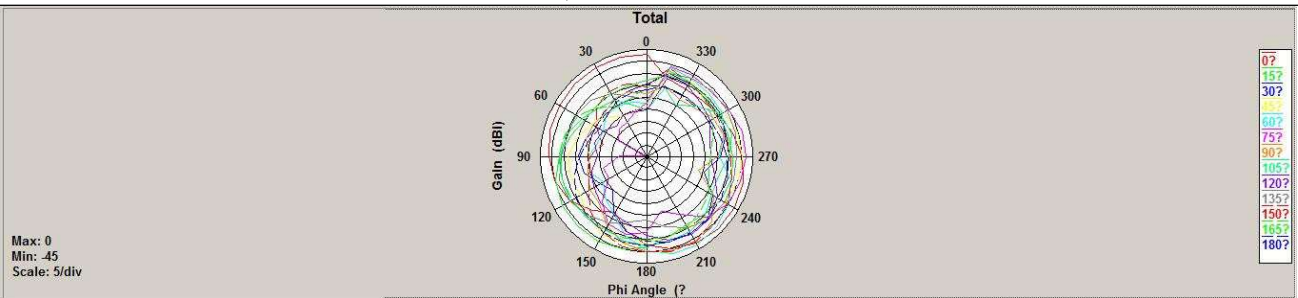

2D POLAR RADIATION PATTERN

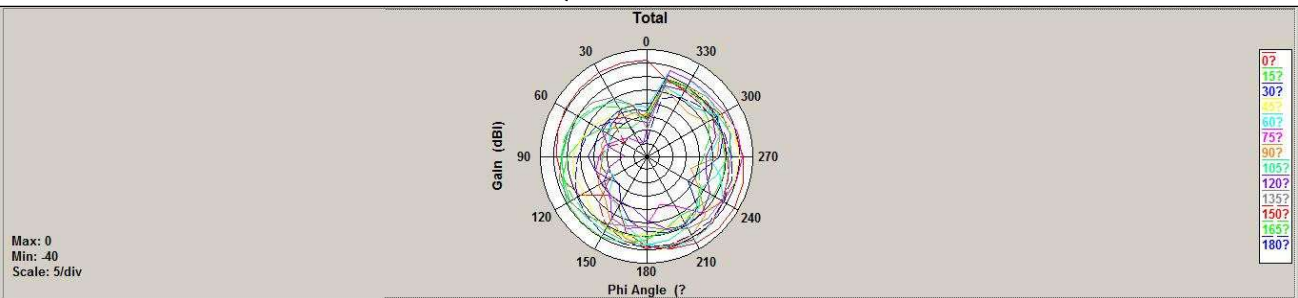

FREQUENCY=2500MHZ

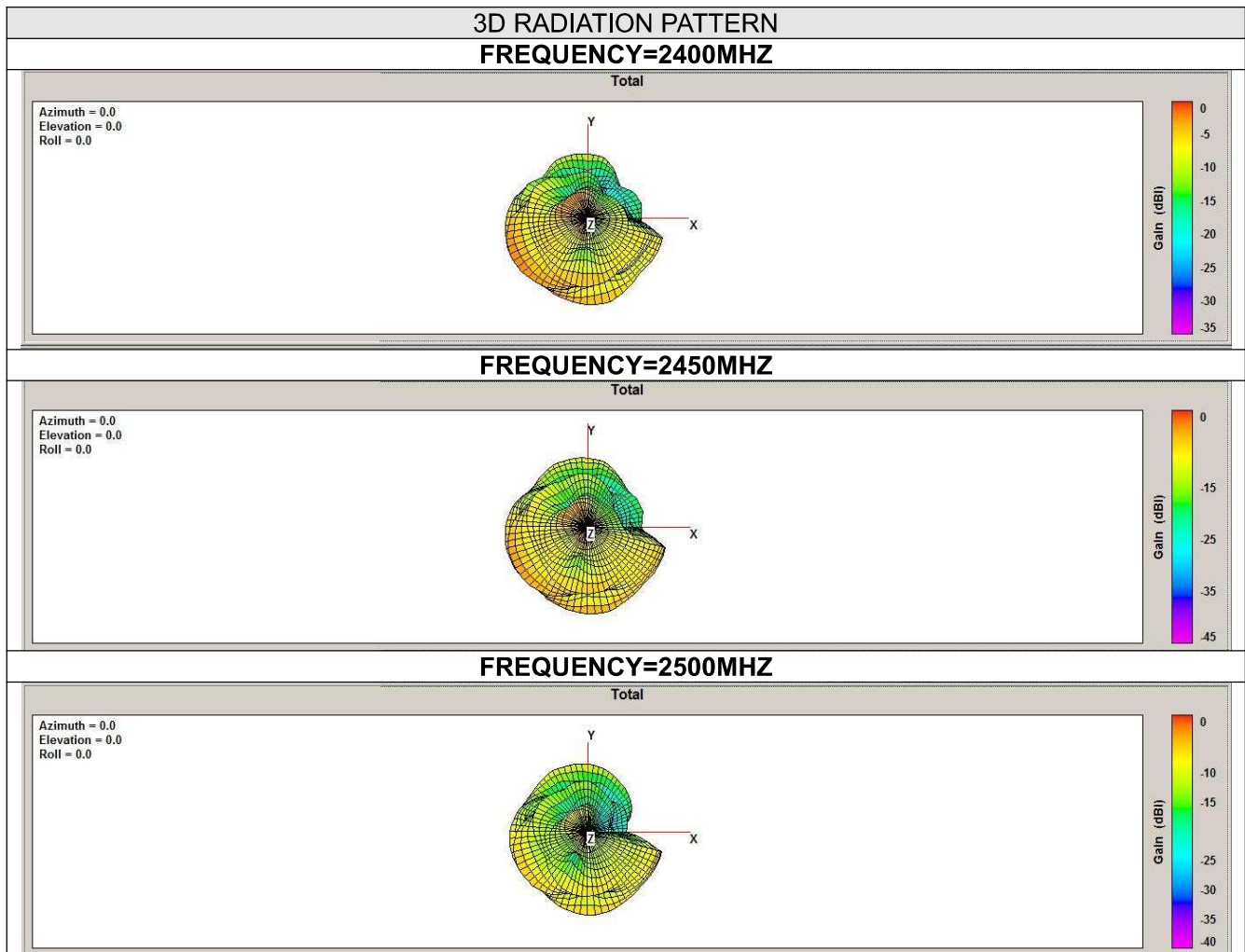

FRONT VIEW OF EUT



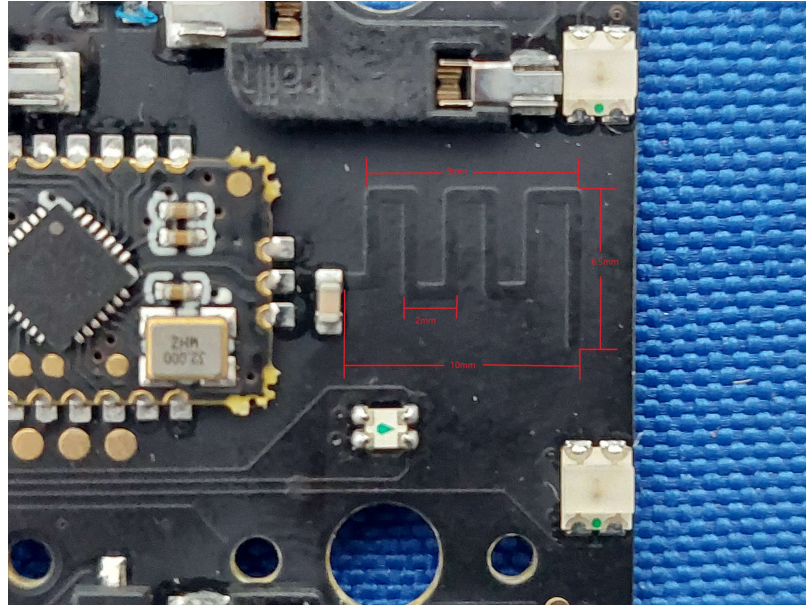
BACK VIEW OF EUT
