## 2. Antenna requirement

The antenna is a PCB antenna which permanently attached, and the best case gain of the antenna is **1.43 dBi**. It complies with the standard requirement.



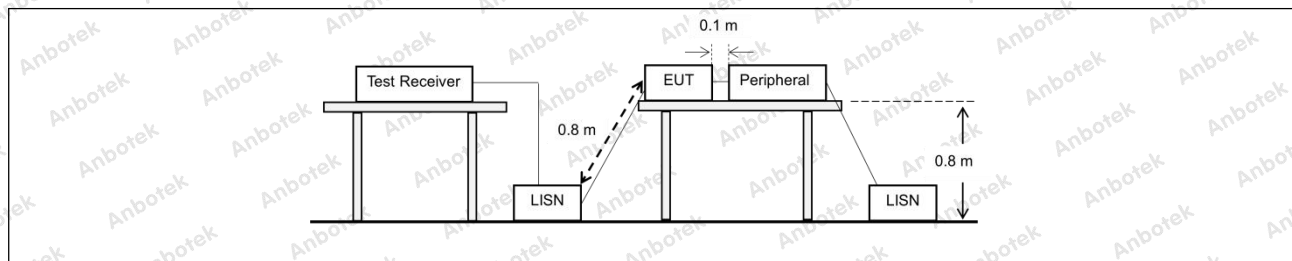
