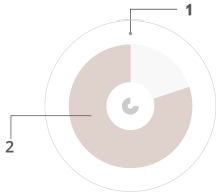
Precautions During Use

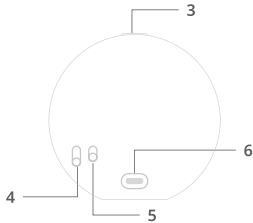
Cases Where Warranty Does Not Apply

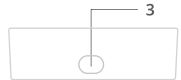

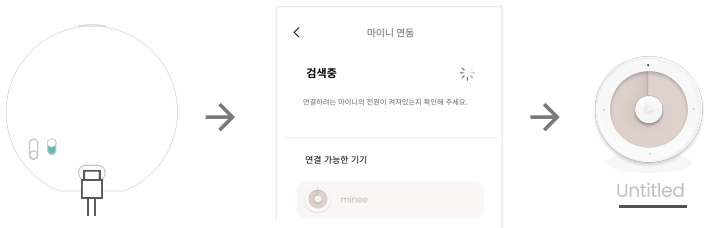

How to set up the first

1. After charging with the USB-C cable, turn on the power of the mine timer.
2. Search for 'minee' in the App Store, Google Play, download the  application, and log in.
3. After linking the machine in the App, write a timer name.
