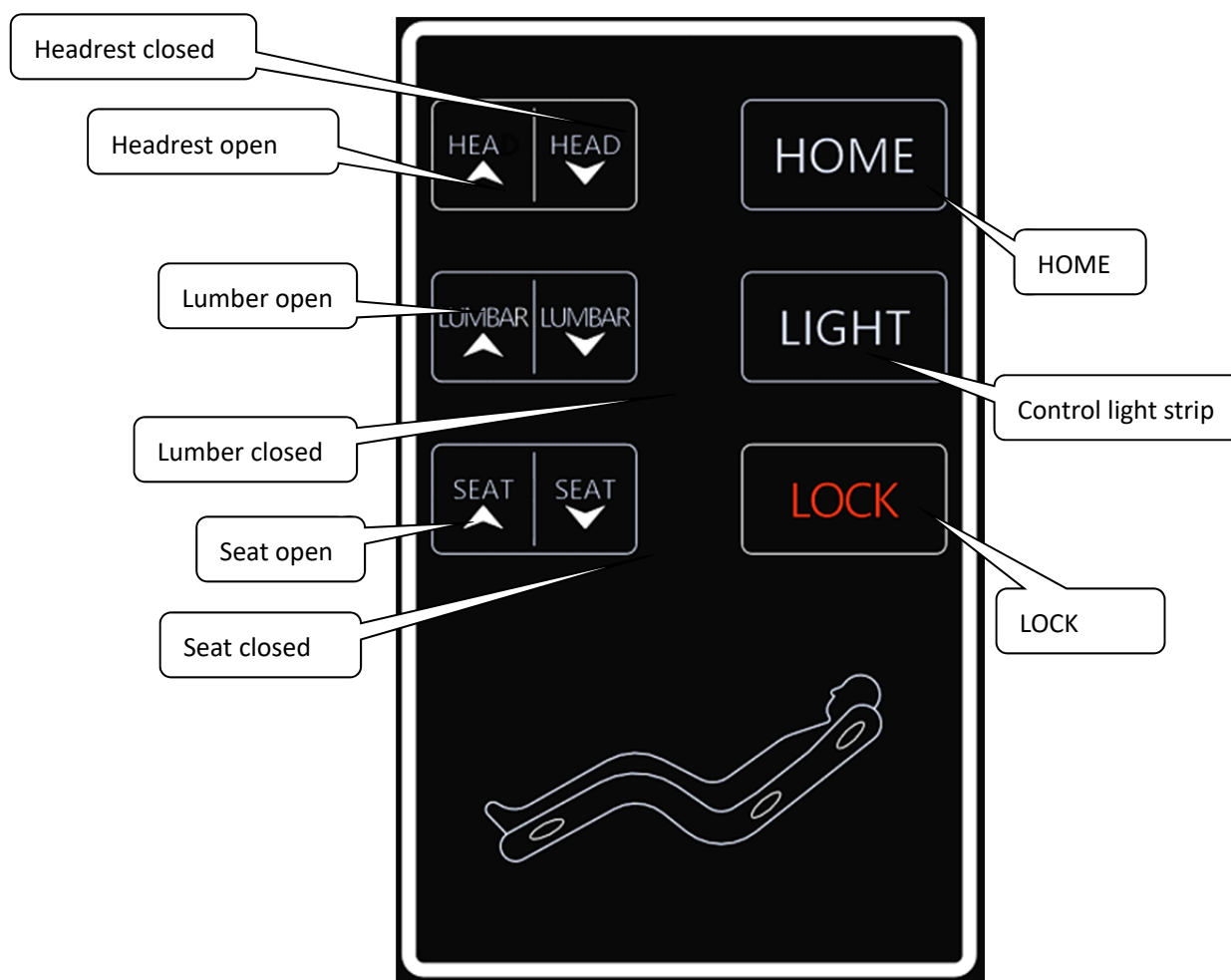
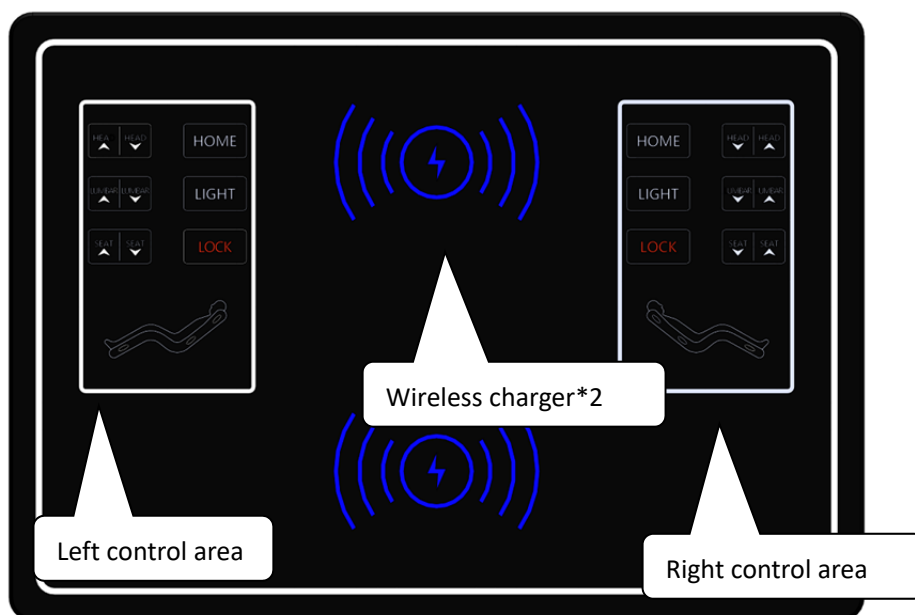


MLSK99-E1 instruction manual

The appearance of the product is matte black acrylic panel, screen printing pattern indication:



Foot push rod ML8-280, open slider close to motor, close, slide away, head/waist is ML12-010, open round tube protruding, close round tube retracting.

一、Button operation instructions:

The entire touch panel is divided into two control areas on the left and right, as well as two wireless charging areas. The following are the control instructions for each area. The right and left panels are completely symmetrical, and the corresponding button functions are the same.:

1、SOFA

HEAD ▲: Press the head motor to turn on, release to stop opening

HEAD ▼: Press the head motor to turn off, release to stop closing

LUMBAR ▲: Press the lumbar motor to turn on, release to stop opening

LUMBAR ▼: Press the lumbar motor to turn off, release to stop turning off

SEAT ▲: Press the seat motor to turn on, release to stop opening

SEAT ▼: Press the seat motor to turn off, release to stop closing

2. HOME

1) By long touching the HOME button, fully close the sofa and return it to its seated position;

3. Lock screen

1) LOCK: Press and hold the button for 2 seconds to lock the product screen; Press and hold the button for 2 seconds again to unlock the product;

2) Wake up function: When all background lights are off, simply click any button to turn on the background lights

The product function can be operated, and the background light will turn off after 10 seconds of inactivity.;

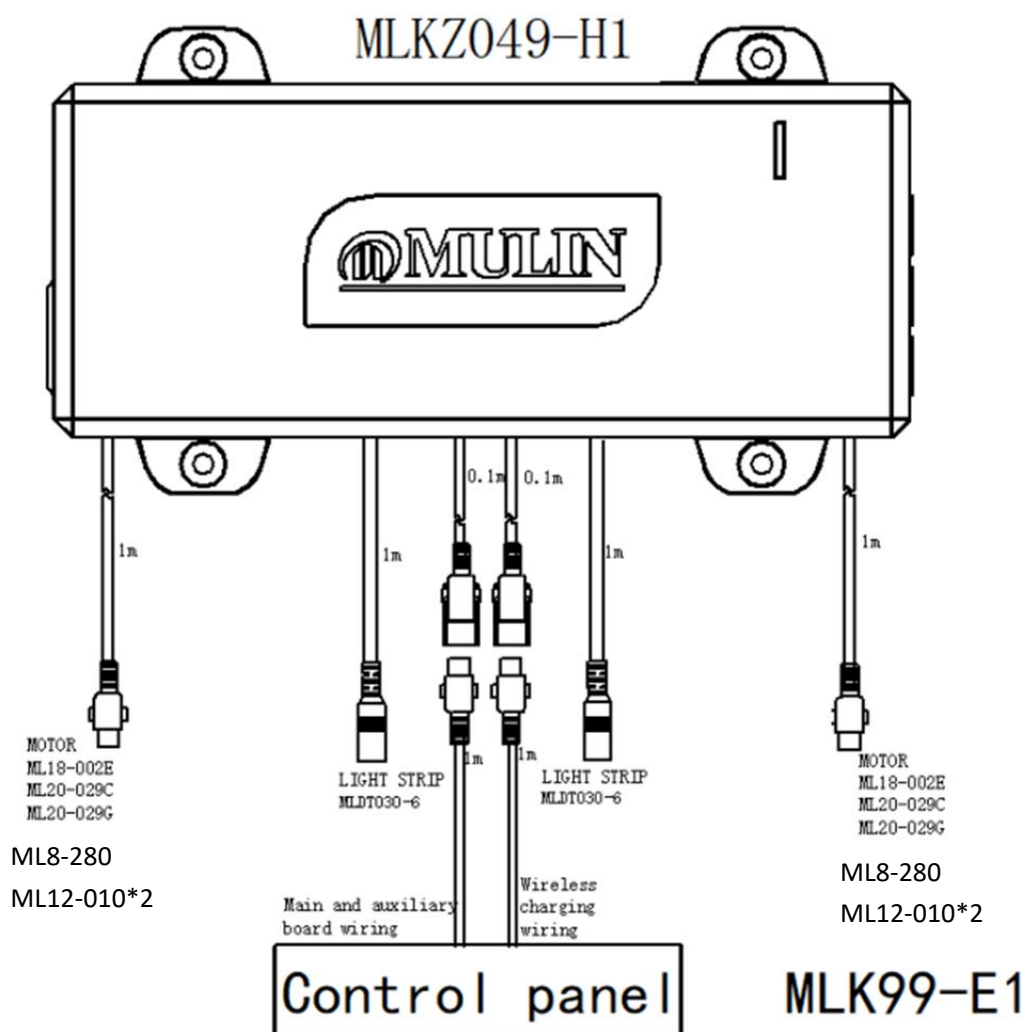
4. LIGHT

- 1) Turn on/off the light strip by touching the LIGHT button;
- 2) After the light bar lights up, the default timer is 1 hour. If there is no operation within 1 hour, it will automatically turn off;
- 3) The light strip can be controlled from left to right, and the LIGHT button on both sides can simultaneously turn on and off the left and right light strip;

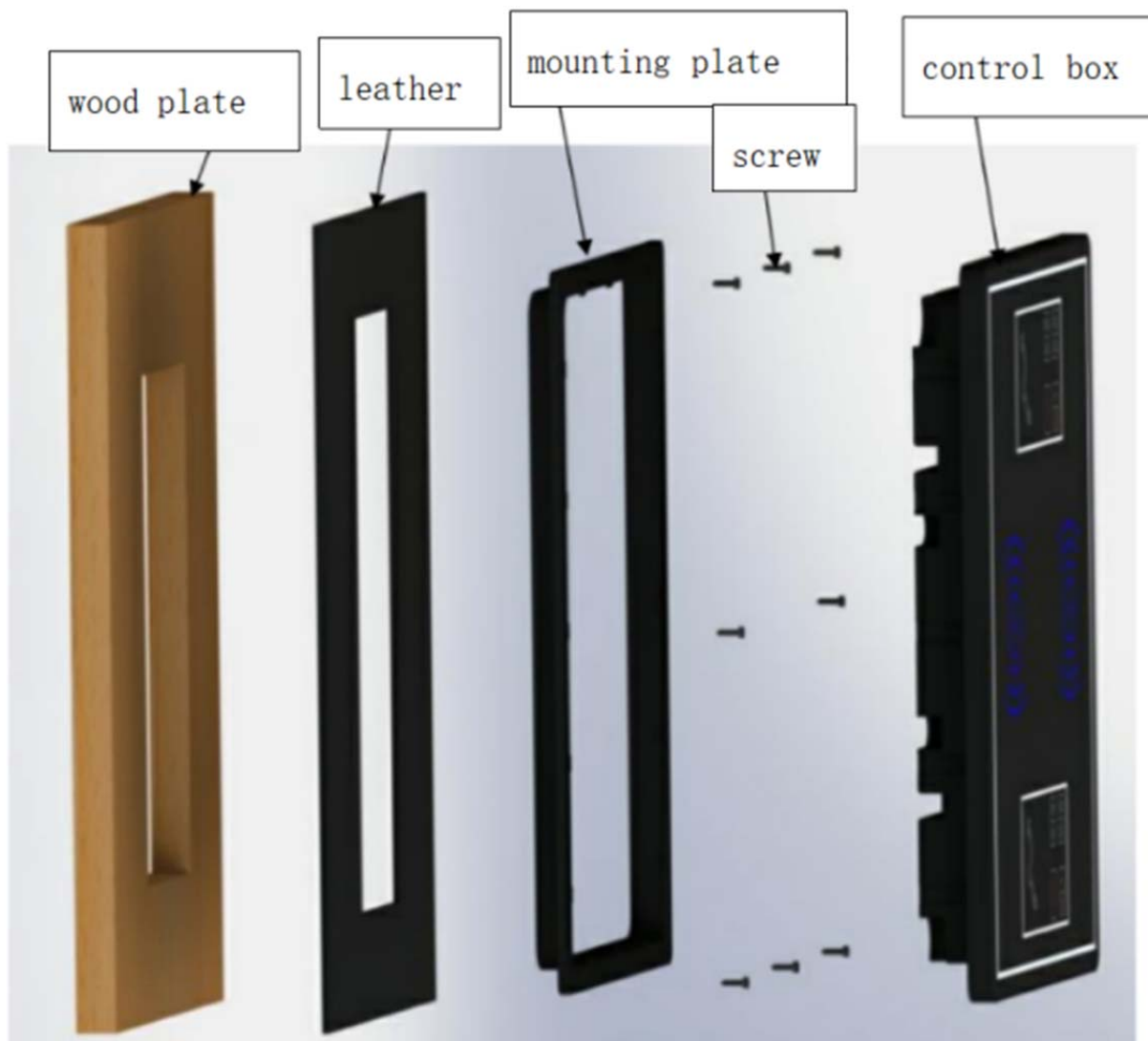
5. Wireless charger

This product comes with wireless charger function, which can achieve simultaneous charging of two wireless charger phones with a charging power of 5W;
