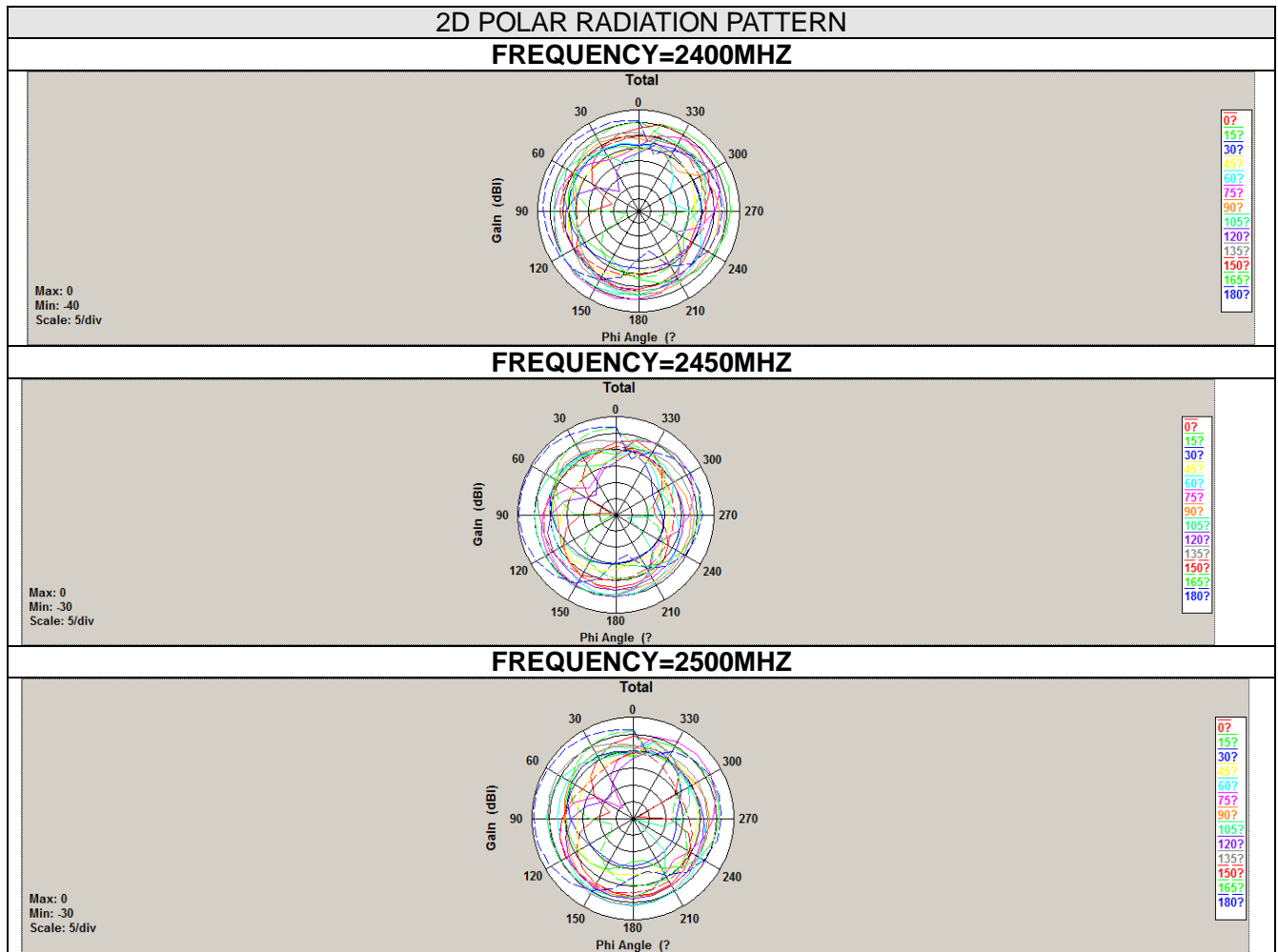

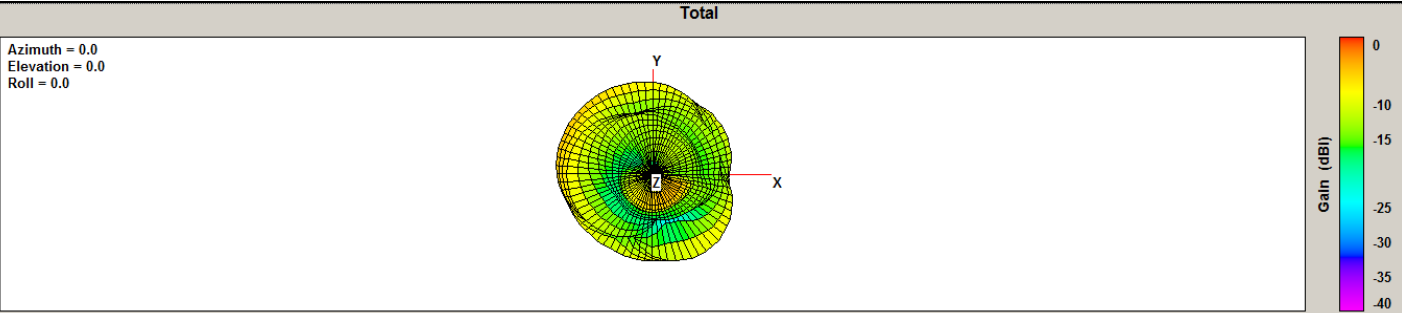

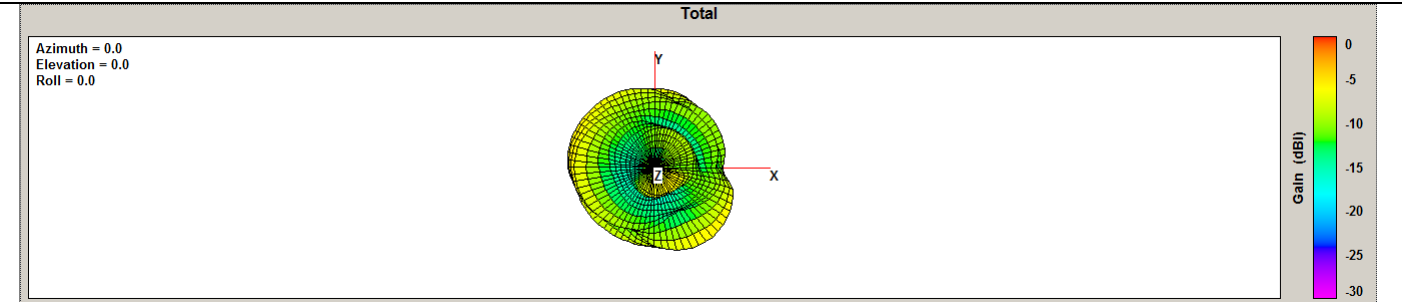

3D RADIATION PATTERN

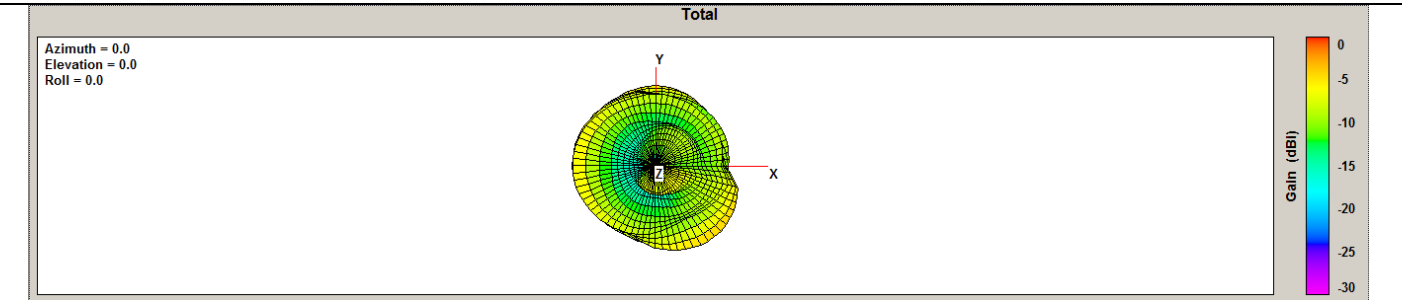
FREQUENCY=2400MHZ

FREQUENCY=2500MHZ

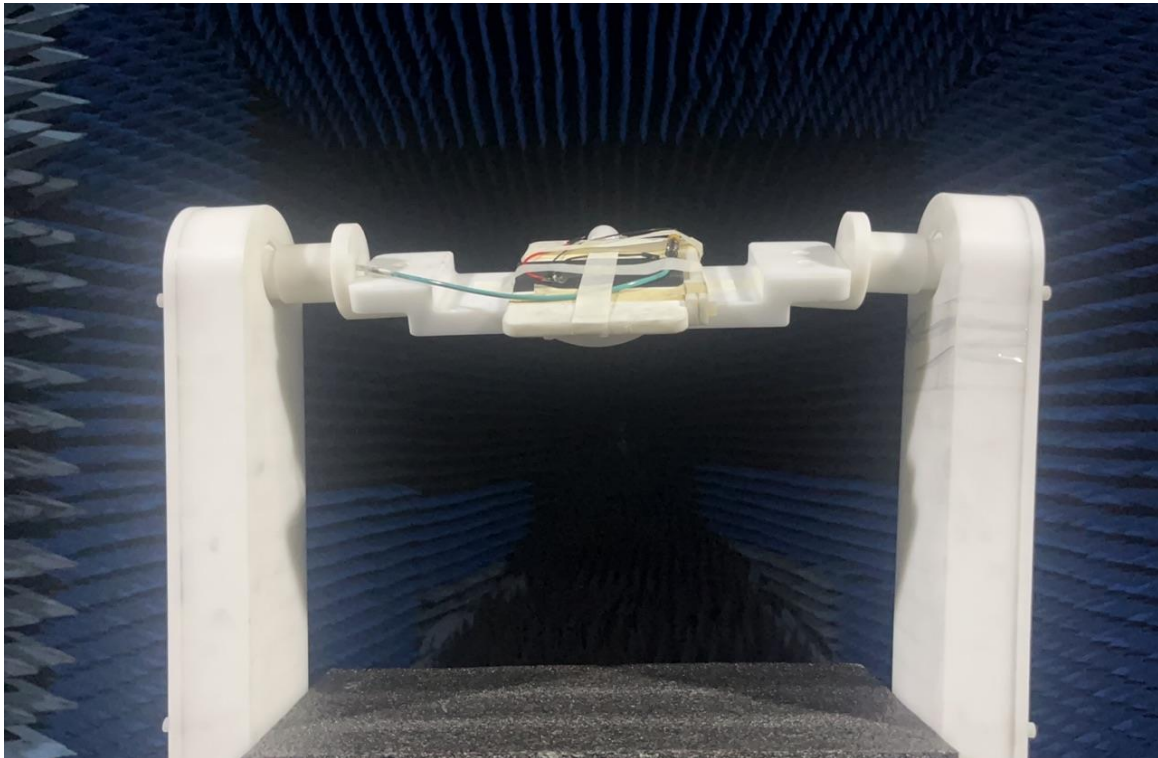

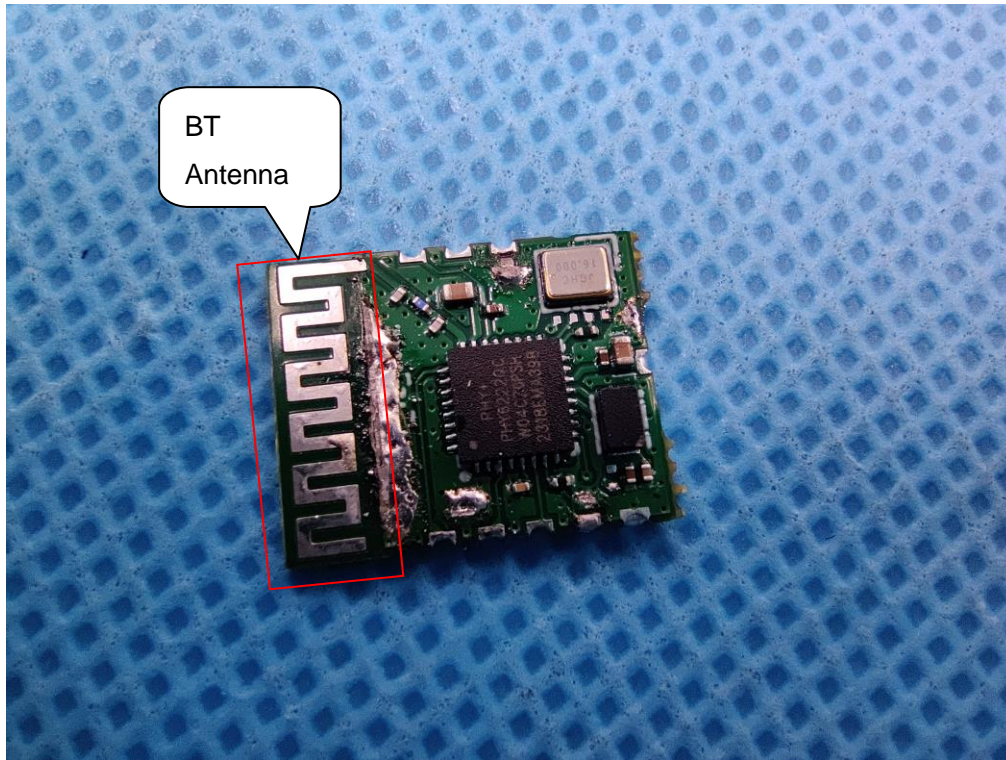
