





◎ Safety Tips:

Avoid sharing this device with others due to hygiene concerns. Only water based lubricant is recommended to use with this product. Do not use massage oils or hand cream as lubricants for this device, as you will damage its silicone soft touch surface. Stop using this device if its tip is chipped or broken or has sharp edges.

◎ Cleaning and Storage:

Please note that the remote controller is not waterproof. Always clean your device thoroughly before and after each use. Clean your device with an antibacterial toy cleaner. Alternatively, you can wash the device with warm water and soap, rinse with clean hot water and pat dry with a clean towel. Hard detergents, disinfectants, acetone or alcohol are not recommended to use to clean your device. Store your device in a clean and dry space and keep it out of children's reach.
