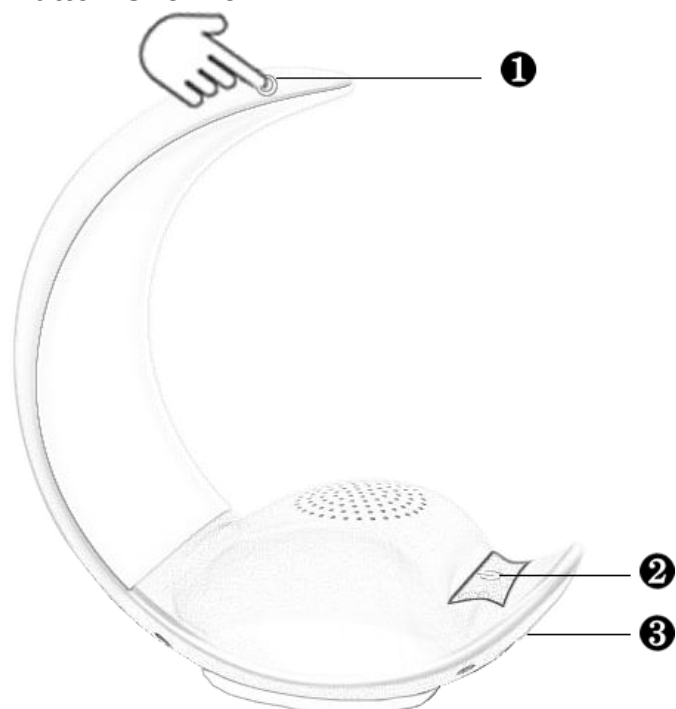

Button Overview



❶ Touch button

Softly touch it to change the LED mode including solid LED light, rhythm LED light and sleeping light or turn on/off the LED light

❷ switch/Pause & Play

Long press (3 seconds) to turn on/off the speaker

Short press to play or pause the music

Incoming calling, short press to answer or hang up the calling; long press(2 seconds) to reject the incoming call; dual click to redial the last calling.

❸ Type C charging slot

Charging

Connect the charging cable to speaker's type c charge port, insert the other end to a adapter in 5V(not include). A red light is on when charging, and will switch off when full charge is reached.

Bluetooth Connection

Use cell phone or other device search Bluetooth pairing name "Moon Speaker" to connect, and the prompt voice will remind the Bluetooth connected successfully.
