## 2. Antenna requirement

**Test Requirement:**

Refer to 47 CFR Part 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.

### 2.1. Conclusion

The antenna is a **FPC antenna** which permanently attached, and the best case gain of the antenna is **2.24dBi**. It complies with the standard requirement.


## 5. Maximum Conducted Output Power

Test Requirement:	47 CFR 15.247(b)(3)
