



## **SAFETY INSTRUCTIONS FOR USING PICOO™ PRODUCTS**

Dear Player,

We are pleased that you will be using the Picoo™ Products, i.e. the controller (the **Controller**), including the integrated rechargeable lithium ion battery (the **Battery**), the Picoo™ carrying case (the **Case**) that is included in the delivery and the USB-C hub, charging cables and adapter (the **Included Charger**) that are included in the delivery (jointly referred to as the **Products**). By means of this document we would like to inform you about the safety aspects and conformity aspects of the Products. Please read, keep and follow the instructions stated in this document. If the Products are used by young children, this information must be read and explained by an adult.

Before using the Included Charger, in addition to these safety instructions for using the Picoo™ Products please also consult the safety instructions of the Included Charger that have been included separately. In the event of any inconsistencies between Picoo's safety instructions and the safety instructions of the Included Charger that have been included separately, the safety instructions of the Included Charger that have been included separately prevail.

### Age restriction

The Products are not suitable for persons under the age of 4. Please keep the Products and packaging materials out of reach of children under the age of 4 to prevent the swallowing of small parts. The Controller's wristband may pose a suffocation hazard. The Case and the Included Charger are not toys and may only be used by persons who are 18 years or older.

### Compatibility

The Controllers are intended only to play games with that were manufactured by Picoo. The Included Charger and Case are not toys. Do not use the Products in any other way.

### Mandatory use of wristband

Please make sure that the Controller's wristband is worn around the player's wrist at all times when playing to prevent the Controller from slipping out of their hands and coming into contact with something or someone. The wristband must be attached in such a manner, using the sliding lock, to prevent it from slipping off the player's hand. The Controller must be held firmly when playing. Please ensure that the playing area is safe and that there is sufficient space, and always keep an eye on the surroundings when playing. When the player is done playing, they can simply slide the lock back to increase the size of the band. The wristband can then be removed from the wrist.

### Physical Safety

The Controller is not suitable for physically touching fellow players. The Controllers make a sound. Do not hold the Controller close to your ears. Always close off the USB-C connector with the rubber cap when playing.

### Medical Safety

Persons who have or have had a medical condition or who are pregnant must consult a physician before playing with Picoo.

'Persons with a medical condition' in any event include but are not limited to persons with: i) a heart condition, pacemaker<sup>1</sup> or other medical implant; ii) respiratory difficulties; iii) back, joint or orthopaedic problems; iv) epilepsy; and v) high blood pressure.

Before playing, please also consult a physician if they have recommended limiting physical exertion or if you have other medical problems that may be worsened by physical exertion.

Persons who are being treated for injuries to or disorders of the fingers, hands or arms are advised against using the Controller's vibration feature. If a player experiences discomfort when playing as a result of the Controller's vibrations then they must discontinue the game and consult a physician.

- Do not open, disassemble or repair the Products yourself.
- Substances in the Product may be harmful to the environment or cause injury in case of improper use or incorrect disposal.
- Do not expose the Products to high forces.
- Do not expose the Products to fire.
- Do not keep the Products in bright and direct sunlight.
- Do not use the Product in the vicinity of heat sources such as radiators, heaters, microwaves, ovens and other devices that produce heat or electric heat. Switch off the Products if they feel warm or hot.
- Discontinue using the Products as soon as they feel warm or hot.
- Do not immerse the Products in water. This may lead to fire or electric shocks.

- Do not use the Products in extremely cold or extremely hot conditions, or when the temperature may suddenly change extremely.
- Always store the Products indoors in a dry and covered place out of reach of pets.
- Some Products use wireless communication. Wireless communication is not always allowed, for example in hospitals and on airplanes. Always follow the local instructions.

### Cleaning the Products

Please use a soft and dry cloth and a mild cleaning agent (no abrasive cleaners, thinner, benzene or alcohol (except for isopropyl alcohol) to clean the Products.

### Batteries

**CAUTION: The Battery is not replaceable!**

**Never replace the Battery or Included Charger yourself. Never open the Controller's casing. Do not disassemble the Controller or Included Charger.** If you do so, the guarantee lapses and this constitutes a safety risk. Please contact Picoo for information about repair or replacement if the Controller or Included Charger does not charge anymore.

Immediately discontinue the use of the Controller if the Battery is leaking. Rinse your eyes immediately with plenty of water and consult a physician if your eyes come into contact with fluid from the Battery. Wash your hands thoroughly with water if your hands come into contact with fluid from the Battery. If fluid from the Battery comes on the outside of the Controllers or the Included Charger, carefully wipe away the fluid with a dry cloth.

### Charging Controllers general

- Please only charge the Controllers indoors using the designated Included Charger or USB Charger that (i) is compatible with the USB BC 1.2 standard; (ii) can provide a minimum of 1A of current per Picoo; and (iii) complies with local regulations relating to electrical safety.
- On account of heat generation, always place the Charger or Included Charger outside the Case during charging.
- Please remove the plug of the Charger or Included Charger from the wall socket after charging.
- The Products may be damaged during a thunderstorm, and lightning increases the risk of electric shocks. That is why you should remove the plug of the Charger or Included Charger from the wall socket and not use the Controller during a thunderstorm.
- Please check whether the Controllers and all USB ports and connectors of the Charger or Included Charger are completely dry and undamaged before charging the Controllers. Do not charge the Controllers if the Controller, USB ports and/or the cables of the Charger or Included Charger is/are wet and/or damaged.
- To charge the Controllers, connect the USB-C cables to the Included Charger. Plug the USB-C cables into the bottom of the Controllers. Connect the Included Charger to a power outlet.
- Once the Controllers are fully charged, they slowly blink green for 5 minutes. Then they automatically power off.
