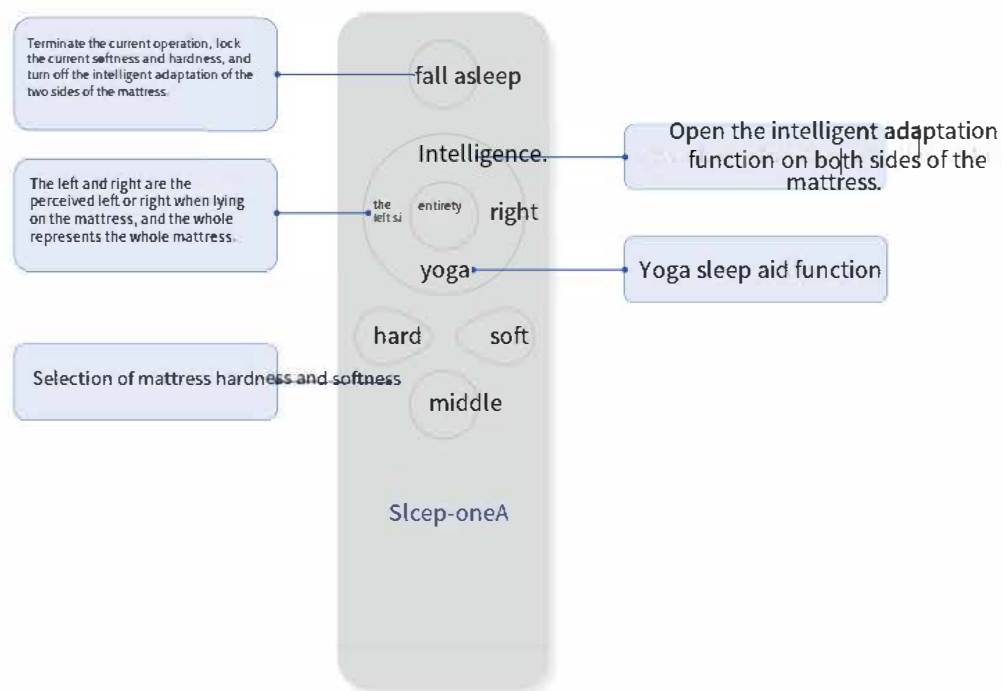

## Sleepone Ai Intelligent Mattress Remote Control Instruction Manual

## Schematic diagram of Sleepone Ai smart mattress operation



### 1. Adjustment method

Press left/whole/right to confirm the position of the mattress before adjusting the hardness or yoga to help you sleep.

Take yoga to help sleep on the left as an example: press left first, then press yoga.

Take the right hard adjustment as an example: press right first, then press hard.

### 2. Intelligent adaptive switch

If you need a completely silent sleep environment, you can press Sleep before going to sleep, thus turning off intelligent adaptation. Smart adaptation will not be turned on automatically after it is

turned off. If you want to turn it on again, please press Smart.

The sleep key and smart key are aimed at the whole mattress, and there is no distinction between left and right. There is no need to choose the position of the mattress before use.

## Frequently asked questions

FREQUENTLY ASKED QUESTIONS	Possibility analysis	Solution countermeasures
The remote control cannot be adjusted.	The mattress is not plugged in. Or the plug is loose	Please check whether the adapter is connected to the power cord, whether the power cord is connected to the mattress and whether the power plug is plugged into the triangular socket.
	Remote control pairing abnormal	Please re-pair your remote control with the smart mattress and try again.
	The remote control is dead.	Please replace the remote battery.
How to control the mattress after the remote control is lost?	In the case of stable home network environment, you can still use Mijia APP to control the mattress (if the mattress has not been equipped with a network, you need to complete the network configuration first, please refer to the product manual of smart mattress for details). If you need a new remote control, please contact customer service.	
What should I do if I want to redistribute the network after losing the remote control?	Please contact customer service to get a new remote control, then pair the new remote control with the bed cushion, and then you can re-allocate the network.
