### 3.2 Channel List

The EUT has been tested under its typical operating condition. Pre-defined engineering program for regulatory testing used to control the EUT for staying in continuous transmitting. Only the worst case data were reported.

The EUT has been associated with peripherals pursuant to ANSI C63.10-2013 and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: radiation (9 KHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower).

The details of test channels and bandwidth were for RF conductive measurement.

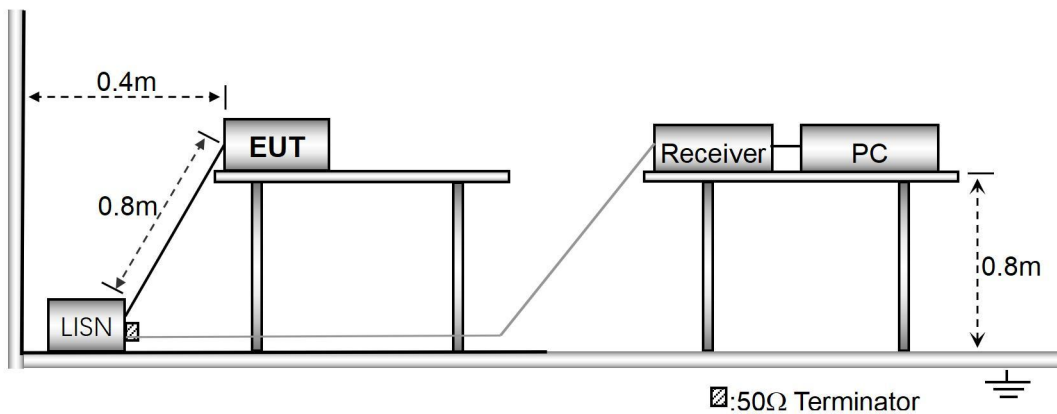

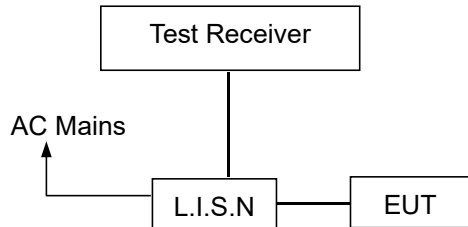

### 5.4 Measurement Procedure

1. The EUT was placed on a table, which is 0.8m above ground plane.
2. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
3. Repeat above procedures until all frequency measured was complete.

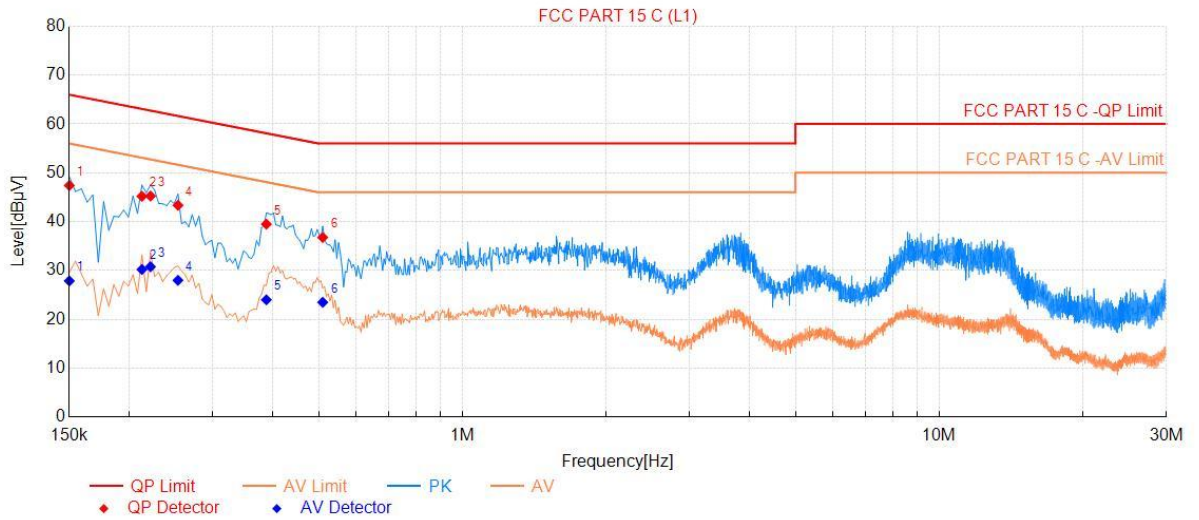

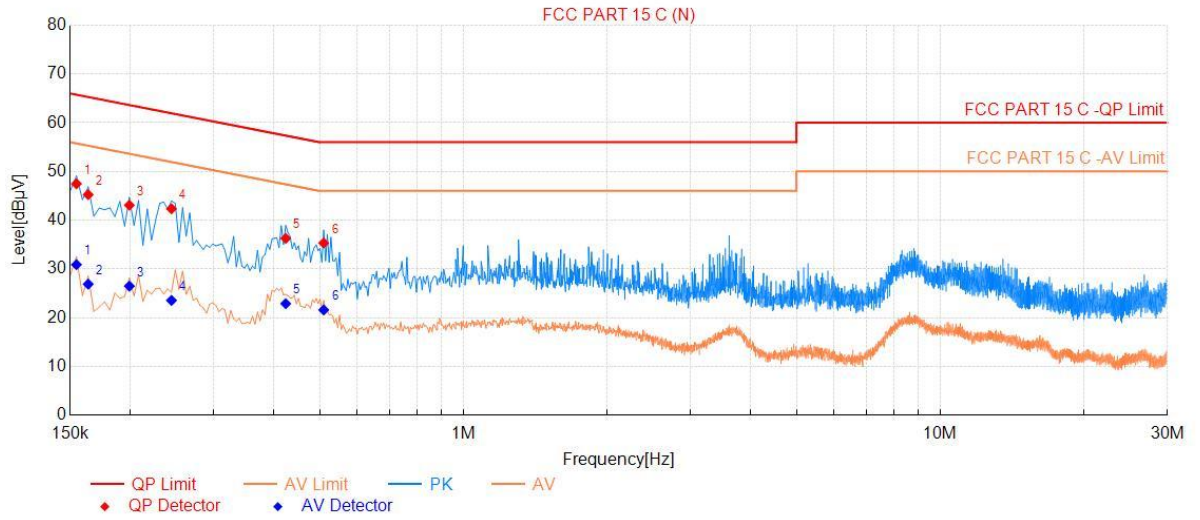
Line-AC 120V/60Hz

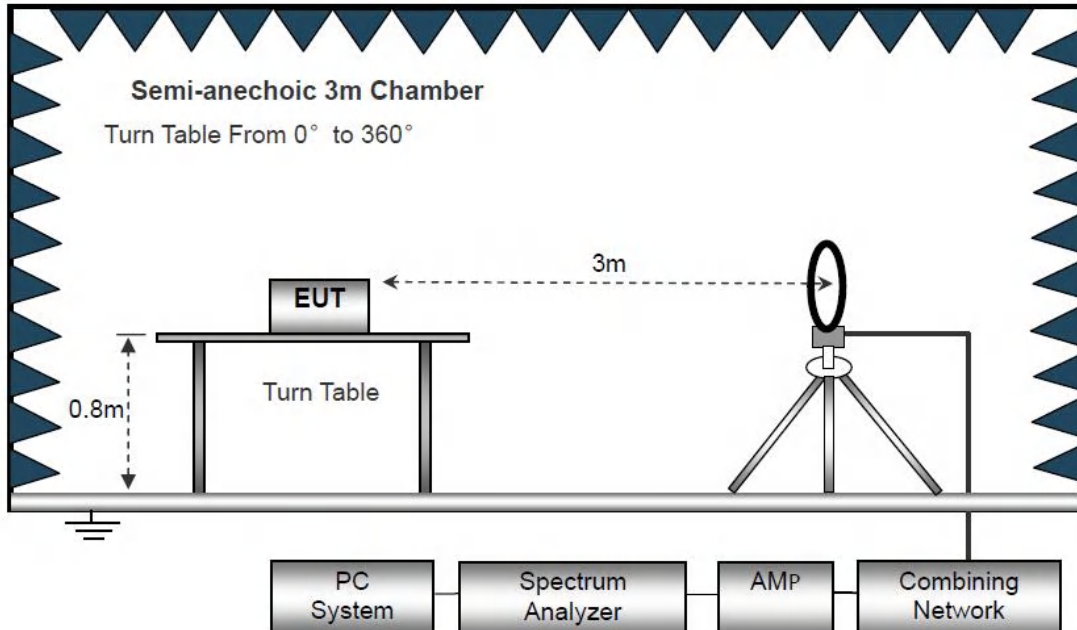

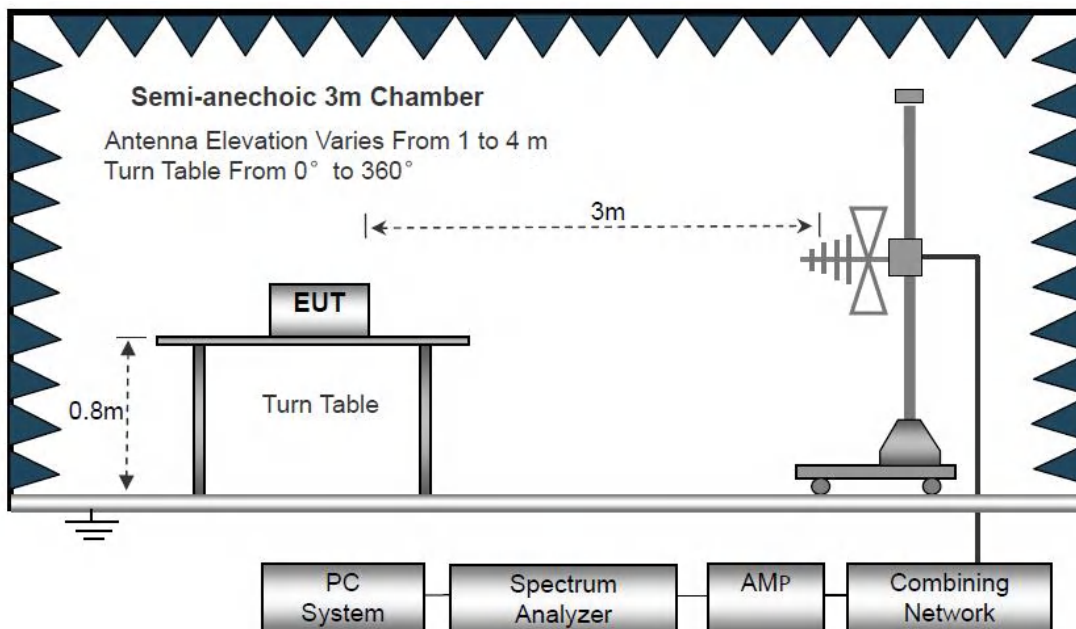

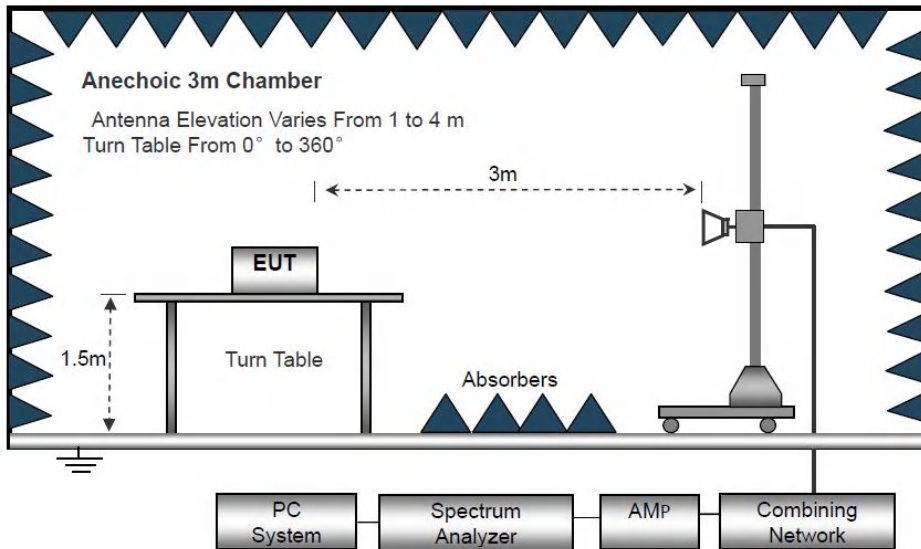
The test setup for emission measurement below 30MHz

## 6.4 Test Procedure

1. The testing follows the guidelines in Spurious Radiated Emissions of ANSI C63.10-2013.
2. Below 1000MHz, The EUT was placed on a turn table which is 0.8m above ground plane. And above 1000MHz, The EUT was placed on a styrofoam table which is 1.5m above ground plane.
3. The EUT was set 3 meters from the interference receiving antenna, which was mounted on the top of a variable height antenna tower.
4. For each suspected emission, the EUT was arranged to its worst case and then tune the Antenna tower (From 1m to 4m) and turntable (from 0 degree to 360 degree) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level to comply with the guidelines.
5. Set to the maximum power setting and enable the EUT transmit continuously.
6. Final measurement (Above 1GHz): The frequency range will be divided into different sub ranges depending of the frequency range of the used horn antenna. The EMI Receiver set to peak and average mode and a resolution bandwidth of 1MHz. The measurement will be performed in horizontal and vertical polarization of the measuring antenna and while rotating the EUT in its vertical axis in the range of 0 degree to 360 degree in order to have the antenna inside the cone of radiation.
7. Test Procedure of measurement (For Above 1GHz):
  - 1) Monitor the frequency range at horizontal polarization and move the antenna over all sides of the EUT(if necessary move the EUT to another orthogonal axis).
  - 2) Change the antenna polarization and repeat 1) with vertical polarization.
  - 3) Make a hardcopy of the spectrum.
  - 4) Measure the frequency of the detected emissions with a lower span and resolution bandwidth to increase the accuracy and note the frequency value.
  - 5) Change the analyser mode to Clear/ Write and found the cone of emission.
  - 6) Rotate and move the EUT, so that the measuring distance can be enlarged to 3m and the antenna will be still inside the cone of emission.
  - 7) Measure the level of the detected frequency with the correct resolution bandwidth, with the antenna polarization and azimuth and the peak and average detector, which causes the maximum emission.
  - 8) Repeat steps 1) to 7) for the next antenna spot if the EUT is larger than the antenna beamwidth.
8. The radiation measurements are tested under 3-axes(X,Y,Z) position(X denotes lying on the table, Y denotes side stand and Z denotes vertical stand), After pre-test, It was found that the worse radiation emission was get at the X position. So the data shown was the X position only.



For Average Measurement:

VBW=10Hz, when duty cycle is no less than 98 percent.

VBW $\geq$ 1/T, when duty cycle is less than 98 percent where T is the minimum transmission duration over which the transmitter is on and is transmitting at its maximum power control level for the tested mode of operation.

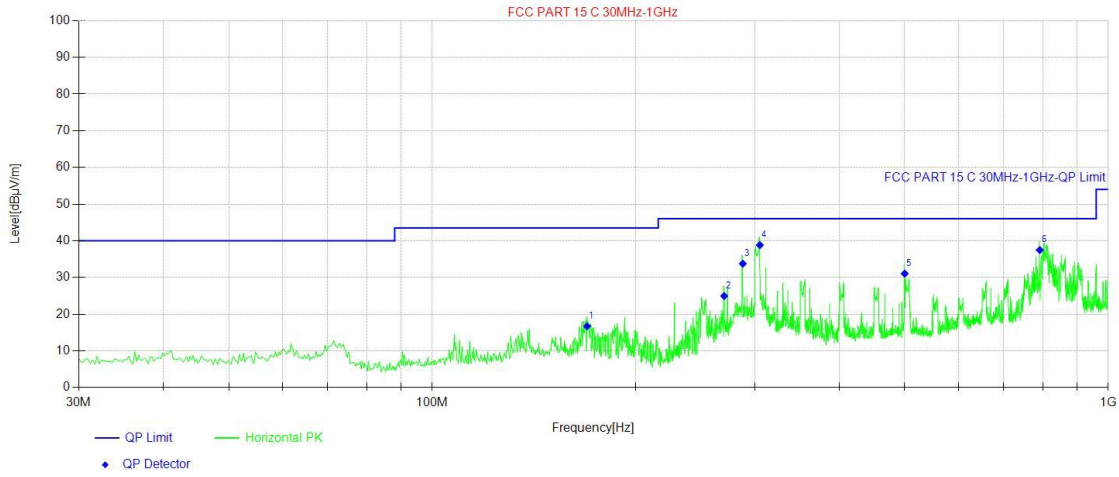

Antenna Polarization: Horizontal GFSK(CH00: 2402MHz)

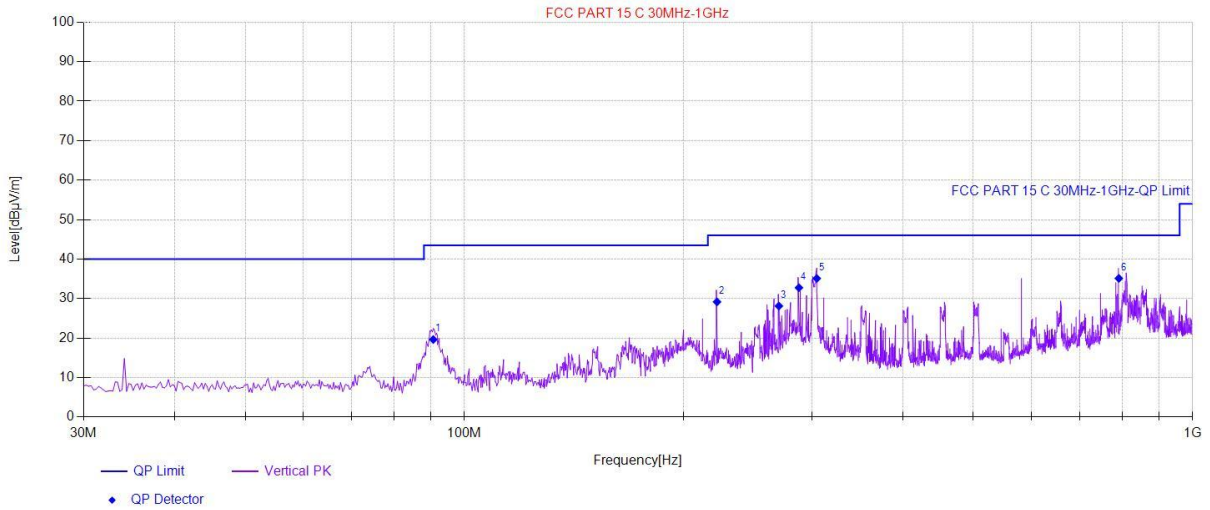

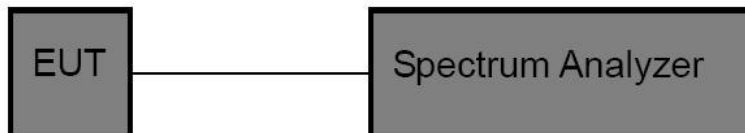
## 7 Conduct Band Edge And Spurious Emissions Measurement

- Test Requirement : Section 15.247(d) In addition, radiated emissions which fall in the restricted bands, as defined in Section 15.205(a), must also comply with the radiated emission limits specified in Section 15.209(a) (see Section 15.205(c)).
- Test Method : ANSI C63.10:2013
- Test Limit : Regulation 15.247 (d), In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

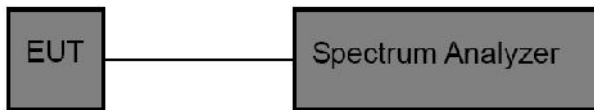
## 9 Maximum Peak Output Power

Test Requirement : FCC CFR47 Part 15 Section 15.247  
 Test Method : ANSI C63.10:2013  
 Test Limit : Regulation 15.247 (b)(3), For systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power.

### 9.1 Test Procedure

1. The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.
2. Set to the maximum power setting and enable the EUT transmit continuously.
3. Measure the conducted output power and record the results in the test report.

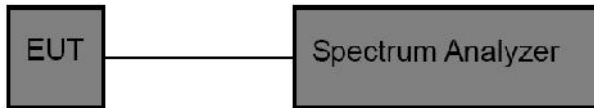
### 10 Power Spectral density

- Test Requirement : FCC CFR47 Part 15 Section 15.247
- Test Method : ANSI C63.10:2013
- Test Limit : Regulation 15.247(f) The power spectral density conducted from the intentional radiator to the antenna due to the digital modulation operation of the hybrid system, with the frequency hopping operation turned off, shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

#### 10.1 Test Procedure

1. Remove the antenna from the EUT and then connect a low RF cable from the antenna port to the spectrum.
2. Set the spectrum analyzer: RBW = 3kHz. VBW = 10kHz , Span = 1.5 times the DTS channel bandwidth(6 dB bandwidth). Sweep = auto; Detector Function = Peak. Trace = Max hold.
3. Allow the trace to stabilize. Use the marker-delta function to determine the separation between the peaks of the adjacent channels. The limit is specified in one of the subparagraphs of this Section Submit this plot.

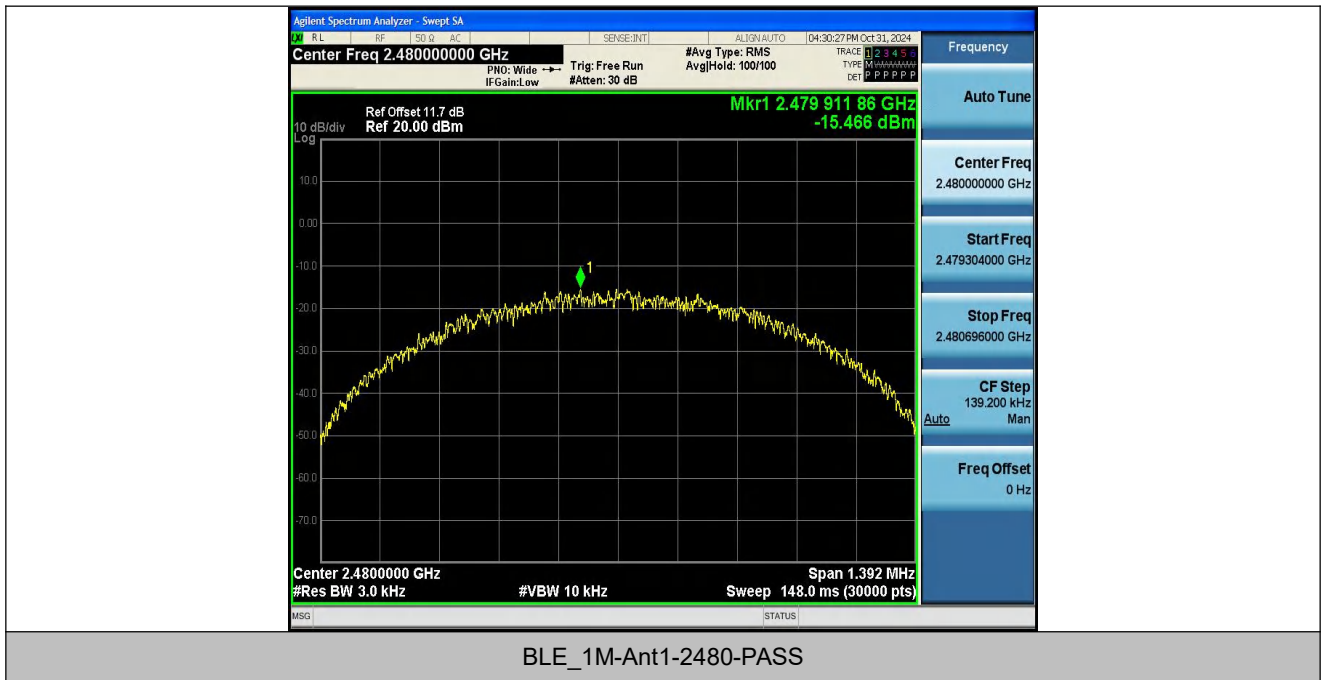

## **11 Antenna Application**

### **11.1 Antenna Requirement**

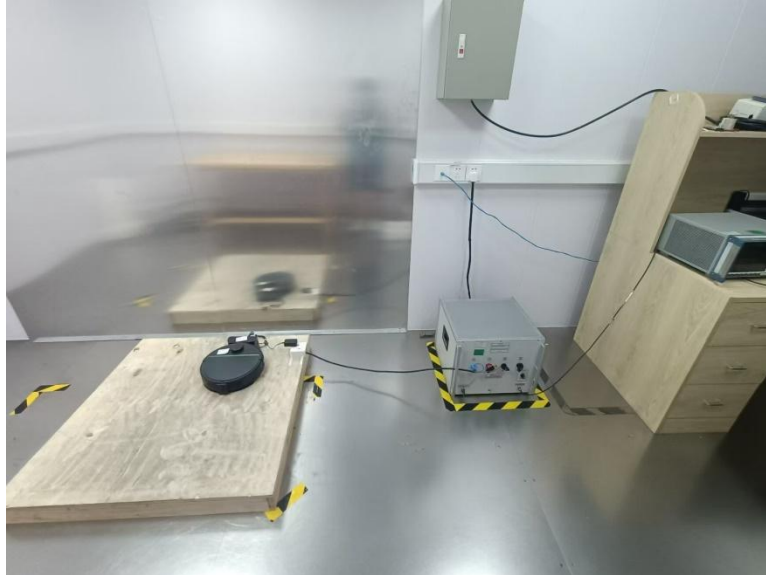
For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. And according to FCC 47 CFR Section 15.247 (b), if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

### **11.2 Result**

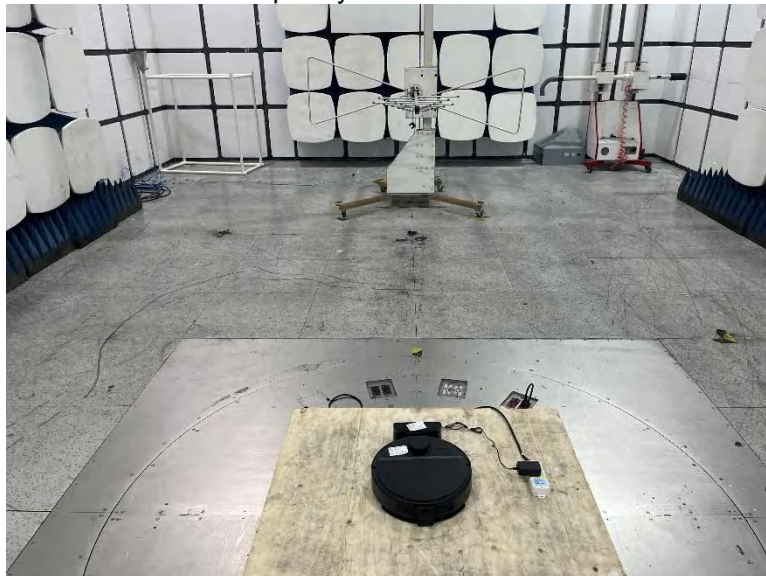
The EUT'S antenna, permanent attached antenna, is internal PCB antenna. The antenna's gain is 4.02 dBi and meets the requirement.

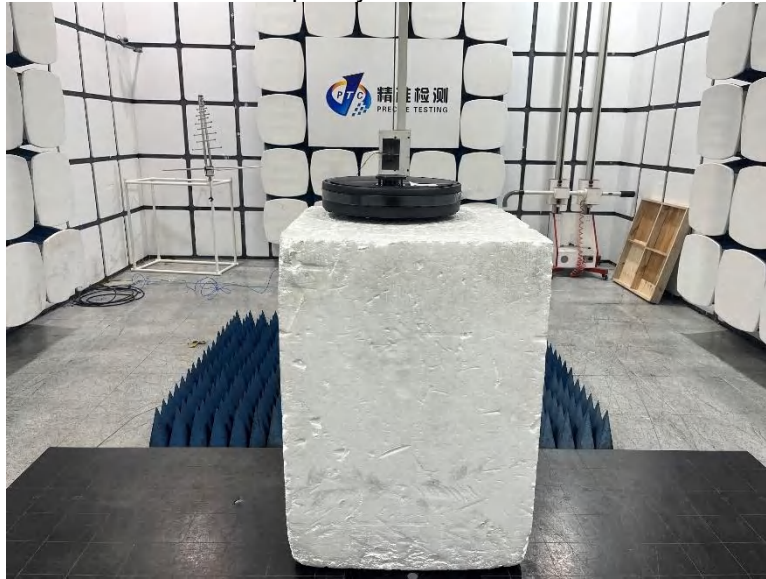


Radiated Spurious Emissions
