2. Antenna requirement

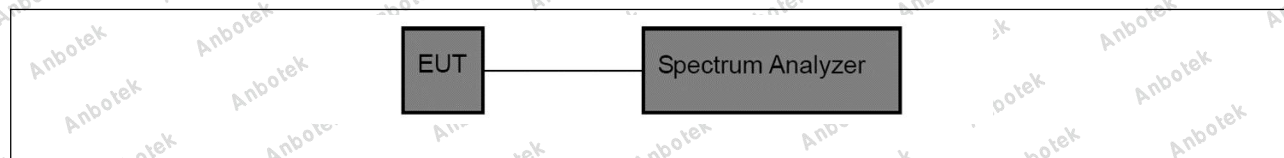
5. Maximum Conducted Output Power
