





FUNCTION DESCRIPTION

Key Functions:

Light switch/mode key:

Long press: enter sleep mode (short press to cancel sleep while in sleep mode); Short press: Switch the lighting modes in sequence (there are a total of 8 lighting modes, please refer to the lighting functions below for details).

Note: The functions of the remote control buttons are consistent with the switch/mode keys.

Main Power Switch:

The main power switch, ON is in the powered on state, and OFF is in the powered off state.

Indicator Light Function:

Flashing red light: low battery state;

Red light always on: charging in progress;

Green light always on: fully charged.

Lighting function:

The lighting functions are: running, breathing, flashing, flowing water, warning light, purple, red, and technology blue.
