### 7.2 TEST PROCEDURE

1. Set RBW = 100 kHz.
2. Set the video bandwidth (VBW)  $\geq 3 \times \text{RBW}$ .
3. Detector = Peak.
4. Trace mode = max hold.
5. Sweep = auto couple.
6. Allow the trace to stabilize.
7. Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.

## 9. CONDUCTED BAND EDGE AND SPURIOUS EMISSION

Test Requirement:	FCC Part15 C Section 15.247 (d)

### 9.1 APPLICABLE STANDARD

in any 100 kHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power, In addition, radiated emissions which fall in the restricted bands, as defined in§15.205(a), must also comply with the radiated emission limits specified in15.209(a).

### 9.2 TEST PROCEDURE

Using the following spectrum analyzer setting:

- A) Set the RBW = 100KHz.
- B) Set the VBW = 300KHz.
- C) Sweep time = auto couple.
- D) Detector function = peak.
- E) Trace mode = max hold.
- F) Allow trace to fully stabilize.

## 10. ANTENNA REQUIREMENT

Standard requirement:	FCC Part15 C Section 15.203 /247(c)
<p>15.203 requirement: An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.</p> <p>15.247(c) (1)(i) requirement: (i) Systems operating in the 2400-2483.5 MHz band that is used exclusively for fixed. Point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6dBi.</p>

The antennas are FPCB antenna, the best case gain of the antennas are 2.34dBi, reference to the appendix II for details
