





Operating instructions

POWER
ON

Press the 3-second power button to turn on the device, and it will prompt "POWER ON".
Press the power button to turn on the device while charging, and it will prompt "POWER ON".

POWER
OFF

Press the button for 5 seconds to turn off the device with the prompt "POWER OFF".

Pairing

Turn on your phone's Bluetooth, click M9 and the connection is successful.
After successful connection, you can listen to music and make phone calls.



Press the button once to answer the call.



Press the button once during a call to hang up.



Press and hold the button for 2 seconds to hang up the phone.



Press the button once to pause the music playback.



Press the button twice to pause the music playback.



Press and hold the button for 2 seconds to enter the voice assistant.
