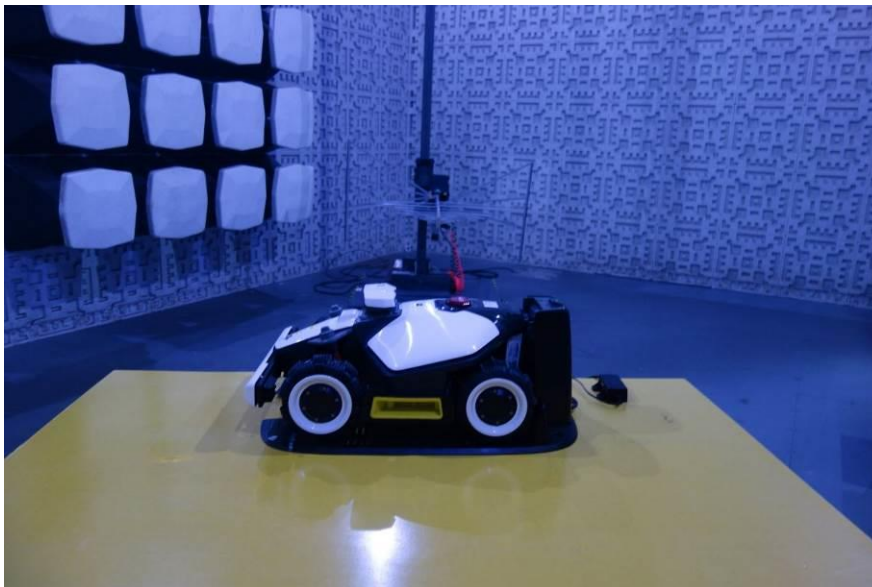

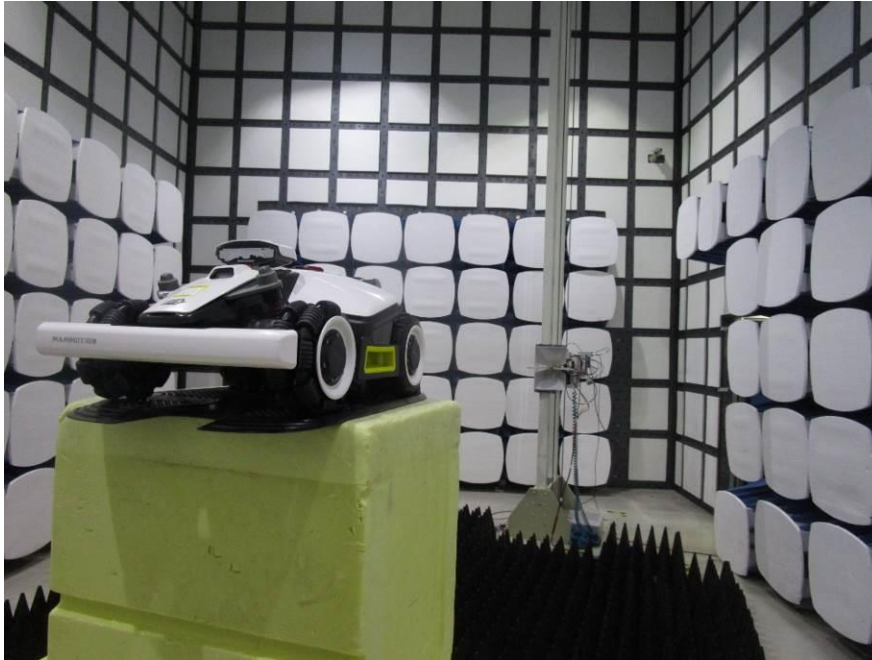
Conducted Emissions at AC Power Line (150kHz-30MHz)
