Subject: Request for Confidentiality Regarding FCC ID 2BG3YE04

Pursuant to the provisions of Sections 0.457(d) and 0.459 of the Commission's rules (47 CFR §§ 0.457, 0.459) and FCC Guidance Document KDB 726920, SetPoint Medical Corp. hereby requests confidential treatment for documents filed with the Commission in connection with the application for equipment authorization referenced above. SetPoint Medical requests that Long Term Confidentiality is applied to the following documents:

Theory of Operation

These documents reveal detailed technical and design information that is protected by SetPoint Medical as confidential and proprietary trade secrets. This information has been disclosed to those required to maintain its confidentiality, and it is not customarily disclosed to the public even after commercial release of a device. As a result, disclosure of this information by the Commission would harm SetPoint Medical by giving competitors an unfair advantage even after commercial release of the device.

In addition to the above mentioned documents, pursuant to Public Notice DA 04-1705 of the Commission's policy, in order to comply with the marketing regulations in 47 CFR §2.803 and the importation rules in 47 CFR §2.1204, while ensuring that business sensitive information remains confidential until the actual marketing of newly authorized devices, SetPoint Medical requests that Short Term Confidentiality is applied to the following documents for one hundred eighty days after the date the grant of equipment authorization is issued:

These documents reveal technical and design information that has not been publicly disclosed in marketing materials and is protected by SetPoint Medical as confidential and proprietary trade secrets. This information has been disclosed to those required to maintain its confidentiality, and it is not customarily disclosed publicly prior to the commercial release of the device. As a result, disclosure of this information by the Commission prior to commercial release would harm SetPoint Medical by giving competitors an unfair market advantage. SetPoint Medical believes the period of confidentiality is necessary to protect the information until the commercial release of a device.
