



Body - distance between sensor and EUT is 20 cm




Photograph 1. Body, Front Surface, 20cm




Photograph 5. Body, Top Edge, 20cm




Photograph 6. Body, Top Edge, 20cm




Photograph 7. Body, Right Edge, 20cm




