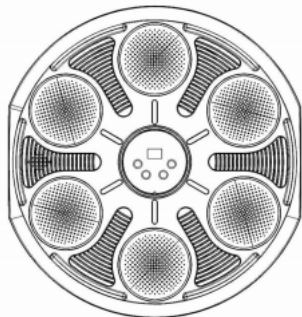


Musical Boxing Machine Operation Instructions



Product Parameters :

Please read the instruction manual carefully before use .

Product Introduction:



1. On/off Holddown for 3 seconds to turn on or off the machine. Press the button to turn on and off the blue function Bluetooth name Bluetooth The machine will enter standby mode without hitting for 1 minute.
2. Speed: The gear adjustment cycle is increased. The display window is H01-H12, indicating that the lights are changing faster and faster. The default startup is H01. Press and hold to reduce the volume.
3. Mode indicates the mode adjustment button. P01-P12 is displayed, indicating 12 modes change program selection. Press and hold to increase the volume.
4. Music Short press this button to display F00 to turn off the impact sound effect and F01 to turn on the impact sound effect Long press this button for 3 seconds to display P -to enter the music checkpoint mode.
5. Press the ON/OFF button to display 1-9 numbers corresponding to slower checkpoint speed.

Installation Instructions



1. The first installation method is to tear off the backing adhesive attached to the back of the machine and directly stick it to the position to be installed. The backing adhesive is divided into several sections, and according to the position that needs to be pasted, the backing adhesive template is selected, which is similar to a ceramic tile surface. The outermost circle is enough (as shown in Figure 3)
2. The second installation method is to tear off the adhesive sticker on the side of the fitting and stick it directly on the back of the machine, paying attention to the parallel direction of the machine when pasting (As shown in Figure 2)
3. Glue the Velcro needle surface and the matte surface together, find the corresponding position on the wall, determine the position, tear off the sticker behind the matte surface, and stick it to the wall (as shown in Figure 3)

Product Introduction:

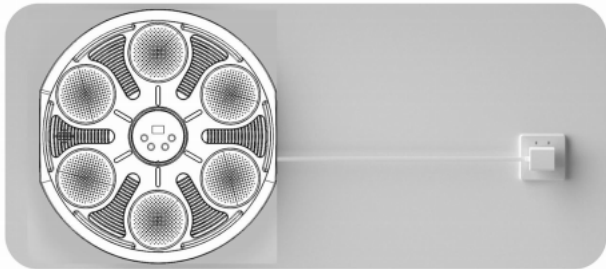
1. **Speed Adjustment:** The device is equipped with 12 speed levels, ranging from H01 to H12, each associated with a distinct frequency of target blinking. The speed progressively increases with the level number, getting faster from H01 to H12.
2. **Mode Selection:** There are 12 preset modes available, identified as P01 to P12. Each mode offers a different pattern regarding the number and position of the blinking targets.
3. **Music Toggle:** To switch between the device's internal music and music streamed via Bluetooth, simply press the "On/off" button while in any mode.
4. **Count Display:** The device can display the count of strikes, with the ability to show numbers ranging from 000 to 999.
5. **Operational Step Optimization:** For a streamlined experience when adjusting the volume or changing modes, users have the option to long-press the "On/off" button. This action will lock the device into performing a single function until the button is released or the operation is completed.

Charging Instructions:

Use power supply equipment (self-provided): Input 100-240V output bC5V--1A(2A) charging through the supplied slave wire link The location close to the wall target. The socket should not be more than 1.5 meters away from the machine interface.
