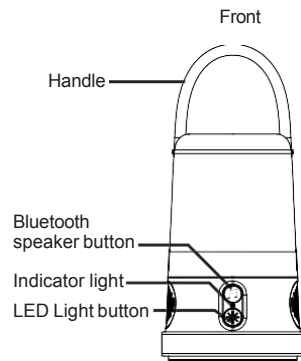

### LED Light button

1. Long press the light control button to turn on/off the light. The default light level is level 1 when the light is turned on.
2. Short press the light control button to cycle through the following light effects
  - ① Level 1 3000K light source (dark level)
  - ② Level 2 3000K light source (mid-level)
  - ③ Level 3 3000K light source (bright level)
  - ④ Level 4 - RGB amber level: When Bluetooth is not turned on, not connected, or Bluetooth is not playing, it will show a breathing light effect. When Bluetooth music is playing, it will show a rhythmic effect. When the music is paused, it will be in a low-light state.
  - ⑤ Level 5 - Multi-color RGB rhythmic level: When Bluetooth is not turned on, not connected, or Bluetooth is not playing, RGB multi-color cyclic gradient changes. When Bluetooth music is playing, RGB and music will automatically generate rhythm.
3. When the battery voltage is lower than 3.2V, the light will automatically turn off and wait for charging. Please turn off the light when charging.



**Notice: long press to turn on/off, short press to switch modes;**  
**When the battery voltage is below 3V, light will turn off automatically and wait for charging; plz turn off light when charging;**

Do not use unmatched adaptor

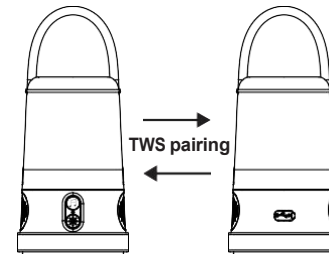
The red indicator flickers say power charging, green light going on say full with power.

- A. Long press speaker button to turn on Bluetooth;
- B. Short press to pause or play music;
- C. When playing music, blue indicator shine slowly; when pausing music, blue indicator steady on; when Bluetooth disconnected, blue indicator shine quickly;
- D. When Bluetooth disconnected for 5 mins, it will automatically turn off;
- E. When low voltage, there is a sound prompt and Bluetooth will automatically turn off.

Two audio devices enter the pairing state after powering on. Double-click the power button of any device to enter the "TWS search slave device and automatically pairing state". After TWS pairing is successful, the indicator light of one device flashes and the indicator light of the other device stays on. After the mobile phone is connected to the TWS device, one device is the left channel and the other device is the right channel, and the light control action is synchronized.

When one device is already connected to Bluetooth, if you need to open another device for TWS pairing, you can first double-click the power button of the device that is already connected to the mobile phone, disconnect the mobile phone Bluetooth connection, and then perform TWS pairing.
