

## 手机夹安装说明 Mobile Clip Installation Instructions



1.向外拉然后向上推  
1.Pull outward the buckle and push it upward

2.上下拉伸夹持手机  
2.Pull upward the end of the bracket as your phone size, and fix the phone in it



3.收合  
3. Retract the retaining ring and gently press it back

4.相机安装  
4. Directly mount the camera by aligning the 1/4 screw hole

## 无线连接说明 Wireless Connection Instructions

- 1.长按2S开机,长按3S关机。
- 2.打开手机蓝牙进入搜索状态。
- 3.在设备列表中,选中"Selfie",提示"Selfie"配对,点击配对,提示已链接表示配对成功;此时,绿色指示灯常亮。
- 4.未连接状态时上灯快闪10S,慢闪180S。若期间没有手机与其配对连接,则180s后自动关机。
- 5.连接上后,灯停止闪烁。每按一次按键,手机拍照一次。若超过10min没有按键,则自动关机。

1. Long press 2S to switch on, long press 3S to switch off.
2. Turn on your mobile phone's Bluetooth to enter the search state.
3. In the device list, select "Selfie", prompt "Selfie" pairing, click on the pairing, mentioning click "Selfie" to pair with the device, and then click "Pairing", and then it will show that the pairing is successful; at this time, the green indicator light is always on.
4. When it is not connected, the upper light flashes fast for 10S and slow for 180S, if there is no mobile phone connected to it during the period, it will turn off automatically after 180S. If there is no mobile phone connected with it during the period, it will switch off automatically after 180s.
5. When connected, the light stops blinking. Every time you press the button, the phone takes a picture. If more than 10min without pressing the key, the phone will switch off automatically.
