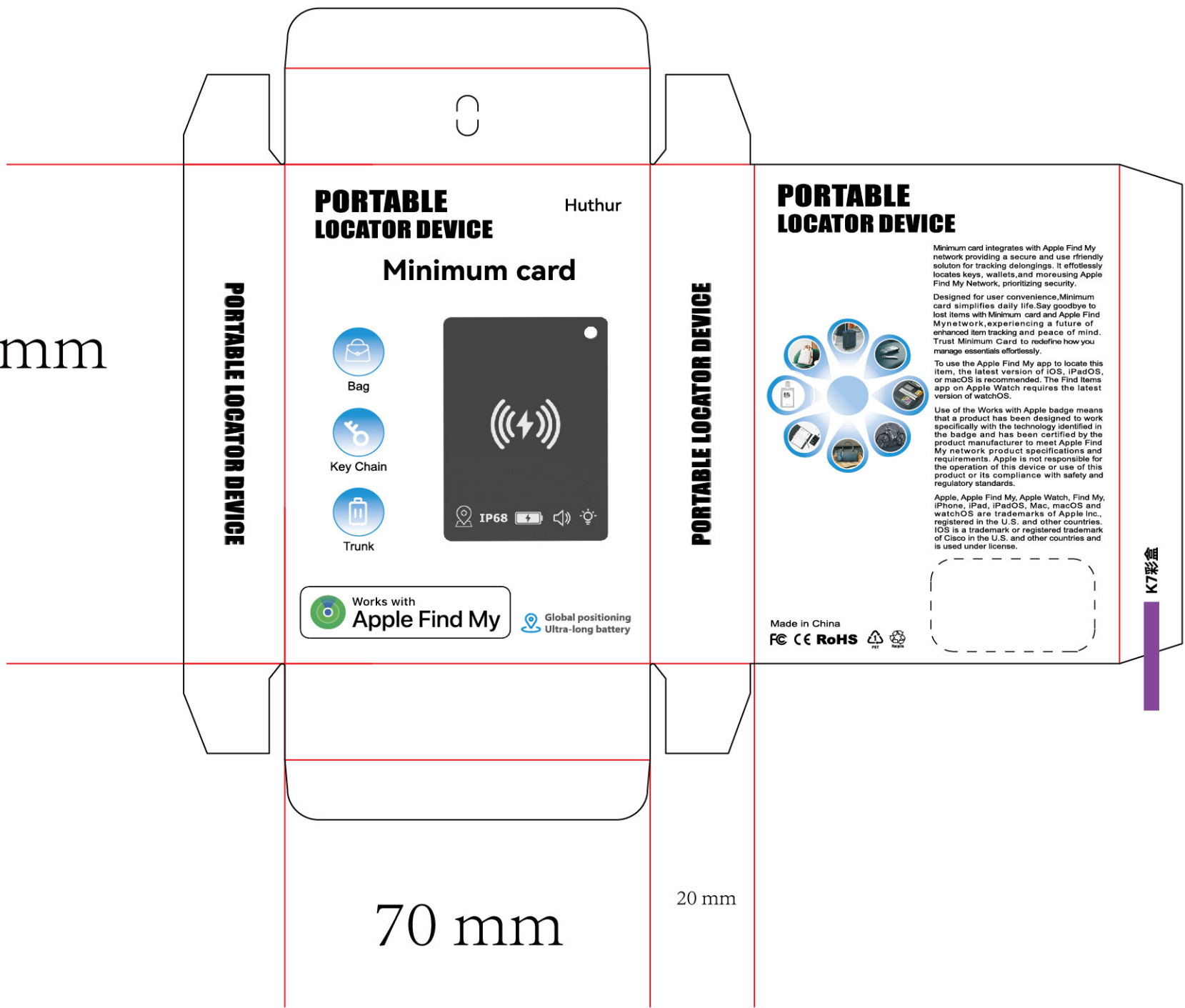
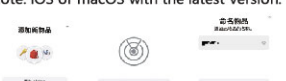

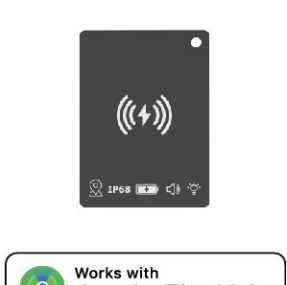

As shown in Figure 1. 1.6 Once your Minimum card is located, tap "Connect". As shown in Figure 2 and tap "Continue". As shown in Figure 3. 1.7 Enter a name and choose an emoji for your Minimum card. 1.8 Find My will ask for confirmation to add your Minimum card to your Apple ID. Tap "Agree". 1.9 Tap "Finish" and your Minimum card will be set up and ready to be used. Battery Minimum card contains a rechargeable lithium battery. Charging Operation: 2.1 Locate the wireless charging logo on the back of the card. 2.2 Align it and place it on a wireless charger. There will be a beep and the red light will turn on when charging starts. 2.3 When the battery is fully charged, the FINDER indicator will turn green and there will be three consecutive beeps.	Additional Tips 3.1 Press and hold the button until you hear one beep, followed by two consecutive beeps, and then three consecutive beeps. Keep pressing for 5 seconds. When you hear a long beep, release the button and the device will be restored to factory settings. 3.2 To delete FINDER from your Apple device, open the "Find" application, select "Items", click on the device to be removed, and then scroll down and click "Remove This Device". 3.3 If FINDER fails to connect to the Find My application, perform a factory reset as described in 3.3 and then restart the pairing process.
