


## Multi-Function Wireless Charger

### User Manual

To ensure the correct use of the product, please read this user manual carefully.

## Aroma Diffuser Operation Guide

### • Switch Button:


First time short press the switch button, turn on the continuous spray. Second time turn on the intermittent spray. Third time turn off the spray.

### • Light Button:

First time short press the light button, turn on gradient lights. Second short press switches to a fixed light color, with each press switching the light color until the light is turned off.

**• Protection Function:** Built in water shortage protection chipset, automatically stop working after detecting the water tank without water.

## Product Operations



1. Open the upper cover



2. Add appropriate amount of water to the water tank




3. Insert the power



4. Touch the switch button to turn on the device

## Clock Operation Guide



### 12 Hour Clock/24 Hour Clock Time Setting Button

Press and hold the icon once for 3 seconds to switch between 12-hour and 24-hour time. When the time is in 12-hour format, the AM/PM icon is displayed on the left side of the screen. Press and hold the icon again for 3 seconds, AM/PM will disappear and the time will switch to 24-hour format.

### Alarm Time Setting Button

Press the icon for 3 seconds, the clock screen will flash quickly (currently is hour setting), click the icon continuously to set hour, after confirm the hour, soon press and hold the icon for 3 seconds, the minute screen will flash quickly (currently is minute setting), click the icon continuously to set the minute time, after confirm the minute, release the button and wait for 5 seconds after the beep sound, the alarm icon light will light up, and the alarm clock setting is completed.

Cancel the alarm is to press the icon for 3 seconds, the light of the alarm icon will turn off and with beep. Click any icon to cancel the ring for the day.

(If there is no need to set the minute time, stop touch the button after confirm the hour time)

### Local Time Setting Button

Press the icon for 3 seconds, the clock screen will flash quickly (currently is hour setting), click the icon continuously to set hour, after confirm the hour, soon press and hold the icon for 3 seconds, the minute screen will flash quickly (currently is minute setting), click the icon continuously to set the minute time, after confirm the minute release the button to complete the local time setting.

\* Alarm clock notice: Adjust the alarm time according to the PM/AM icon when the time is 12-hour format.

## Product Maintenance

1. When the product is not in use, turn off the product switch and disconnect the power supply.
2. Correctly pour the right amount of water into the water tank.
3. Please use soft cotton to wipe the water on the water tank and cover.
4. Please wipe the atomizer gently with cotton.
5. It is recommended to clean the product regularly.

If you feel that there may be something wrong with this product, please confirm the following points before asking user for repair:

As soon as you turn on the switch, Less than a second. The incense machine will immediately. Automatic shutdown.	<ul style="list-style-type: none"><li>● Please make sure there is water in the tank. Or is there enough water?</li><li>● Please add water to the container.</li><li>● Is the AC adapter properly connected to the product?</li><li>● Please make sure that the product is fully connected to the adapter. Please unplug the charging wire and plug it into the product again, and plug it into the power again.</li></ul>

No spray or. Spray anomaly	<ul style="list-style-type: none"><li>● Is there too little water in the container? Too much?</li><li>● If there is not much water, please add water, and if the water exceeds the water mark, please pour out some of the water.</li><li>● Is the ultrasonic atomization tablet filled?</li><li>● Please clean the atomization port in the container (wipe with soft brush)</li></ul>

Aromatherapy machine leakage	<ul style="list-style-type: none"><li>● Is the suction port at the bottom covered with dust?</li><li>● If the air intake at the bottom is covered with dust, the exhaust air volume will be greatly reduced, thus as a result, there is not enough wind to spray the fog.</li></ul>

Use requirements.	<ul style="list-style-type: none"><li>● Is the upper cover covered (accident)?</li><li>● -- reinstate the upper cover.</li><li>● Is the water splashed into the air outlet when the product is tilted or poured?</li></ul>

Please pour all the water out of the machine, then dry it and try again.

1. This product is suitable using clear water or pure water. Do not use corrosive liquids.

2. If the operation is not correct, the water may leak into the machine.

If in that case, please unplug the power immediately, pour out the water, clean the device and leave it in a ventilated place for about 3 days, let it dry naturally before use it. If there is any other abnormal situation, please contact the local dealer or contact us directly.
