

## barber case with bluetooth



### User Guide For Adjustable Stand

1. Open case to get four adjustable stands and stretch them.
2. Rotate the stand clockwise to place and make sure it is tightly attached to the bottom of the case without any shaking. Loosen the screw rings at one end of the stand by unscrewing it counter-clockwise.
3. Press the two height adjusted buttons located at upper part of the stand and stretch out the lower part of it simultaneously so as to adjust the stand to the right height, tighten the screw rings at the middle of the stand by screw down them clockwise.
4. Repeat steps 2-3 so as to make sure four support stands are of exactly the same height.
5. Lift up the case and make sure four support stands on the door evenly and steadily .

### Instructions For Locks And Bluetooth

6. Code to connect with the "MANE TAME" bluetooth: -0000,1234,2288 or 000000
7. Slide the resetable button from "OFF" to "SET"
8. Dial your desired code numbers(e.g.,888)
9. Return the resetable button to "OFF" position. Your lock is now set with new code.

## **User Guidance For Light Bulbs And Plug Socket**

10.The product can be used in countries with voltage rated at 110-250V,maximum wattage is 500W.
