## 2. Antenna requirement

The antenna is a PCB antenna which permanently attached, and the best case gain of the antenna is 1.63dBi . It complies with the standard requirement.



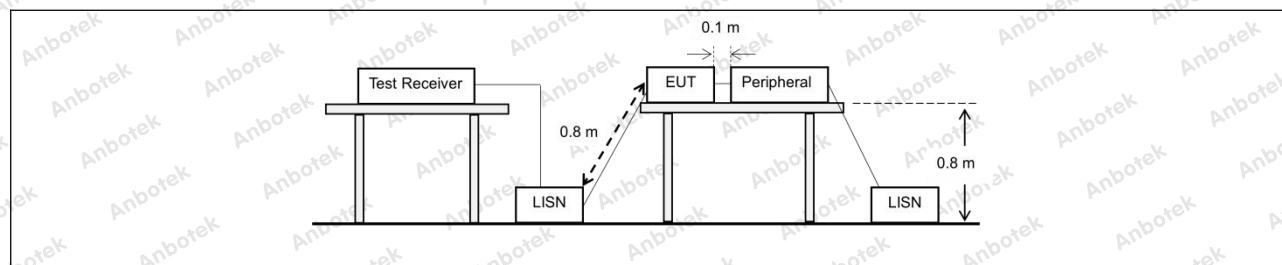

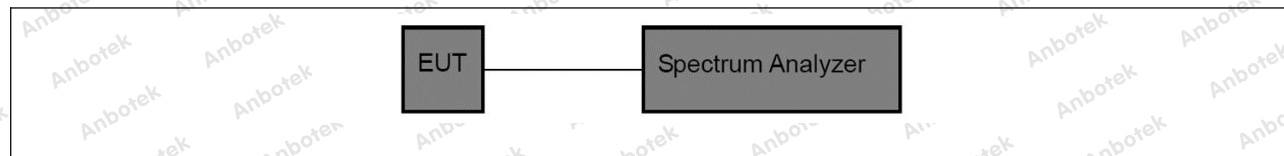
## 5. Maximum Conducted Output Power

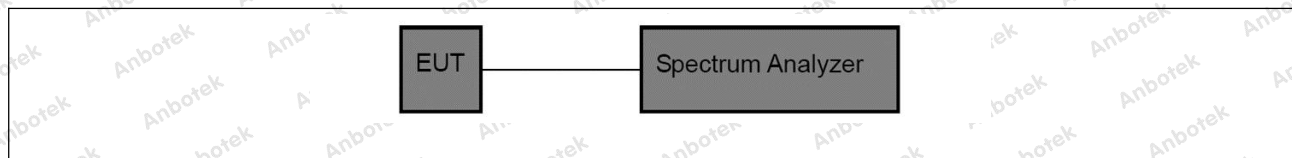
## 6. Power Spectral Density

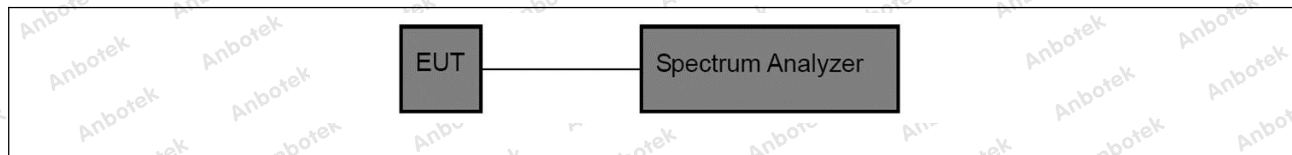
## 7. Emissions in non-restricted frequency bands

Test Requirement:	47 CFR 15.247(d), 15.209, 15.205
