

Product Feature

Using the computer chip control technology to carry on the humanity simulation control, this product is a compound high-tech eye massager. The product adopts advanced high-tech infrared heating body which has the characteristics of uniform heating, low power consumption, high far-infrared density and light weight. Infrared ray can activate the irradiated cells, making the molecules produce resonance, enhance the intermolecular force, enhance the regeneration ability of tissues, improve immunity, increase oxygen and dredge collaterals and achieve the health effect.

Acupoint Function

This product successfully applies the new concept of air pressure to eye health care, making the product more humanized. Under the control of micro-computer, the air pressure can knead the eyes in an all-round way, relieve the pressure on the eyes, fully relieve the eye fatigue, restore the contraction ability of the ciliary muscle, regulate the physiological elasticity of the ciliary muscle and relieve the elongation or atrophy of the eye axis.

Product Operation

Preparation

- 1. Turn on the machine to check whether the power of the massager is sufficient
- 2. If the power is insufficient, please use DC5V stable power supply configured by our company to charge until the power is sufficient



Charge

- 1. Find the charging port on the left side of the massager body
 2. Insert the output plug of the USB charging line into the charging socket of the product, and then connect the USB end to the charging adaptor of the home mobile
- phone.
 3. During the charging process, the red charging indicator is always on, and the red indicator is off after the charging is completed (the blue indicator is on after charging is completed for voice model).
 4. During the charging process, then machine can not work (self-protection function,
- automatic shut off for the machine during charing).
- 5. Charge for 3 hours.

Operation Method

Press the switch for 2 seconds to turn on the machine. The default mode is automatic.

When press key shortly, the key will enter the next mode. The massage mode will be cycled in turn. Press the button for 2 seconds to switch off the machine.

Mode cycle with one button control:

The default working time of the machine is 15 minutes after it swicthes on. If you want to extend the using time, you need to switch on the machine again(it is recommended that the using time should not exceed 15 minutes for each time)

Press this key for a long time to control the volume and sound to increase. Press this key for a short time to switch to the next music.
