## Preparation and charging before use

### Pre-use Preparation

Aim the head massager at your forehead, put on the machine, adjust the elastic band to the most comfortable size, and adjust the machine up and down to the most comfortable position.

Please remove glasses, contact lenses, hair clips, hair accessories, etc. before wearing to avoid discomfort during use. Do not use this product with wet hands. Do not fall or step on this product.

### Charging

The USB plug of the USB charging cable is inserted into the USB socket of the power adapter (5V-1A), then the power adapter (5V-1A) into the power outlet, and finally insert the plug of the USB charging cable into the charging port of the product.

### Warm reminder

During charging, the indicator light flashes, and the indicator light is always on when fully charged.

During charging, the product can not be turned on and work, after charging is completed, please disconnect the power adapter.

If the product is charging while working, the product will stop working automatically.

### Usage

#### Turn the product on or off

Press the " " key for 2 seconds to turn on the machine. After the machine is turned on, the indicator light is lit and the machine starts to work, default is automatic mode. The working time is 15 minutes, playing music.

While the product is working, keep pressing the " " button for 2 seconds to turn off the machine or the machine will turn off automatically after 15 minutes of use.

#### Switching Mode

Press the " " key for less than one second to switch modes. Operate once to switch to the second mode; operate twice to switch to the third mode; and so on.

#### Music control

Press the " " key twice in a row for less than - seconds to turn the music off or on.

## Mode introduction

Automatic mode = Air pressure massage + hot compress massage + vibration massage + music

Decompression mode = Air pressure massage + hot compress massage + music

Vitality mode = Air pressure massage + vibratory massage + music

Comfort mode = Hot compress massage + music

(Note: Because the product version is constantly updated, the actual mode may differ from the manual)

### Connecting Bluetooth

After powering on the machine, the machine Bluetooth is turned on by default. When you need to link Bluetooth, please open your cell phone's Bluetooth and search for Bluetooth (default Bluetooth name is:Head Eye Massager). Play cell phone music after successful connection. After disconnecting the Bluetooth, the machine plays the built-in meditation music.

## Transportation and storage

### Storage environment

Room temperature, no corrosive gases, well ventilated, dry room.

### Transport

This product has simple shock-proof facilities, suitable for air, railway, road and ship transport, should avoid rain, exposure, inversion and collision and other bad conditions.

### Cleaning and storage

Please use a dry soft cloth to clean the product (please turn off the machine when cleaning, do not use benzene or diluent and other corrosive cleaning agents, otherwise it will cause fading, surface aging, structural damage and other problems).

Please put the product in a well-ventilated, dry room, and cover it with a protective cover when it is not used for a long time. When the storage time exceeds 3 months, please open the box for inspection and charge for more than half an hour.

## Caveat

5. Do not disassemble this product by yourself. This product contains batteries, do not put dry high temperature (above 50°C) or into the fire, otherwise there will be explosion risk.

7. This product is not a toy and should not be used by children alone unless parents or guardians have set it up in advance, or have given children adequate guidance on its use.

8. The use of this product will block the line of sight, do not use in walking, driving and other behaviors.

9. After using this product, the eyes need to return from the relaxed state to the tense state, and there will be short-term blurred vision, which is a normal phenomenon. Please close your eyes for 1-3 minutes, and your vision will gradually become clear.

10. The storage use temperature of this product is -10°C ~ 50°C. It is prohibited to store and use in extreme environment (low dry temperature negative 10°C or more than 50°C).

11. This product should be charged at least once every 3 months when it is not used for a long time.
